MEMORANDUM AGREEMENT  
Between the  
ATLANTIC COAST LINE RAILROAD COMPANY  
And Its  
Train Porters, Mail Porters and Chair Car Attendants  
Represented by  
BROTHERHOOD OF SLEEPING CAR PORTERS

IT IS AGREED:

Article 1 - WAGE INCREASE

- (a) A wage increase of nine cents [9¢] per hour shall be granted train porters, mail porters and chair car attendants effective April 1, 1966, and in applying such increase, monthly rates of pay will be increased \$15.66 (9¢ x 174 hours); and
- (b) A wage increase of nine cents [9¢] per hour shall be granted to train porters, mail porters and chair car attendants effective April 1, 1967, under the same formula as provided in (a) above; and
- (c) A wage increase of nine cents [9¢] per hour shall be granted to train porters, mail porters and chair car attendants effective April 1, 1968, under the same formula as provided in (a) above.

Article 2 - MORATORIUM

No proposals for changes in rates of pay shall be initiated by either party to this agreement prior to April 1, 1969.


Article 3 - EFFECT OF THIS AGREEMENT


This agreement is in full and final settlement of Section 6 notice dated January 12, 1966, served by the Brotherhood of Sleeping Car Porters on the Atlantic Coast Line Railroad Company. This agreement shall remain in force and effect until changed or modified in accordance with the provisions of the Railway Labor Act, as amended, with the understanding, as provided in Article 2, that no notice will be served by either party to be effective prior to April 1, 1969, to change rates of pay resulting from Article 1.




