
I am in receipt of the copy of your letter to Democratic and Republican leaders of the Legislature regarding the Fair Employment Practices Commission and the funding for its operation and for additional staff.

I agree with the observations put forth in your letter that the FEPC is underfunded and understaffed. As I am sure you are aware, the same thing has again happened this year with Governor Reagan's proposed budget. I want to assure you that I will do everything I can as an individual and as a member of the Senate to see that some kind of realistic funding is appropriated for the commission.

It seems to me to be the very epitome of hypocrisy to set up an institution such as FEPC and then cripple it by not providing the adequate funds or staff to do the job. I think that your request for an additional \$150,000 is more than reasonable.



To: All of you who came to NAIRO's Conference.
From: All of us in Cincinnati who welcomed you.
Subject: WE'RE GLAD YOU CAME.

Dear Folks:

In a conference it's not just taste, but aftertaste too that counts. Frankly, we local hosts expected to be mighty glad when NAIRO's 14th was over. Well, we did feel relieved -- duty done, course run, that feeling. But we were not prepared for the deepening satisfaction with which we now remember it all. Not self-satisfaction (we see details we might have done better), but a sense of having been stretched by a great, searching, affirmative experience.

That impression comes from: the impact made on other Cincinnati citizens; the quality of the main presentations; the sharp front-line flavor of some reports; but most of all the diversity of interesting people assembled (meaning you; and you; and you . . .)

So we're glad you came. Hearing that John Lassoe was sending you a conference evaluation form, we asked that these our sentiments be tucked in... Also, because a number of you requested copies of the invocation offered at the banquet by the Very Rev. Paul L. O'Connor, S.J., president of Xavier University, we close our greetings by repeating:

AN IRISH BLESSING

May the blessing of Light be on you, light without
and light within.

May the blessed sunlight shine on you and warm your
heart till it glows like a great peat Fire, so that
the stranger may come and warm himself at it, and
also a Friend.

And may the light shine out of the two eyes of you,
