
Dear Dell:

Please consider this letter as the usual and customary thirty day notice under the Railway Labor Act, as amended, of our desire to revise and supplement existing Agreements pertaining to wages, to the extent, that the wages of all the employees of your road represented by the Brotherhood of Sleeping Car Porters, be increased by 40% effective January 1, 1971. This 40% increase to be applied after any and all increases already scheduled to become effective January 1, 1971.

The above Section 6 service is being served for the purpose of protecting our right to seek equal treatment with the dining car employees, since national negotiations are now going on between the Carriers and four unions.
