

Dear Sir and Brother;

We the undersigned, believe that Union Pacific Railroad is using discriminatory practices with our seniority by using paragraph "C" or rule 20 in the changing and posting of runs.

Enclosed you will find copies of runs and turns, and if you will notice, they are using rule 20. Also enclosed are copies of assignments of turns. On left side next to turn number we have furnished you seniority dates of each chair car attendants. On right side you will note they are telling the extra board how they will work and when. The company has spelled out the correct amount of hours, days, and turns of trains for the extra board. We feel that this is no extra work but a regular job according to rule 20, that all chair car attendants should have a right to bid.

Mr. McNeal, from what we have heard, we are being punished by local officials for asking to be paid according to rule number 5. We have made a check and found out no district has no such plan in affect ~~as~~ as Los Angeles. All over, the men are allowed to make a little extra time, and we have ~~one~~ contract with one company, Union Pacific Railroad.

Every little petty thing they can find in our contract, they will twist it arund to suit them.

Therefore we are asking you to look into this at once, and let us know where we stand.

LABOR LION ENDORSES RONALD V. DELLUMS

The Primary Congressional Campaign of RONALD V. DELLUMS took on an added dimension and received an enthusiastic boost, with the endorsement and avowed support of one of labor's old guard, MR. C. L. DELLUMS, International President, AFL-CIO, Brotherhood of Sleeping Car Porters.

High in the circles of Labor and prominent locally and - - - nationwide an acknowledged gladiator in the arena of Civil Rights, his support as well as his credentials are formidable.

Mr. Dellums, was elected as the second president in his union's history, succeeding A. PHILLIP RANDOLPH, in September of 1968.

His activities in the areas of human dignity and social justice, have been heralded almost as widely as his achievement within the labor movement. Laboring in the NAACP for 36 years - first as president of the Alameda County Branch, later as Regional Chairman - a post he held from 1944 to 1967.

He has the distinction of being the only Commissioner of the California Fair Employment Practices Commission serving Governors Brown and Reagan since the Commission's inception in 1959.

Mr. Dellums vehemently denies family ties has anything to do with the endorsement. He cites, the crying need for Black Representation in Congress

as being the only valid basis for his decision. "When I count the number of Black Congressmen, in proportion to our Black Population, I am appalled at how Black People are being short-changed. Jeff Cohelan and I have been friends for many years, but this did not deter me from making this choice. I can see no better way of achieving many of the Black Man's needs without forceful representation. Had Ron not chosen to run, I would have been duty bound to support the best qualified Black Candidate. Remember, I said qualified - I would not support any Black Man who decided to run - he would have to be first and foremost, by my standards, be qualified and," he said, "my standards are high. Ronnie, I am happy to say, meets them." He is his own man, independent, proud, intelligent, mature and has the guts for the job. He is not afraid of a fight and he did not come courting my favor, he realizes what he is up against and believes he can win - quiet as it is kept, he winks; so do I."

MEMORANDUM OF UNDERSTANDING CONCERNING
TRIAL PERIOD OF THE APPLICATION OF RULE
46 OF THE WORKING AGREEMENT REVISED,
EFFECTIVE JANUARY 1, 1953.

It is hereby understood and agreed between The Pullman Company and its porters, attendants, maids and bus boys, represented by the Brotherhood of Sleeping Car Porters, that Rule 46. Operation of Extra Employes Out of Home Station of the working Agreement revised, effective January 1, 1953, is to be given a trial for a 6-month period ending June 30, 1953. Either party shall have the right within such 6-month period to serve notice of desire to modify this Rule or to cancel the Rule. In the event the first paragraph of Rule 46, as revised, is canceled, the first paragraph of Rule 46 and related rules mentioned therein of the Agreement in effect prior to January 1, 1953, shall be reinstated.

In the event there is no such notice of cancellation served by either party by the end of the 6-month period, Rule 46 of the Agreement revised, effective January 1, 1953, shall remain in full force and effect until revised in the manner prescribed in Section 6 of the Railway Labor Act, as amended.



The senior applicant will be assigned the turn of his choice with respect to his seniority standing, thus it is advisable that several choices should be submitted.


If no bids are received for any vacancy it shall be filled by the junior extra man in accordance with Rule 20.


