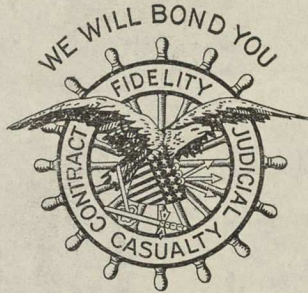


Dear Mr. McNeal:

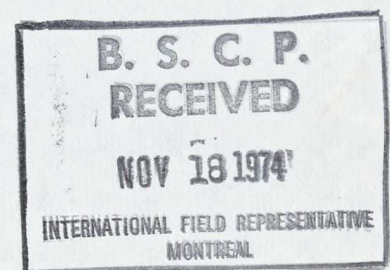

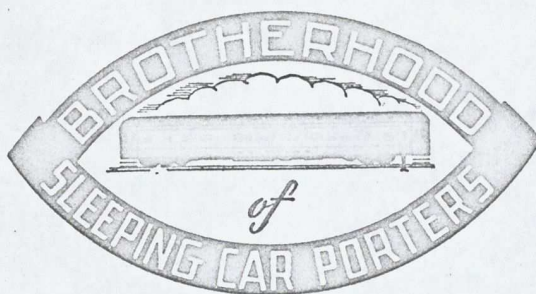
