With these cold mornings, blankets are a necessity. At present we have only enough for emergencies, and in many cases they are in dire need of more blankets.

Many persons are allergic to straw and are asking for blankets or some other substitute for mattresses if they are not available.

The leveling of the blocks, should be rushed so that the residents can start some gardening to keep them occupied and discourage them from other activities such as going to the hills, trying to trap wild animals and etc.

One of the greatest dangers in this camp is fire. We in our block are starting a volunteer fire fighting division to operate until the fire engine arrives and then an organized system of rescue work and the prevention of the fire spreading.

One of the main and vital things necessary is ladders. We believe that two permanently stationed ladders on each side of the Mess Hall is very vital. One to be placed on the side of the building nearest the kitchen (South East corner) and the other corner (North West corner). These ladders are not only vital in the prevention and extinguishing of fires but have a dual purpose in that it gives authorized persons access to the roof to clean the chimneys, sweep the roof and etc.

Also movable ladders of sufficient length should be placed against every other barrack or every barrack. These are to be used for giving access to the roofs to put out cinders and sparks flying from a fire to adjacent barracks. At present we have no way of getting on the roof and in case of a fire we have no way of getting on the roof and in case of a fire we are handicapped in trying to keep the fire from spreading.

As our barracks are our only homes and at present contain all our personal belongings; if they should go up in flames we will all be homeless and clothless presenting a critical problem as God only knows when we can have new barracks build under the present depleted conditions of supplies caused by war.

Therefore I believe it is only proper that the Administration do everything in its power to prevent this situation and the first step I believe is to supply each block with sufficient ladders or materials for ladders. In this way even if one barrack is destroyed we might be able to prevent the fire from spreading to the rest of the block or blocks.

We are fortunate that we have not had a major fire as yet but in a city of 4500 people this is one of the unfortunate things to be expected. When this happens any plans for prevention is too late.

Why is it we were all crossed up on the soap? The Community Enterprise assured us they had plenty of soap on hand and even went so far as to press us for not selling the soap fast enough as they were to give us a case a day. Due to this factor we increased the allotment per family and sold out but did not have enough to go around to all the families of the block. The next day we received only one case instead of the three we were expecting and we're told that there was no more. This created quite an amount of dissatisfaction among the residents.

After the block manager's cooperated to their fullest extent and then to be put on the spot by the Community Enterprise is not right. The Community Enterprise must have no respect for the Blk. Managers to enter into a business deal of this type and not to keep us better informed. It seems the Community Enterprise is not trying to help or benefit the people of Poston but is only trying to build up a large surplus and build up their prestige.--

The truck being used for the transportation of the school teachers to and from breakfast comes by our block at an unnecessary high rate of speed. Early in the morning there are many people and children going across the road to the small fires built to warm up. The small children especially are running across the road from between the barracks and behind the oil tank. The rate this truck is traveling it would be impossible to stop. Before there is any casualty something should be done to slow them down.

He is asking our full cooperation to make this project a success on a democratic basis and the allows the army to fence us in within our small bound areas certainly is not in accord with his words. Mark my words! With the going up of the fence you will find the cooperation, especially of the isseis, going down; if not to a standstill.
