Dear Mrs. Guild:

I trust I am not making an error in addressing you as "Mrs." If so, I feel sure you will be charitable.

Although I have delayed so long in acknowledging your kind offer of cooperation, it seemed desirable in order that I might tell you of definite decisions. The enclosed sheet will tell you in outline the form the Committee is taking. We feel fortunate on securing Mrs. Kingman as Executive Secretary, and she will be corresponding with you and others in Seattle about next steps.

No doubt you are in close touch with the leaders of the Evacuees Service Council, and I am asking Mrs. Mildred Potts and Miss Priscilla Wicks to share with you a letter I have just sent them.

As to the effort to disfranchise Japanese-Americans, a bill has been introduced in the California Legislature, termed Senate Joint Resolution No. 2, for "an amendment to the Constitution of the United States barring persons of Japanese descent from citizenship and requesting said Congress to propose said amendment for ratification by the Legislatures of the several States". In other words, it is to be a memorial to Congress. Although it is practically sure to pass, it is said that no one expects Congress to pay much attention to it, since the unconstitutional character of the proposal is recognized. But it should be protested, because it adds fuel to the anti-Japanese (and anti-minority) sentiment of the Coast and the country as a whole. I should, however, think it might be well for citizens in other states to postpone their protests until it has been adopted in California or becomes a matter of serious comment in the press or radio. Then protests to Congressmen and in the press would help.

The Legislative Committee of our Committee on American Principles and Fair Play is keeping watch on all matters at Sacramento. The Legislature will reconvene about March 13th.



Dear Mr. Johnston:

I am writing to ask you to become a member of the Advisory Board of the Pacific Coast Committee on American Principles and Fair Play which is being formed to support the principles enunciated in the Constitution of the United States, particularly as they apply to Americans of Japanese ancestry.

The Committee is already functioning through its San Francisco office. I enclose a copy of its initial release to the press. This will acquaint you somewhat with our purposes and principles. The enclosed temporary letterhead will indicate the high calibre of citizen that has already been enlisted in the northern part of the state. A similar support is to be sought in Southern California and in Oregon and Washington.

It is not contemplated that members of the Advisory Committee will be expected to attend many meetings nor are its members accepting any financial obligation. The program will be financed by voluntary contributions from individuals up and down the Pacific Coast, but financial support is not a condition of your acceptance.

It may be that the future of all minorities in this nation will depend somewhat on the success or failure of work of this kind. This Committee should play an important function in defending the American way of life, and I sincerely hope that you will consent to accept this invitation to add your name to its roster.






Dear Dr. Deutsch:


Dear Mr. Kwong:

It has been my conviction for many years that no person should accept a position on a Board of Directors or an Advisory Board unless he intends to work actually on the job. He should be prepared to attend the meetings, listen to the information presented and be a party to all decisions reached. When I became a member of the Advisory Council of the Committee on American Principles and Fair Play I violated this principle completely as it was very apparent even then that I would be unable to do any of the things mentioned above. Since that time pressure of various war time jobs has become even more acute and it seems very unlikely that there will be any change as long as hostilities last.

With these considerations in mind and with apologies to my fellow members of the Advisory Board for being unable to take a share in their work, I am tendering my resignation as a member of the Advisory Board of the Committee on American Principles and Fair Play.
