Dear Sir:

I entered Japan in the middle part of January 1947 after coming aboard the Voluntary Ship U.S. Gordon with my parents and I have been trying every source I can find in making my return to the States as soon as possible, but in my position I haven't been able to do anything.

In the states I have been residing in the Full Lake Center and I have been caught in force to renounce my citizenship, but to my prayer it was not approved by Attorney Biddle. I was free to go outside to relocate which were my greatest wishes then, but after

so many harsh quarrels with my family and due to strong ties I was forced to come back with them.

Prior to leaving the Tule Lake Center I was escorted by a Canadian worker to the Justice Department and there - I was being registered by taking identification photo of face, taking fingerprints and necessary other physical identifications. This was to enable my return to the United States.

No papers, no documents were issued before departing the center. I have gone to the American Counsel in Yokohama and without some certified identification documents as to my returning to the U. S. am I able to make any application to get back.

I will appreciate it very greatly if you will take this matter into more than a consideration for my greatest desire is to return to the United States and reside all my life. Would like very much if you will answer me at your earliest convenience.

Dear Miss Hirata:

If you were under 18 years of age at the time you signed a renunciation application in the Tule Lake Center, the Attorney General would have refused to approve it, and consequently, you would not have lost your U.S. citizenship. If you were 18 years of age or over and the Attorney General did not approve your application you are still a citizen of the United States.

If you are still a citizen of the United States you are entitled to return to the United States by applying to the American Consul and submitting to him a proof of your birth and citizenship. It is my impression that he would ask you to fill out an application and to supply a certified copy of your birth certificate and other evidence of your U.S. citizenship. It may be that the American consul would ask you for a letter from the Alien Enemy Control Unit of the Department of Justice stating that although you submitted an application for renunciation, that your application was cancelled by you or was not approved by the Attorney General.

In the event that the consul refuses you the right to return to the United States, you would then have the right under Title 8 U.S. Code, Sec. 903 to file a suit to determine your nationality in a U.S. District Court in the district in which you claim permanent residence in the United States and thereupon submit affidavits and other evidence to the American consul showing that your claim to U.S. nationality in such suit is presented in good faith and has a substantial basis. Whereupon he would issue you a certificate of identity and you would be permitted to return to the United States when passage could be obtained.

In any event the American consul to whom you apply will inform you what the requirements are for you to be able to return to the United States.


Dear Mr. Collins:

I have your letter of June 11, 1947, inquiring as to whether this subject's renunciation of United States nationality had been approved or rejected.

The Departmental records indicate that Miss Hirata renounced her United States citizenship on January 15, 1945, at Tule Lake, California, that she voluntarily repatriated to Japan on December 28, 1945, and that her renunciation was approved by the Attorney General on April 18, 1946.

The notice of approval of her renunciation has just been mailed to Miss Hirata at the address you gave for her in your letter. It was because her address in Japan was heretofore unknown that she had not been sent the notice.

Dear Miss Hirata:

Enclosed find copy of a letter I received from Charles M. Rothstein, Esq. which informs me that your renunciation application was approved by the Attorney General on April 18, 1946. In view of that fact your renunciation apparently was approved.

If you desire to take steps to protect your rights you should send to the Attorney General a copy of the enclosed letter addressed to him and make a copy for your own records. Thereafter if you wish and you request me so to do, I shall join you in equity suit No. 25294-G if I receive your request to be joined before the judge renders his opinion. If you are joined in such suit you will be entitled to apply for a certificate of identity from the U.S. consul as outlined to you in my letter to you of June 9th, 1947.

Dear Miss Hirata:

In reply to your letter of January 2nd, 1948, please be informed that Judge Goodman has not yet rendered a decision in the equity cases which are to determine whether the 2300 plaintiffs therein are to have their citizenship restored or not. When the decision is rendered newspapers in Japan will carry an account thereof and each of the interested parties therein will be informed as to its nature by letter from me.

I have not joined you as a party plaintiff in the case because, to date, you have made no request of me to do so. In my letter of June 30, 1947, I informed you that if you wish to join the suit that you could do so by requesting me so to do. Inasmuch as once the case is decided a party may not be added as a party plaintiff thereto, I would thank you to inform me immediately by air mail if you wish to be joined as a party plaintiff. In addition I would thank you to send me your age, and date and place of birth.

Dear Sir:

On or about _____, 194____, I signed an application for renunciation of U.S. Nationality at the Tule Lake Center, Newell, Modoc County, California.

I hereby repudiate, withdraw, retract and revoke the said renunciation upon the following grounds and for the following reasons:

(1) The circumstances under which said renunciation form was signed by me did not constitute a fair and impartial hearing and was a denial of my constitutional guaranty of due process of law and of the equal protection of the laws;

(2) I was not a free agent at the time when and the place where said renunciation form was signed but then and there was held in duress and was the victim of fraud, menace, undue influence and mistake of fact and law;

(3) I then and there was and for a period of time prior thereto had been detained in said Tule Lake Center by official authority and was deprived of substantially all my constitutional rights, liberties, privileges and immunities as an American citizen and was treated as though I were an alien enemy and thus was discriminated against solely by reason of the Japanese nationality of my ancestors;

(4) I was intimidated, coerced and compelled to sign said renunciation form by reason of the duress in which I was held by the government and the duress, fraud, menace and undue influence of groups and individuals within said Center, against which the government failed to protect me.

Because of the foregoing reasons the said renunciation was fictitious and is invalid and void.

I am not a citizen or subject of Japan and I do not and never have owed or given that country or nation any allegiance. I am not an alien enemy. I am a native American by birth and by choice. I have no dual citizenship through any act or acceptance upon my individual part.

I demand that you withdraw and set aside the said renunciation form, and the approval thereof if any approval thereof was given.

I am ready and willing to have this matter re-opened and a hearing be granted me in order to prove the said renunciation application was executed under the circumstances above-mentioned when I was not a free agent in any sense of the word but was acting under duress, menace, fraud, undue influence and mistake of fact and law.

I respectfully request your immediate consideration of this urgent matter.
