Dear Miss Uchida:

We have received your letter of October 19th and are sorry to have been so slow in replying. We are working with a good many students, attempting to get them placed for the second terms, and we have been trying to decide how best to advise you.

Dean Hoyt tells us that she has as yet had no reply from Smith College. We are very much afraid it will not be possible to place you there in February unless funds for you could be found from some other source. There is a faint possibility that we could secure some scholarship aid, but we do not want to raise your hopes unduly on this score.

In any case, before going into the financial aspects of your problem, we would like to know if you have any interests more definite than the rather general major in education in which you have indicated you are interested. If Smith is not available for you, it will help us considerably in suggesting other institutions if we know of a more specific field in which you would like to work. If you had been able to take a fifth year at the University of California, without the teaching experience at Tanforan, what field would you have selected? We are not trying to discourage you from your interest in elementary school teaching in the relocation center, but in view of your general background, which is good, and the exceptionally fine references you received, we feel you are capable of undertaking work in addition to the amount of education you would need to take for an elementary school certificate. Teaching requirements for other states are not nearly as high as they are in California.

We would be glad to hear from you as soon as possible. There is a considerable amount of red-tape involved in securing a travel permit and the sooner we are able to suggest a college to you and you to the college, the sooner we can begin assembling the documents necessary for a travel permit.

Thank you very much for your letter of the 14th. I appreciate your kind consideration when you have so many other cases to handle.

In regard to your question as to a more specific field in which I might have continued at the University of California, had evacuation not intervened, I believe I would have gone on with History (especially as related to present world events.) I also would have liked to continue in the fields of English, Art, etc... on the side.

I realize that having taken such a broad and general major at the University, in History, English and Philosophy, it is probably very difficult for me to be placed as a graduate student. However, I had always felt that a good, broad background of four college years followed by some sort of specialization would be the sort of education I desired.

I know that I have no right to be particular in selecting a college which I might attend, but I do want very much to attend a smaller college with good liberal arts courses, preferably back East, and in going on with graduate study, I would like to work in History and at the same time obtain an elementary teaching credential, if possible.

I am at present asking the advice of a few of my friends, Mr. Galen M. Fisher for one, and should like to write you, if I may, upon receipt of advice from them as to what college I might apply should Smith College be definitely out of the picture.

I hope this bit of information will have been of some assistance to you. I shall look forward to hearing from you again in the near future.

Dear friend:

We have an extremely interesting suggestion to make to you and we sent you a telegram today briefly outlining it.

The Hessian Hills School at Croton-on-Hudson, New York, which is not very far from New York City, is a very progressive school for children. We have just heard that they can take on their staff a Nisei student of education as a student teacher. We know that the school will give excellent training and I suppose you know that an increased number of schools are using these "teacher internes" - college graduates who want to continue in the field of education are taken on the staff for definite work which is very adequately supervised.

While waiting for your reply to our telegram we are writing the Hessian Hills School to see just what they offer in the way of financial assistance, if anything, other than room and board. We will suggest to them at the same time that we are in correspondence with you and we shall also give them a resume of your transcripts.

The Hessian Hills School has always had a number of student teachers most of whom leave to work in other modern schools so that you can see the Hessian Hills School has had considerable experience in training young people.

I thought the situation over very carefully, for I know that such a fine opportunity does not come often, and I appreciate your considering me for a candidate. I talked the situation over carefully with my family and also with our youth counselor Kay Yamashita, but finally decided that inasmuch as there seems yet to be a possibility of my entering Smith College some time during 1943 according to Miss Bryson's letter which I forwarded to you, I believe I would prefer to wait for that opportunity. Somehow I feel I should like to go there especially since I seem to have the closest connections and contacts there, and feel perhaps it might be worth waiting till later in 1943 if I would be sure of entrance.

However, I may be taking too much for granted, so I would appreciate it very much if you could check once more with Smith College as to whether I would be accepted in February, June, or September of 1943.

I do sincerely appreciate your efforts on my behalf when you must have hundreds of others to consider, and hope that some deserving student may be accepted at the Hessian Hills School.

I hear that the Delta telegraphic service is appallingly slow and hope that my wire did not reach you too late.

Thank you for your telegram. I am sure you have given this careful thought and that your decision is final.

We have received your letter of December 25 as well as two letters from Mr. Chas. Warren. The first letter makes the suggestion to us that if you go to Holyoke that his daughter and her husband would be very glad to have you live in their home. The second letter from Mr. Warren indicated that he had heard from you and believed under the circumstances that you were not going to consider his suggestion. He, therefore, gave us the name of another Japanese American.

Thanks for sending us Miss Bryson's letter to Miss DeForest. The situation seems to be that Holyoke has refused your application because they do not have graduate courses in education. Smith College does not at this time have available place for you for the second semester but apparently are quite anxious to consider you for work there next fall. Have you decided that you prefer now to wait for Smith, if they accept your credentials, until September 1943? Personally I wish you would give reconsideration of the possibility of getting some excellent experience in teaching at the Hessian Hills School with the thought that you could go on from there for some courses at Smith next winter. I suppose you have seen a Smith College bulletin as there must be a copy available to you at Topaz. Their graduate courses include problems of American Education with Mr. Kotschnig, Problems in Secondary Education, Experimental Educational Psychology, Practice Teaching and Advanced Studies. Just as soon as I have word from you as to your final decision, I will get in touch with the Hessian Hills School and with Smith College.

Write us whenever you wish. That is what we are here for!

Incidentally, I have been sending all my communications to Mrs. Goddman since I had been making my other contacts with her, and trust that you have seen these previous letters.

It was very nice of you to send me all the details of this new possibility which truly sounds very interesting, and I do appreciate very much your considering me for a candidate. The one thing however which makes me hesitate to accept is the fact that I still feel I may have an opportunity at Smith College, and, as I explained in my other letter, feel perhaps it might be worth waiting till later in 1943 if I can be certain of entrance then. I hope the letter of Miss Bryson which I forwarded to your office has reached your hands and will explain why I have such hopes for Smith.

Thank you so very much for your letter of January fourth. I appreciated your advice to me immensely, for I didn't exactly know where to turn or how to make my decision.

If I could receive teaching experience at the Hessian Hills School, and then go on to Smith in September as you suggested, it would truly be more than I ever dared hope for. I wonder if I could apply for the Hessian Hills School under those circumstances?

With your letter today, I also received such a very nice letter from Miss Bryson. She stated that there were no openings at Smith for February, and said, "I should hope hard that you could eventually get to Smith, but we can't know for some time how many openings for next fall we may have, if any. You keep in touch with me, and be very sure that we are much interested."

I would like very much to be placed on the waiting list at Smith for September 1943 if possible, and if in the meantime I could be at the Hessian Hills school, I could ask for nothing more. However, I'm afraid I would have to receive financial aid for tuition, besides room and board, as under the circumstances, I cannot receive much aid from my father. I would also like to know more about the school, what would be expected of me, where I would stay, etc.....

I have filled out a form 126 (for leaving camp), which seems to have gone through the office already, so now I shall wait for results on it.

I shall be waiting to hear from you again. My sincere thanks to you for all you are doing for me.



Such a new problem! Mr. Hymes, of the Hessian Hills School, has written a very nice letter saying how much they all want you with them, but - since it seems to take some time for all permits to come through, he is afraid you won't get there until pretty late in the spring. The school closes on May 30th and he doesn't know what you could do during the summer. The second semester has begun - they have 2 weeks' vacation in March - and then school closes in May.

If you go next fall, they will provide you with room and board and arrange your program so that you can take special courses in New York City (an hour from Croton), and would in addition pay you a small sum that would cover incidental spending money and transportation to NYC.

This office is closing up for at least 2 weeks - we are moving to Philadelphia, 1201 Chestnut Street. So we can't do much about anything for anyone for a while. If you get some word meanwhile from Washington about your travel permit, why don't you write at once to Mr. Hymes, saying that you could come very promptly, and that you would no doubt find some work during the summer, either in NYC, or in the vicinity of Smith. Just as soon as possible we shall get in touch with you, perhaps around March 1st. (Address, James L. Hymes, Jr., Hessian Hills School, Craton - on - Hudson, New York) In the meantime, we expect a report from Washington that the school is approved - things do move very slowly!

I am awfully sorry for this new delay. Needless to say, we all hope some satisfactory solution can be found.

I just received a letter from Miss Bryson of Smith College which now adds to all the confusion! She wrote saying ".....I write today to say that we have been authorized to continue next year in having several Japanese American girls at Smith, and it looks as though one or two of the girls now here will move out to something else. If you are still interested, I suggest that you send us your application, so that we may view it along with others which will be reaching us. I am so sorry that the opportunity at Mt. Holyoke fell through, and I sincerely hope there may be no hitch in the proceedings for Smith."

Since the Hessian Hills School offer also seems to be largely for the Fall semester, I really didn't know what to do, and have talked the matter over with Dr. and Mrs. Joe Goodman who are now here, and also with our Youth Counselor. They both thought I should send in my application to Smith since it is such a very fine opportunity. Then if I could possibly get out to New York before summer, and if I am accepted at Smith, I could explain the situation to both parties and perhaps some solution could be found. It would be so much easier to explain in person than by letter.

Miss Bryson already knows about the Hessian Hills School but does not know that I have been accepted there for the Fall semester. I believe however, that the Hessian Hills School knows nothing about my application at Smith.

Would you please send in to Miss Bryson, Chmn, Committee on Exchange of Students with Foreign Countries, Smith College, a transcript of my records etc..to make my application official? I shall also write to her in reply to her letter.

In the meantime, I believe the only thing I can do is to wait for an answer from Mr. Hymes of the Hessian Hills School to my inquiry about entering this Spring, wait for my travel permit, and wait for word regarding my application at Smith. I would certainly appreciate your advice in this matter as I realize it is going to be a complicated situation if I am accepted at Smith. Thank you.

Dear Miss Johnson and Miss Maier;

Thank you so much for your very nice letters of the 25th and 27th. It was very kind of you to write Mr. Hymes for me, and thank you too, for sending my records on to Smith College.

I received a letter, along with a catalog, from Mr. Hymes a few days ago, which leads me to doubt very much if I shall be able to go the Hessian Hills School this Spring.

He wrote, "My earlier letters to the SRC were intended to be exploratory of the possibilities but replies and action growing out of them have come faster than we here have been able to act. Just at present we are in the midst of our Spring Vacation which means that our staff is scattered somewhat and that I cannot bring them together to make some remaining decisions that must be made before we can move ahead. One relates to such a simple thing as housing. We have a small boarding department which we are planning to expand by next fall. For all of this year the House has been filled.....It may be possible, if we can go ahead, to work out some other living arrangements for the spring but I will have to write you in a week or so about this.from the simple academic standpoint there is no insurmountable obstacle in arriving in mid-semester."

I also wanted to inquire about one other thing. My sister may have an opportunity to go East in June. If she is able to go, then, my parents would like very much to have us travel together. I wonder if you know of any work which would be available during the summer months, preferable in New York City, or at some school or College. I am able to do a little typing and would like some clerical work if possible. I could then go on in the Fall, either to Hessian Hills or to Smith.

I would appreciate any information along this line as soon as possible. In the meantime, I shall also contact one of my friends in NYC about possibilities for a position during the summer months.

I shall let you know if Mr. Hymes' next letter brings any added information.

Everybody seems to have had a chance to write you and so now it is my turn. We have just heard from Smith College - "It looks as though we were going to have a place for Yoshi Uchida next year and I am awfully glad. We can't make our decision just yet but I am pretty sure of the opening".

We have also heard from the Hessian Hills School. They regret not having answered us sooner but state that it was because of their vacations. They feel very badly about the way things turned out in regard to you - "I took my letters inquiring about the possibility of some one's coming up to be of an exploratory nature, in large part because we have not yet been able to work out here such practical questions as where she would live I was sorry, however, that Miss Uchida had been told her coming was a definite thing."

Personally I believe your chance at Smith College is by far the best and that it will take some time before Hessian Hills School decides one way or another.

Thanks for your letter. To answer your question we were thrilled that your sister may be going East in June. If you have been officially accepted at Smith College, if we are able to work out the financial picture, if you have been checked with the F.B.I. and if your educational leave has been issued you should be able to go with her. You might also try it on the employment angle and see if you could not get out that way and then turn up at Smith College or Hessian Hills School in the fall. There probably is work available during the summer months in New York City. You might contact John Thomas of the American Baptist Home Mission Society, 212 Fifth Avenue, New York City. There might also possibly be work in our Philadelphia office. Of course, the chief difficulty at the moment from the employment angle is that of having to go before a Review Board in order to enter the Eastern Defense Command Area for employment purposes.

I am sorry I do not have any more exciting news for you at the moment, but we hope that soon something will break for you for you have been waiting so very long.

She also inquired among her friends, and one who has quite a good knowledge of the teaching field felt that I would not be too happy in this particular school for several reasons. I realize that I should not be swayed by one person's opinion, but since I am at such a great distance from New York, I can only rely on the advice and information given me by my friends.

I have been waiting several weeks for word from Mr. Hymes of the H.H. School, but have heard nothing since I last wrote you. Thus I believe it is very improbable that they want me this Spring.

I hope you will understand when I say that I feel now that I would rather concentrate on getting to Smith rather than attempt to go to Hessian Hills at all. I am enclosing a copy of the last letter I received from Miss Bryson, and wonder if I should have copies of my letters of recommendation sent too. If you think this should be done, would you kindly forward them to Miss Bryson?

As I wrote you in my last letter, if my sister should go out in June, I would like very much to go at that time too---and I have just received a letter from my friend Mrs. W. Bellew of New York who very kindly invited me to stay with her family until such time that I could get settled. I believe she has written your office about this too. I wonder if I could be released to go to New York in June even though I may not have an acceptance from Smith at that time? I would appreciate any information about this point.

I sincerely regret that all did not work out well regarding the Hessian Hills School after all that you on the Council have done for me in connection with this situation, and do hope that some one else will be able to benefit from an internship there.




