My dear Mrs. Kingman:

The receipt is acknowledged of your letter of July 1, 1943, with enclosures, concerning the activities of the Committee on American Principles and Fair Play. It is noted that this organization receives many inquiries relative to the Japanese-American population of the United States and that on occasion you wish to obtain information from this Department.

The inquiry contained in your letter in regard to impounded Japanese credits in this country is one which arises under Executive Order 8389, as amended, regulating transactions in foreign exchange and foreign-owned property, providing for the reporting of foreign-owned property, and related matters. In as much as this Executive Order is one which is administered by the Treasury Department, your letter has been referred to that Department for reply.

With reference to your Committee's general activities, the War Relocation Authority, Washington, D. C., and the Department of Justice, which are engaged in activities relating respectively to the relocation of persons of Japanese ancestry and the internment of Japanese subjects, may be able to answer questions which arise in the future regarding these matters.

You may be interested to know that upon the outbreak of war, this Government communicated to the principal opposing belligerents, including Japan, its intention to observe the Geneva Prisoners of War Convention of 1929 and to apply its provisions to civilian internees, in so



far as they are adaptable to civilians, and informed the opposing belligerents that it expected them to do likewise. The opposing belligerents, including the Japanese Government, informed the Government of the United States that they would on their part apply the provisions of the Geneva Convention not only to prisoners of war but also to civilians.

Dear Dr. Peattie:

It is good to know that you have taken over the leadership of the Santa Barbara Branch of the Pacific Coast Committee on American Principles and Fair Play. Dr. Deutsch was most gratified with your acceptance and we are looking forward to the addition of one more cooperating group in Southern California.

At your suggestion I am sending materials which we feel will be of value in your organizing meeting. In answer to some of your own questions:

- 1.) Branch organizations apparently need a chairman, vice-chairman, secretary-treasurer, plus the sub-committee heads indicated on the enclosed sheet. This group obviously makes up an excellent executive committee.
- 2.) The activities are suggested by the sheet on "Suggested Sub-Committees".
- 3.) Dues, or contributions, are necessary in order that the central office, as well as the regional offices, about to be established in Seattle and Los Angeles, may be maintained, and the materials and organization details distributed as widely as possible. As you will see in the By-laws, a certain quota (not to be regarded as inflexible) is agreed upon between the organizing group and the central office, to be raised annually by the local group. Any funds over and beyond that, are for the use of the local committee. We suggest that for Santa Barbara an annual quota of \$350. (two hundred and fifty dollars) seems proportionate to the quotas of other communities. Fresno is operating under a quota of \$200, as are Pasadena and Sacramento. Naturally, if your committee feels that it would be able to raise a larger amount, it merely means a wider program for us all.

We are just now getting together a new release, which should be in shape by next week. May I suggest that you write to Mr. William Carr, 1360 West Colorado St., Pasadena, and ask him for an idea of some of the work the committee there



is undertaking, and how it supplements the thing we are doing on a "fact finding, fact disseminating" basis.

If you wish further information, I shall be glad to try to give it to you. --I liked the July Readers' Digest.

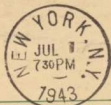

I believe that you are familiar with the position of our committee, of which Mr. Chester Rowell is a member, so you will also know that we are scarcely an ill advised group in our thinking on this subject..

For some time I have intended to ask your advice on ways and means by which more persons might be reached in an attempt to create a more realistic and constructive attitude toward our loyal Americans of Japanese ancestry. As it becomes increasingly obvious that this recent "hate" campaign is playing into the hands of Japanese propagandists, (see July 3rd Chronicle reprint of "Race Trouble is the Japs' Best Propaganda" by Mr. Owen Lattimore) it seems that something pretty widespread must be done to combat just this sort of thing.

The Chronicle has so long been the most fair minded of our California papers, that I do not hesitate to go to you with this very serious problem.

Thank you for the invitation sent to the writer by

The persecution of American citizens of Japanese  
extraction is one of the blackest crimes against our  
country. Putting citizens into "concentration camps"  
without even asking about their loyalty smacks of the  
German dictatorship. This is not only grossly unfair to  
the victims, but may serve as an entering wedge to de-  
prive other minorities of constitutional rights. That is  
precisely the pattern Hitler followed--Jews, Communists,  
Socialists, trade union members, liberals generally,  
and finally every one except his own party.

I inclose my check for two dollars as dues of a  
"general member." I regret the check is not larger, but  
the rising cost of carrying on civilian business and the  
multiplicity of good causes to help make it necessary  
for one to spread out his contributions rather thinly.

My dear Mrs Kingman:

The material from your office was forwarded to me. <sup>from Santa Ana</sup> It was a great encouragement to know some citizens are awake to conditions. I have been depressed over the great activities of American Legion groups, Native Sons and Mayors and police groups. It looks as if Legion groups have gotten their men in key places, as sheriffs etc, just for this movement.

I just wrote a letter to Sheriff Jesse Elliott of Santa Ana, who is spending much time speaking to Elks, Lions, Navy Mothers, in fact, all service groups against the Japanese Americans. These groups then send in resolutions against return of Japanese to Washington. It is a vicious circle. Mayor Bouron of Los Angeles is on the same propaganda line. I think both are American Legion men.

I recently wrote a letter for the Santa Ana paper. I received some abusive cards, some sincere, but prejudiced letters, which I answered. The cards I ignored. I haven't financial means to give; but I am trying to do everything I can personally.

During your western travel, so we understand, you had occasion to visit one or more of the centers to which Americans of Japanese ancestry have been evacuated from the West Coast.

Undoubtedly you have been impressed with the deep irony, not to say tragedy, of a situation which has forced one race group of our citizens to accept wholesale evacuation and confinement as their peculiar contribution to the winning of this war, even while thousands of their flesh and blood wear honorably the uniform of the Army of the United States. You recognize, as do we, the severe and growing strain which prolongation of this detention places upon the integrity of those American and constitutional principles for which we fight. You appreciate also the jeopardy to wholehearted and international support by people of many races which we require for success in this war. Beyond that, you will see the subtle impairment of that confidence between ourselves and the non-white peoples of the world upon which our children and grandchildren in times to come will be obliged to rest their security.

Many citizens on the Pacific Coast hold these opinions. Some of them have formed this Committee of American Principles and Fair Play the better to express them. We believe that any publicity you may be able to give to these views will be helpful to the cause of the United States.

My dear Mrs. Kingman:

It will interest and satisfy you to know that none of the people to whom I wrote regarding the influence of your little folder agreed with me. Bishop Stevens gave me a small spanking for writing this letter on our letter-head. With my face somewhat red, therefore, I shall ask you to regard the incident as closed.

However, I do find in my files a clipping from the Los Angeles Times of June 8th, which gives the following communication from Fresno: "State Senator Hugh M. Burns said here today that the group which he charged was attempting to obtain the return of interned Japanese to the Pacific Coast area was the Committee on American Principles and Fair Play." People like this will read into any statement favorable to Japanese an attempt to bring the Japanese here now, unless it is definitely stated that the group opposes such a return.

It may interest you to know that Dr. Farnham prepared a report for the Dies Committee under date of June 15th. He stated in that report: "While under the American Constitution, except for marshal law and military requirements, the American-born Japanese probably have legal right to return, we hold that it would be most unwise for them to do so." That puts the Church Federation clearly in opposition to the return now of the Japanese. David Henley, of the Friends Service Committee, also agreed with me yesterday that if we are to be "wise <sup>as</sup> serpents" we would definitely state that we do not favor the return of the Japanese now.

Regarding the Congressional action regarding the Chinese exclusion and similar laws, we shall have to postpone further activities until Congress re-assembles in the fall.

I hope that the work of the Pasadena Committee isn't going to be too heavily burdened by answering some of the letters that I have had addressed to it. As a bright and shining example of what an affiliate can be, I've asked two or three new groups to get in touch with Pasadena for pointers.

I wonder if you have seen the new pamphlet put out by the government "They must be heard". They are using our "stuff" quotations, etc., but they are excellent. I've asked for 10,000 and will send 1,000 to your group if and when they arrive.

It is wonderful to see the way you are "catching on" to our educational policy. It is doubly reassuring to know that you feel that our policy of holding to such a program, instead of including emphasis upon evacuee welfare, is the best one for our group.





Dear Dr. Williams:

We were glad to receive your letter this afternoon, expressing your continuing interest in the work of our Committee. I am very glad to tell you some of the things we have done but many of our activities are among the "intangibles", whose influence is strong but hard to define. I refer to the many conferences and contacts with key persons upon whose understanding and action final decisions are made, and much of our correspondence.

We are, very specifically, collecting a valuable selection of statements from persons in authority which support our present position. By means of careful use of these statements we feel that we have been able to do much to temper the wave of hysteria at the West Coast. Naturally, the press (most of it) has gone along on the crest of the wave, but one of the things we are trying to do, quite successfully, is to draw the attention of people in strategic positions, to the fact that justice and democracy are of national interest, and the solution of our American Japanese problem must be a national solution, not sectional.

May we call your attention to a broadcast over NBC on Sunday, July 18, at 4:30 p.m. of the Town Hall of the Air? This whole problem is to be discussed, and we are hoping that large numbers of listeners will write in to Town Hall, following the program.

You have probably received a copy of the enclosed pamphlet. We have sent out over 20,000 of these, and are now mailing out the next 10,000. We have also sent 10,000 reprints of the Harper's article of June. These have been sent not to members, but to persons outside our membership, whom we feel might be interested. A new release is being sent out within a week, including a short resume of some of the things already done, to be sent to members only.

With limited office personnel, it is impossible to keep all of our members informed of our activities. Some method should certainly be worked out which would make this practicable. We shall work it in as soon as we possible can, for we do want

all of our members to feel a real part in the thing  
we are all trying to do.

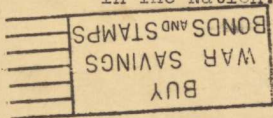



Because of your generous recommendations, Mr. Everett L. Dakan, Relocation Officer at Columbus, Ohio, has been kind enough to communicate with me regarding work opportunities in the Ohio area. Thank you, Mrs. Kingman, for your continued interest.

I have answered Mr. Dakan's letter today, and, followed his suggestion about filing an application for employment with the Cleveland WRA office.

Last month, after declining a situation offered through the American Friends Service Committee of Chicago, I came to the conclusion that, perhaps, it would be more advisable to seek placement through the WRA channels. Accordingly, in the latter part of June, I cancelled my application filed with the American Friends, and just two weeks ago contacted the Detroit, Michigan WRA office about jobs out there. No answer has been received as yet, but there appears to be a sufficiency of evacuee workers in that area at the present time, so it may be some time before I hear from them.

Now that, through your good office, Mr. Dakan has promised to keep me in mind, I feel almost confident about relocating within a month or two. Mr. Dakan informs me that the offer about which he wrote you--a position at the First Congregational Church of Columbus--has been postponed for the time being. But he conveyed his belief that there are possibilities of additions being made to the WRA staff, and encouraged me along that line: hence my application to Mr. Harold S. Fistere, Relocation Supervisor at Cleveland.

However the outcome, please accept my deep gratitude for all you have done. Your sincere interest and encouragement inspires me. I hope that my work will support your trust.
