CONVERSATION BETWEEN W. WADE HEAD, PROJECT DIRECTOR, AND H. H. TOWNSEND, SUPPLY AND TRANSPORTATION OFFICER, ON DECEMBER 1, 1942.

- Head - Good morning, Mr. Townsend
- Townsend - Good morning. I just got your memorandum and want to discuss it with you. Please let me apologize for my actions during the strike. I must have been so upset I didn't realize what I was doing. I was afraid that I and the other employees were going to be slaughtered by the Japs.
- Head - Mr. Townsend, if you do not mind, I am going to have notes kept on this conversation, inasmuch as your actions of the last few days have been such that they cause me to doubt your honesty and reliability. Do you object?
- Townsend - I don't blame you for wanting a record of everything I have to say.
- Head - Now, Mr. Townsend, you said you were frightened; did you actually see, personally, any signs of violence on the part of the people or the destruction of any government property.
- Townsend - Since having time to calm down I realize that there was no sign of violence, and now that the trouble has been settled and I have had time to look around, it is easy to see the crowd must have been peaceful all the time and there was no sign of any damage to any government property.
- Head - Do you consider that sufficient reason for leaving the project and failing your duties during the time of trouble?
- Townsend - I don't know what I meant. I lost my head I guess. I would have done more harm here than good (good) in that condition.
- Head - I think you have done more harm than good here ever since you came, and in the past few days it has been reported to me that you have been frightened ever since arriving, and that you have always carried a gun.
- Townsend - I think every employee here should be armed at all times.
- Head - If you think that, you absolutely have no business working here. This is no place for cowards nor unstable people. Besides, every government employee who places more importance on his own safety than his duty to the government is not fit to work for Uncle Sam. You were not only disloyal to your job, you were disloyal to John Evans, and disloyalty was displayed before all the project employees when he was in charge and was working under tremendous pressure. By the way, did you leave Poston in a government car?
- Townsend - Yes, I went to Parker in a government car and from there I caught a

ride with a friend to Los Angeles.

Head - I am extremely disappointed to find we have had an employee working here like you. It is easy to understand why you might have become upset, but I cannot understand why you became frightened and fled. You had a responsibility to the government to look after its property. We have employed you in a responsible position and put our confidence in you to carry out that job, then you fail completely; and besides, look at the men here with their families who were not afraid. Ralph's wife was here alone. She had planned to go to Phoenix for the week end but when the sitdown strike started, she immediately saw that her duty was here, and she stayed. She is not a government employee but she is a loyal American. Other men and their wives stayed with their children. To me, just at a time when you were most needed, you absolutely failed.

Townsend - I guess I can't blame you for feeling that way.

Head - I am sorry to say this, but never have I been so disappointed with a fellow employee as I have been with you. You insisted that the Army be called in, not because you thought that was best, but because you were afraid. "Yellow" is a good word for it. That would have been an easy way to settle this thing. Thank God, John Evans was not a coward. He displayed real character when he refused to follow your and a few other crackpots' advice. I want you and everyone else in the country to know that John Evans has my complete confidence and backing in every decision he made while here. If John had thought it was necessary to call the Army into Poston to protect government property or human lives, he would have done so, but at no time did he feel it was necessary. You can see now, from events, that it wasn't. Had the Army come in, no doubt there would have been some people shot. Our government knew what it was doing when it put these people here, and you know yourself that the strike wasn't due to anybody in jail, but due to the fact that we had failed to furnish some of the minimum necessities of life to them such as heating stoves and many other items and we would have been a bunch of cowards in taking advantage of them by marching the Army in and having defenseless people shot. There are many reasons he could not outline to you why the Army should not have been called in; I think it is unnecessary in your case to do it. I want to point out that the Japanese have many thousands of American prisoners and if anything happened here in which the Japanese would be shot or otherwise hurt, retaliation would no doubt have been taken against the various Americans held as Japanese prisoners.

Townsend - I see now that Evans was right; he was level headed.

Head - After your actions during this disturbance, as far as I'm concerned, it is too late in the day for you to change. To be perfectly fair and frank with you, I want you to know you would

not have been allowed to return to this project had not John Evans recommended it to me, but I am convinced in my own mind that it was a mistake.

Townsend - Would you like to have me hand in my resignation?

Head - Personally, I think you should, but probably it will be better inasmuch as you are working with Empie, that you discuss the matter with him. My personal feeling in this is that although you might do a good job in some other position, you are too emotionally unstable to work on a project like this. Anyone who will carry a gun and who will go around trying to frighten the employees by telling them they are not safe, has no business working here.

Townsend - I wish you could have seen how upset and disturbed I was and I think you could see my side.

Head - I have no more to say to you except this; you became emotionally upset and unstable at the time your services were most needed, so you have no business here. Mr. Townsend, in all the years I have worked, you are the first employee I have felt it was necessary to call a stenographer in to take notes on the conversation, and you realize as well as I, why I feel this is necessary.

Teachers in Relocation Camp Meet Chinese Airmen.

Place: Phoenix, Arizona, the "Mandarin".

Time: One week-end in March.

Persons: Four teachers from Poston Relocation Camp:

Martha Hayakawa, teacher of 6th grade. Graduate of Cal.

Mari Matsumoto, teacher of 7th grade. Graduate of Cal.

Myrtle Barley, teacher of 6th grade. ^{Church of} Brethren connections.

Winifred Hemingway, Per-school work. Returned from China.

Three Chinese boys with training from both Chinese and United States Air Units.

Events leading up to this evening:

All four girls have been in Poston since last fall and they have planned a trip to Phoenix for some time. They finally get permission and start out to see the world. Everything is new and exciting, on this first trip to the "Outside". Even the four-hour wait for the train at Parker doesn't dampen their enthusiasm. They wonder about getting a place to stay in Phoenix, as it is over-crowded; but some kind person at the U.S.O, finds a room in a small hotel where there are two beds so that question is solved. The next morning they go out to shop. Saturday shopping is always strenuous but the crowds seem especially large to these four who have been out of it for a while. They each have some things to buy but the main part of the day's work is filling the orders of friends in camp. It must remind Winnie of a trip to Peking with all the errands for friends both American and Chinese. In the evening they are exhausted but decide to go to a Chinese Restaurant for dinner as planned.

Now comes the High Point of the Day:

The Restaurant, "Mandarin", is crowded with guests and after the girls have given their order they have time to look around them. At a table nearby are three boys in uniform who look Chinese. They are speaking a foreign language and Winnie realizes that she can understand it as they are talking the national language of China. She sits still as long as possible and then goes over to speak to them. The boys are very cordial and just as thrilled as she to find someone who speaks their language. Mr. Yd, the spokesman, is from Tientsin and has not heard from his family there for three years. He is anxious to hear all he can about conditions in Occupied China. His English is as good as his Chinese, which means that it is excellent. The other two are Mr. Liu from Fukien and Mr. T'ang from Kwangtung. All three have been in the Chinese Air Force for several years and last fall were sent to this country for special additional training. They asked ~~abo~~ about the two girls, if they are Chinese or Japanese. When they hear that the girls are from a Relocation Camp they ask to be introduced. They say that they feel Americans of Japanese origin have nothing to do with the war even as ordinary citizens in Japan had nothing to do with bringing about the war. Then they ask if the four girls will go with them to the movies that evening. The special feature is a Newsreel showing a corps of Chinese Airmen receiving their Wings. The girls go to the movie and are thrilled as they see their new friends standing in the front row of the group receiving their second set of Wings.

An incident such as this does more to breakdown barriers of prejudice than hours of preaching. These boys, tho not connected with the church had more truly Christian ideas than many of us in Churches.

Sgt. Sugiyama Has Busy Day in Italy

Posthumous Report on
Brother of Poston's
First City Clerk

In a single day, Sgt. Togo Sugiyama from Los Angeles killed eight Germans, took one prisoner and was credited with knocking out or routing four machine-gun nests near Pastina, Italy.

Sugiyama's outfit, the 442nd, was fighting with the 34th "Red Bull" Infantry Division on the Fifth Army front at the time.

In the early morning attack on Hill 119, Sugiyama first supervised his squad in setting up their heavy machine-gun on a saddle-back between two hills to protect the advance of two companies of riflemen, along the forward slopes of both hills.

Having his guns and men emplaced, Sugiyama crawled along a ridge and established an observation post on a point of high ground about 75 feet away.

From his OP post the sergeant noticed an enemy machinegun and snipers firing on his gun positions from a point 150 yards away. He crawled 150 yards along the reverse side of the slope until he was opposite the enemy position. Using his Garand rifle, Sugiyama killed two snipers and drove off the machine gunners. Mr. and Mrs. Henry K. Akiyama, 12-10-D, received a telegram on Oct. 23, informing them that their son-in-law, John F. Aiso, 35, had been commissioned a major at Ft. Snelling.

Maj. Aiso, whose wife is the former Sumi Akiyama, entered the service three years ago and has been civilian director of academic training at the Snelling language school.

He was educated at Brown university, Harvard law school, Chuo university law school, and practiced law in New York.

Mrs. Aiso is a graduate of the USC school of music and was teaching violin in Los Angeles when she met her husband.

Maj. Aiso's parents reside at Manzanar.

Among the few Nisei majors, whose ranks were recently increased, is Maj. Frank Masao Ikuno, brother of Bill Ikuno, fund custodian for the local C.E.

Maj. Ikuno was born in Rock Springs, Wyo. where he graduated high school. In 1933 he graduated from the Massachusetts Institute of Technology.

A lieutenant colonel in the National Guard, Maj. Ikuno was called into service before the outbreak of the war. He is believed to be stationed in Alaska.

SGT. TOGO SUGIYAMA HAS BUSY DAY IN ITALY

Later, after returning to his OP, he sighted two snipers about 15 yards from his gun position. Taking a bag of grenades, he led three riflemen to the German dugout. He ordered the two snipers to surrender but one refused. Firing a rifle grenade into the dugout, Sugiyama killed the remaining German.

The German prisoner

was sent back to the battalion command post.

Early in the afternoon the Japanese-American squad leader located a hostile machinegun firing from a slope directly in the path of his advancing riflemen. Sgt. Sugiyama fired tracer bullets to indicate the enemy position and they were wiped out by the American riflemen.

Later, he noticed enemy troops in a concrete building 25 yards away on the right forward slope. Crawling 25 yards back, he went around the right reverse slope to warn the advancing infantrymen. He led a squad back and drove out the Germans.

He returned to his OP and sighted two light machine guns manned by eight Germans. They were crawling up a draw to ambush the advancing Americans and were below the line of fire of Sugiyama machineguns. He crawled forward 25 yards and took cover in a shallow ditch.

Firing rifle grenades he killed five Germans and the other three fled without their machineguns. This action drew fire from another machinegun 600 yards across the valley. The weapon withdrew, however, before he could return the fire.

Sgt. Sugiyama was reported killed in action in early July, 1944. His father, Yasukichi Sugiyama, resides at Rohwer center. His brother, Franklyn Sugiyama, was first city clerk here and chairman of the Unit I council. The latter relocated with his wife to Sweetmine, Utah last year, where he is now foreman with the Hudson Coal Mine.

A sister-in-law, Mrs. Lois Sano, is a resident of this center, at 6-4-B.

THOUGHTS PROMPTED BY ANTI-EVACUEE TIRADE

(The following thoughts were prompted by Lt. Governor Frederick Houser's recent address in Riverside, says Dr. Eubanks Carsner, U.S. Department of Agriculture senior pathologist in charge of sugar beet experimentation, who is stationed at Riverside, Calif.)

There is here, though, such a wide area of agreement among Democrats and Republicans and all the rest of us that choices among candidates are often sadly limited. The level of the wide area of agreement is low. President Roosevelt is reported to have once said, when chided with some of our reprehensible national policy: "There is an old Rumanian proverb 'It is permissible to walk with the devil until the bridge is passed'". Most Americans, I greatly fear, agree. Governor Dewey in his very shrewd pursuit of votes seems also to have profited by this "wisdom" of the Rumanians. As I understand some of his promises he will vigorously advance certain commendable ends of the New Deals but of course by superior means. His confidence in this appeal apparently has already caused heart failures among the old guard of both parties. The basic fallacious philosophy of ends and means that is involved might be restated: "It is right for me to do evil if good for me will come of it".

Does the pervasiveness of this pernicious philosophy prove that this is the only heritage which all who can call themselves Americans share in common? Probably it is the lowest common denominator. No! We have in common wisdom and goodness and justice and mercy that have come down to us from on High. These have come down to us through Moses, Isaiah, Jesus, Paul, Francis, Tolstoi, Kagawa, Buddha, Laotse, Mohammed and Gandhi...

Mr. Houser is, I believe, on the basis of limited information, admirably qualified in many ways to represent us citizens of California in the United States Senate. I had intended to vote for him. Now I am in a quandary about it. I do not want him to represent us at our lowest level. I do not know much about Senator Downey. Those who control the most accessible sources of information have seen to that. I wish I could vote for a man who means what he says when he repeats the American Creed: "with liberty and justice for all".

KUNIYOSHI TOPS CARNEGIE INSTITUTE SHOW

Yasuo Kuniyoshi, nationally known artist won the \$1,000 first prize in the annual Carnegie institute (Pittsburgh, Pa.) exhibition for "Painting in the United States", with a still life entitled "Room 110",

according to the Pacific Citizen on Oct. 14. "Room 110", which was adjudged best of 311 entries, depicts a group of unrelated items suspended from a plaster cast and rested on a tilted table top, against a backdrop of glass-fronted office door, the PC said.

Kuniyoshi previously won first prize at the 1940 San Francisco Fair for the best painting by an American artist. He has been teaching at the Art Students League and the New School for Social Research in New York City, and painting posters and writing broadcasts for the Office of War Information. Recently he presented to United China Relief the proceeds from a 20-year retrospective exhibition of his work. He is a native of Okayama, Japan and came to the United States at the age of 13.

THOUGHTS PROMPTED BY ANTI-EVACUEE TIRADE

(The following thoughts were prompted by Lt. Governor Frederick Houser's recent address in Riverside, says Dr. Eubanks Carsner, U.S. Department of Agriculture senior pathologist in charge of sugar beet experimentation, who is stationed at Riverside, Calif.)

...An end is something you go after, such as a seat in the United States Senate, a job, or anything else you want. Generally, all ends are more or less good. But if the way or the means you choose to attain an end are evil, then the end, such as election to a position of which you are unworthy, becomes evil...

Vote-getting is necessary in getting elected to a position of public trust. But the means of getting votes become evil when they include inciting hatred and violent mistreatment of American soldiers and their families. The evil of it is increased by the shrewd calculation that the people abused have practically no votes and that friends in this great Christian state of California are few. Americans of Japanese descent who might otherwise have voted in California in the coming election have valiantly made the supreme sacrifice for their country in all the theatres of this unspeakably evil global war. And among those who have not died, many others will not vote because they are wounded and in hospitals, or because when allowed to return, cannot come back to their rightful homes but must, in order to see their loved ones, go back to those Hitler-style places of "protective custody" in which we, because of ruthless selfishness, ignorant prejudice and hysterical fear, imprisoned them and continue to hold them. Where would Mr. Houser and I be if Americans of German descent had been so treated? Politicians perhaps would not then need to seek our votes. Must we condone tirades against an almost defenseless small minority of fellow Americans as merely campaign oratory? Do we want to entrust such a great responsibility as that of being one of our most important public officials to a man who exhibits such a low sense of moral values? We already have more than enough of that kind. (To be continued)

DR. H. YUASA INSPIRES CONGREGATION...

In his two days visit in Unit III, Dr. H. Yuasa gave an inspirational and educational lecture regarding the future of Japanese in America to a capacity congregation in all three places -- Chapel I 305, Chapel II 329 and 310 Mess hall.

Being able to attend only one of his lectures but thoroughly impressed at his voice that comes from wide experiences, we present to you parts of the talk he gave to the members of Fujinkai at 310 Thursday afternoon.

In his opinion, he believes that the future of the Nisei lies in America. Being born and reared here, all opportunity lies in this country for the Nisei, looking from a standpoint of economic and social advantages.

He also gave the congregation the picture of what kind of country America really is. Knowing that she is not a Christian country but a country striving to live up to Christianity and she is not a democracy but a country trying hard to live up to the ideal, we cannot feel that we are being discriminated against but must ourselves work toward making democracy a reality in America.

He also stated that there is not one minority group in this country that have not been discriminated against. We ourselves are guilty of it, but we do live in a country that is trying to overcome racial prejudice so it will be up to us to help it. He commended the Nisei soldiers who are sacrificing their lives to make America a better place for us to live in.
