The first meeting of the Executive Committee of the Granada Relocation Authority, Amache, Colorado was called to order by the Chairman Jimmy Yamanaka.

The roll showed 1 absent. Since Roy Iizuka, representative of Dist. 1 was unable to attend, it was represented by Walter Higuchi.

Recommendation was made to have an Executive Secretary to hold a full time job.

Duties of the Executive Secretary were discussed as follows:

1. He must act as liaison officer and not a man who makes decisions.
2. Must quote all statement he makes outside of the Council.
3. Must keep in constant contact with affairs in the Center, in regards to their committee work and progress.
4. Also keep in order all correspondence on behalf of the Committee.
5. Be a public relation man for the Council for visitors.

A suggestion was made to get some one outside of the Council, who would like this type of work.

Suggestion was made that we approach Mr. Y. Kubota and Harry Naka.

It was suggested and agreed that a letter of invitation be written to have someone of the Block Manager's to sit in our meetings.

It was suggested that the Executive Committee select 5 members outside of the Council to serve on the Judicial Commission. Discussion followed.

Recommendation was made that we let it up to the Council as to the decision of the Judicial Commission.

It was suggested not to put restriction to the Districts.

A request was made to re-appoint the 3 members from the Appointed Personnel to act on the Judicial Commission.

The Executive Committee is to call a meeting whenever they see fit.

It was suggested and agreed that they meet the hour prior to the Council, on Tuesday at 8 A.M.

Notices will be sent out to Cabinet members and Executive Committee.

Cabinet members of the Council are requested to attend the Executive Committee meetings.

Since no further business, the meeting was adjourned.


The duties of the members in the ten Committees named on the above paragraph are to investigate further, problems concerning their committee work.

 V Seishiro Fujioka


With the exception of District IV the Judicial Commission is complete.
