Dear Sir:

I have your letter of November 29, 1951 and a letter from Mr. T. Kono, The Tule Lake Defense Committee, dated November 17, 1951. First of all I would like to thank you very much for your extraordinary legal work rendered to cancel my renunciation of U.S. citizen which I assure must have been an extremely difficult legal work.

I realize that you are a busy man but I would like to to take a few minutes of your time by this letter to inquire in the court procedure as I am slightly confused in the decision of the Circuit Court which reversed the ruling of the U.S. District Court in cancelling the renunciations in our favor. On October 10, 1951, Nippon Times, a newspaper in Tokyo, published an article stating that the Supreme Court denied a hearing to approximately 4,000 Nisei seeking U.S. citizen (a copy of this publication is attached on a separate sheet.)

My legal knowledge is very small and my interpretation of the Supreme Court denying a hearing meant that it had upheld the decision of the Circuit Court and an unfavorable decision to the renunciants. This I thought was the final verdict.

I am more than happy to pay the sum of \$300.00 for your past six years of tedious task but the reason for the inquiry is whether the decision is favorable or unfavorable in cancelling my renunciation and restoring my citizenship.

Hoping that I will be able to receive a reply from you and please note change of address.

4,000 NISEI SEEKING U.S. STATUS TURNED DOWN BY SUPREME COURT

Kyodo-AP

WASHINGTON, Oct. 9--The Supreme Court Monday denied a hearing to approximately 4,000 persons of Japanese ancestry residing on the West Coast who seek official declarations that they are U.S. citizens.

All of them were born in this country. While held in relocation centers during World War II they signed renunciations of American citizenship. Their attorneys asserted these renunciations were signed because of coercion by Government agents.

The U.S. District Court in San Francisco agreed with the attorneys, ordered the renunciations canceled, and declared the persons to be U.S. citizens. This action was appealed to the U.S. Circuit Court in San Francisco by the Justice Department, where the finding of coercion was asserted by the Government to be "clearly erroneous."

The Circuit Court ruled in favor of the Department. It said many of the persons had voluntarily renounced their citizenship, some had been disloyal to the United States, many became interested in cancellation of the renunciations only when the collapse of Japan indicated living conditions in this country would be better than in the Orient, and many who had spent their youth in Japan were definitely pro-Japanese.

A companion appeal filed in the Supreme Court by 122 other Nisei also was refused by the high tribunal.

The 122 also signed denunciations and the Government issued orders for their removal to Japan, under an Alien Enemy Act of 1798. The Government contended that under Japanese law the renunciations were subjects of Japan.

The Supreme Court's refusal to hear the two appeals means that the cases now go back to the U.S. District Court.





Dear Mr. Uchida:

In answer to your letter of August 4, 1961, I wish to inform you that you applied to be joined in litigation in the U.S. District Court in an endeavor to have your renunciation of citizenship canceled and to be declared a U.S. citizen. I informed you by letter of the fact that you were joined in the litigation as a party-plaintiff on August 23, 1948. Thereafter I wrote to you, as also did the Tule Lake Defense Committee which represented the renunciants in the litigation in dealings with me. I also wrote you and informed you, as did the Tule Lake Defense Committee, that I was successful in having a final judgment entered in the U.S. District Court.

Thereafter, I wrote and informed you that the Attorney General and other defendants had appealed the cases to the Court of Appeals for the Ninth Circuit and that the Circuit Court had affirmed the judgment as to some and reopened the case as to a majority in order to enable the Attorney General to submit additional evidence against each of the plaintiffs. Thereafter, I notified you that the Attorney General and other defendants applied to the U.S. Supreme Court to review the cases and that that court declined to take jurisdiction of the cases. Thereafter, I wrote you and informed you that the mandate of the Court of Appeals was handed down to the U.S. District Court and that the judgment that I entered in your favor became conclusive and that the judgment canceled your renunciation and declared you to be a U.S. citizen.

I wrote to you several letters in Japan requesting you to notify me of the address to which you intended to return in the United States but you did not communicate that information to me. I have a letter from you stating in part "I am more than happy to pay the sum of \$300.00" for the services I had rendered.

A certified copy of the conclusive judgment canceling your renunciation and declaring you to be a U.S. citizen was forwarded to your Japan address. For your information, the legal services


In reply to your letter of September 18, 1961, that my name was joined in the litigation against the Attorney General of the United States may have had legal benefit had I been physically present in the United States.

As you are aware as an attorney that the Attorney General of the United States never had or ever have jurisdiction to exercise the laws of the United States on Japanese soil and the United States State Department is vested with the authority to exercise the approval of applicants to be reinstated as U. S. citizen on foreign land.

Although, you state the case was conclusive, I had to file a litigation with the Japanese courts and be processed by the U. S. State Department as any normal citizen of Japanese ancestry applying to return to the United States. I believe this method has taken 5 years of my life since the judgment you claim was not conclusive to the U. S. State Department which I feel the loss^{of} time and monetary value is quite large. If the fee you claim is valid and judgment conclusive on foreign soil, I believe that I have a justified claim against the U. S. State Department for the delay of issuing the necessary paper for my return to the United States.

In view of the above, I feel that I did not receive an enforceable right to return to the United States from your judgment as a citizen and the fee you claim is exorbitant.
