Dear Sir:

I am writing in behalf of my brother Isami and myself in regards to our property which is located in Dabob, Jefferson County, Washington.

We the American citizen were forced to evacuate from West Coast in June 1942 leaving our beloved property and friends behind like all Japanese aliens and were placed in Tulelake Concentration Camp until December 1945 when we expatriated to Japan. We renounced our citizenship because we were told that no citizen will be able to expatriate, they will be automatically be denounced, so to make it sure that we will be able to accompany our aged parents we renounced. After evacuation aged parents were in failing health because father is 70 and mother 68 years old, having to leave their beloved home and friends behind as well as us. They were hospitalized number of times during our camp living and they insisted that they want to go back to Japan to have graveside memorial services for their late parents before their health fails. It is the responsibility of my brother Isami to see and support the parents but he asked me to accompany too because I a nurse to comfort my aged parents on the trip.

Brother Isami was running a dairy on 160 acres farm and was selling milk to city, Army and Navy Department until evacuation which at that time had to sell all the livestock before we left our dear home and friends behind.

Our property is located at Dabob, Jefferson County, State of Washington. Our agent is paying our taxes during our absence from our Farm Account, so will you please kindly send me the necessary information what will be done to our property because we are in Japan. I would also like to know if the property can be turned over to an American citizen who is now residing in United States, if so, what procedure can I take to take action on it? Also, I would like to know about our Bank Account in State of Washington.

Brother is now working for Liaison Office and I am working for the Kumamoto Ken Public Health Department. This was our first trip to Japan as well as for my aged parents, its their first trip back in 50 years so I could not convince them to later date. To tell you the truth I am having a hard time because I only know English and am waiting for the day that I can get my foot on good ole States soils.

Will you kindly address the letter to Major R. Hartman and he  
will forward it to me.

I will appreciate very much for your immediate action and will  
be waiting for your answer.

Dear Miss Iseri:

In answer to your letter of April 14th, please be informed that under the provisions of Trading With the Enemy Act, the Alien Property Custodian, whose functions recently were assumed by the Attorney General, had jurisdiction over property of U.S. citizens and aliens and resident aliens who are outside our continental limits. The past procedure practiced by that office was to vest title to the property of each person and later convert the property into cash and deposit it in a special funds account of the Alien Property Custodian and thereafter await authority from Congress as to whether or not it would be appropriated by our government or be returned to the original owners.

If your agent is handling the property on your behalf it is my suggestion that you take no action in connection therewith except to enable him to cooperate the property for your benefit.

There is no reason for you to transfer your money to another person. It is likely that your bank account in the State of Washington still remains in your name. You may be able to draw upon that account when Congress or the President officially declares the war to be ended or when a peace treaty with Japan is entered into. It is my suggestion that you write to the Alien Property Custodian in the State of Washington and ascertain whether or not your bank account has been seized by the Alien Property Custodian acting through the Federal Reserve Bank.

Under Title 8 U.S. Code, Sec. 903, any person who claims U.S. citizenship is entitled to return to the United States if he does as follows: (1) Either files a suit or joins a pending suit in the U.S. District Court in the U.S. where he claims his residence "to declare his U.S. nationality", (2) prepares a sworn application stating that the claim to U.S. nationality

in said suit is presented in good faith and has substantial basis. Take or obtain such application from a diplomatic or consular officer of the U.S. in Japan. He will issue a certificate of identity stating his nationality is pending before the court. If the consul refused to issue the certificate, he can appeal to the Secretary of State in Washington, D.C.

If you and your brother desire to be included in equity suit No. 25294-S in the U.S. District Court for the Northern District of California, Southern Division, which already includes in excess of 1600 renunciants, which is a suit to declare the U.S. nationality of each of the parties plaintiff, it is my suggestion that you notify me immediately via air mail inasmuch as names cannot be added to that case after a decision is rendered. From day to day I am expecting that decision to be rendered.

Dear Miss Iseri:

You and your brother, Isami, have been included in equity suit No. 25294-S in the U.S. District Court for the Northern District of California, Southern Division, which is a suit to determine the U.S. nationality of each plaintiff. The American consul in Yokohama is being notified that you and your brother are plaintiffs in said suit.

Under the provisions of Title 8 U.S. Code, Sec. 903, any person who claims U.S. citizenship is entitled to return to the United States if he does as follows: (1) Either files a suit or joins a pending suit in the U.S. District Court in the U.S. where he claims his residence "to declare his U.S. nationality", (2) Prepares a sworn application stating that the claim to U.S. nationality in said suit is presented in good faith and has substantial basis. Take or obtain such application from a diplomatic or consular officer of the United States in Japan. He will issue a certificate of identity stating his nationality is pending before the court. If the consul refuses to issue the certificate, he can appeal to the Secretary of State in Washington, D.C.

Please send me card or letter stating your full names, age, present address, address before evacuation, names of members of your family and whether in the United States or Japan, and requesting that each of you be included in the suit.

Correcting letter sent to you on April 25th, do not write to the Alien Property Custodian but to your agent in State of Washington who can inform you whether or not your account has been blocked.

You have asked the question that if a repatriate came to the United States, how long would they have to be here in order to be naturalized and can they be naturalized. I am unable to answer such a question inasmuch as I do not know the circumstances under which the repatriate would return to the United States. If you will inform me who the repatriate is and whether or not he or she once had U.S. citizenship, and how such person lost citizenship, I may be able to inform you how such a person could return to the United States, the basis thereof and whether or not such person would be eligible for naturalization.

If you wish to receive your individual certified copy of the "Final Judgment" of the Court that cancels your wartime renunciation of citizenship and that declares you to be a U.S. citizen, you can obtain it from me by sending to me the \$ 300.00 balance due on your account. Sometime in the future you may need this document to prove your citizenship, to obtain a passport, to establish your right to vote, in applying for employment, Social Security benefits, various licenses, loyalty checkup, etc. If it presses you too much to pay your balance in a lump sum, you can let me know and arrangements can be made for you to pay the balance by installments.
