STUDENT COUNCIL MEETING

January 11, 1943

Present at the meeting were: Tots Ishida, Terry Nishida, Grace Kushino, Shinobu Kodama, Miyoko Mikasa, Kazuko Nakamich, Violet Takeda, Masato Asakawa, Toyoko Hattori and William Fujino.

Tots Ishida called the meeting to order and asked if the Council was ready to vote on whether or not the group would disband as a leadership class. After discussion, the group decided that it would postpone any action of disbanding until the work which has been "put on the table" was completed. A motion was made, seconded and passed unanimously to elect a faculty adviser for the class. The following were nominated: Jimmy Urata, Miss Gilchrist, Miss Atkinson and Miss McNulty and George Takaoka. Jimmy Urata received the majority votes, so he will be asked if he would accept the position.

Mr. Tashiro stepped in and inquired if the Leadership Class knew about the flag being donated by Mr. Ted Hiramoto to the school. He explained that Mr. Hiramoto is sending for his flag at home and will donate it to the school if the express charge is taken care of. In the meantime, Miss Warvorovsky's Core class had taken it upon themselves to launch a campaign to collect contributions from the core classes in order to purchase a flag. The boys in the class even went so far as to go out into the woods to chop down a ~~large~~ tree for a flag pole. Mr. Tashiro suggested that the money already collected could be used to pay express charges on Mr. Hiramoto's donated flag. A council member said that the classes had decided to return the contributions and that the Senior ~~Class~~ Core Classes will pay for the express.

Since Mr. Jimmy Urata who was elected faculty adviser of the Leadership Class is not a high school teacher, the group decided to reconsider the election. A motion was made, seconded and passed to hold re-nominations. Mr. Take Taniguchi was nominated. The nominations was closed, automatically electing Mr. Taniguchi. The council will ask Mr. Taniguchi if he will be willing to accept the position.

1. That the quickest way of ratifying the proposed constitution is to submit it to each core to study it, discuss it, and that as a student we should request time from Core Class to discuss the constitution.
2. That three representatives be the leaders in their respective core during discussion and exchange the various points brought up during the discussion at the following meeting.

Then Mr. McLaren asked if he should ask the cooperation of all Core teachers to give up Core time to discuss the constitution.

After a bit of discussion on this matter by several students from the floor, it seemed that the majority of the body wanted part of the Core time to study the constitution.

It was announced by Itsumi Oita that the following meeting will be held at Mrs deSylva's Room, during activity, Wednesday, January 27th, 1943. He also asked the full cooperation of all the students to be on time. He urged those present today to notify those who were not present. The matter will be continued exactly where we left off today, the main issue being, "How We Should Carry the Discussion of the Constitution in the Core Classes.

Vote taken on constitution by Rep. Council and ratified by two-thirds vote of 15. The chairman asked why some of the classes voted against it. Some of the classes did not vote. The Rep. from the Jr. class of Blk. 59 period 1 and 2 said that their class wanted the program chairman to be one of the officers, because they thought the Vice President had enough work to do and would be overburdened.

The coming Student Body election was discussed. Constitution states that only Jrs. can run for the office of president, but since this is a special election, only Srs. can run for president. The other offices are open to any of the classes.

S.C.—Petitions for candidates for offices to be started immediately and petitions are to be handed in to the core class rep. by Monday, March 1 by 5:00 P.M. The Rep. St. Body council will meet Tuesday, March 2 to determine eligibility of the nominees. Council will be empowered to make additions to the nominations. 3 lots to be formed at that meeting. Council will suggest to Dr. Harris that we would like to have an hour assembly on March 4, Thursday.

S.C.—Election to be conducted on the following day, March 5, Friday.

March 9, Tuesday, the first meeting of the S.B. R.p. Assembly will be held. All the reps. of each core class, the presidents of the three classes, and the new student body officers are to be present at that meeting.

The 1st and 2nd period Sr. Core Class Representatives are to put the results of the S.B. election on the core class blackboards. The representative for each class is to collect the petitions circulating in their classes--get the candidate's and the core class teacher's approval on the petition.

Mr. Kennedy, director of Employment, made an announcement about part-time work, registering everyone in P_oston. They want 200 to 250 workers. He said he would prefer students--especially Juniors and S_eniors. Work would be mostly copy work. Those interested are to report at Mess 32 between 8:30 and 11:30 a.m.

S.C.--Dr. Harris and Business Manager to sign all checks of the Student Body with the approval of the council.

Present at the meeting to organize an all-Poston Schools softball league were four representatives from Unit II, four from Unit III, namely Nobuo Honda, Leo Minami, Jiro Kodama, and Tots Ishida, and also Mr. DeSilva, head of the Physical Education Department for boys in Poston. Unit I failed to be represented.

Harry Menda, athletic manager of Poston II High School, acted as chairman of the meeting.

"A" and "B" leagues were suggested with athletes being classified as to ability. A "C" league was also brought up but the idea of having too many leagues would probably run into transportation difficulties therefore the probability of having a "C" league is very vague.

All students participating in this league must be bonifide high school students. Post graduate students are ineligible for participation.

Suggestions for names for the league were PISL (Poston Interscholastic Softball League) and PIAL (Poston Interscholastic Athletic League).

Dates for the games would be on week days, sometime in the afternoon because school time cannot be utilized for athletic contests and also because trucks would not be available after supper.

Mr. DESilva then brought up the fact that WRA had recently passed a new ruling stating that no more trucks should be used for athletics, socials, and recreational gatherings, but how much effect this would have on the formation of this league he did not know. He added that transportation was the greatest drawback to the development of this softball circuit.

Rules and regulations to be followed are those in the National Softball Rulebook, with the exception of the 10 men team. The team, instead of 10 men, will consist of 9 men to liven up the sport.

The length of a game is to be 7 innings with no tie games except when circumstances prevent further playing.

Only softball spikes are to be used.
A softball squad will be limited to 15 players.
The home team will be required to furnish the softballs.
No school students are to be used as umpires.

A copy of the minutes of this meeting will be sent to Camp I for its approval. In case Unit I fails to enter the league, both A and B teams of Unit II and III would engage in a 4 out of 7 series.

The initial inter-school game in Poston has been tentatively set for April 30th in Unit II between Camps II and III.

The proposed faculty scholarship which was generally approved by the faculty in a informal manner was approved by the School Policies committee according to the report given by Mr. Aoki.

The School Policies Committee recommended first that funds be raised among the faculty with no ceiling nor a floor be placed on the donations; Secondly, that the amount to be raised would depend on the voluntary contributions rather than any definite amount; Thirdly that the deal line for contributions tentatively will be Saturday June 19; Fourthly, the scholarship can be awarded to the students planning to attend either trade school or a college; fifthly the funds will be collected at the school office.

Miss Hunt and Mr. Ikeda was to act as Treasurers. The recommendation was accepted unanimously by the faculty.

Circular #79 and Confidential Rating sheets were passed out to those present. Circular #79 was read and discussed, correction was made on the rating sheet. The Rating Sheets are to be turned in before the end of the school term, June 28. Report cards will be given out on the 30th. Senior grades must be in by the 18th, report to parents by the 28th. Final examination by the 18th and all others by the 25th. June 25th, 6:00 A.M. Will be the deadline for students to turn in their grades to their respective core teachers.

Storing of books and class room equipment was discussed. It was announced that since the secondary grades will be held at the new

A general assembly of the whole Student Body was called to order by President Istumi Oita. The minutes of the previous meeting were read. There was a correction made. The amount made out to the Jr. Red Cross was \$9.96 instead of \$10.00. Otherwise they stood approved as read.

Mr. McLaren, Principal addressed the Student Body. He declared Monday, June, 28, as "Moving day", a day set aside for cleaning up the various class rooms for the summer vacation.
