VII. NARRATIVE...ANY SIGNIFICANT DEVELOPMENTS, E.G. (1) NEW PROCEDURES, (2) RELATIONSHIPS WITH OTHER AGENCIES (3) MENTAL OR OTHER PROBLEM CASES:

Dr. Pressman, in a meeting with the Principal Medical Officer, Hospital Administrator, Chief Nurse, Medical Social Worker, Project Director, Relocation Officer and Welfare Department, explained procedures to be followed in relocation of hospitalized and clinic patients.

Procedures regarding responsibility of Medical Social Worker to Welfare and Relocation Divisions have been worked out and are being tried out.

Dr. Kiyasu and Dr. Koda have been appointed for special clinics to be held on Fridays for the purpose of examining patients who are relocating. The charts of these patients are first reviewed by the Medical Social Worker and those for whom we need specific recommendations are given appointments. Mimeographed reports sheets have been worked out between the Health and Welfare Divisions and are signed by the examining physicians and approved by the Principal Medical Officer and sent to either Welfare or Relocation Division immediately.

Medical Social Worker was appointed by the Project Director to the Staff Relocation Committee.

Arrangements for a psychiatrist to hold clinics for patients referred by the Medical Social Worker and Division of Social Welfare are made to begin February 4.

Conference with Mr. Reynolds, Employment Officer, and an evacuee worker in charge of the unemployment compensation, has resulted in a smoother functioning of the sick leave procedures. It was decided that all sick leaves should be routed to Butte Employment Office and that Office will assume responsibility for referring to Canal. Compensation, however, goes directly from this Office to the Canal Office.

Miss Retzloff, Administrative Director of the Crippled Children Services, Social Security, Arizona, visited the Project in the interest of our patients.

VII. NARRATIVE...ANY SIGNIFICANT DEVELOPMENTS, E.G. (1) NEW PROCEDURES, (2) RELATIONSHIPS WITH OTHER AGENCIES (3) MENTAL OR OTHER PROBLEM CASES:

(1) A psychiatric Clinic was held on February 4, 1945-Dr. Edward Blank of Phoenix as the psychiatrist. Histories were submitted and he saw four patients. One Commitment was advised. One, a discharged patient from a hospital, was discharged as cured; the other two are to see him on his next visit. It was suggested and accepted by Dr. Blank, that histories would be forwarded to him the week before he came to the Center. This will enable him to be familiar with the cases, to see more patients, and give more time to them. We are asking him to return on March 10, 1945.


(2) A conference was held with Dr. Jeremiah Metzger, Acting Director of the Arizona State Hospital, in regard to the admission of a patient to the Hospital since all feeble-minded patients are admitted there. He was most reluctant to admit her because of the poor facilities which they have. He also stated that they are very short of beds and that they are requesting the transfer of one patient (Mr. Tohei Osaki) whom he had kept for a few more weeks at the request of Dr. Pressman while he was here. He is extremely concerned about accepting very many of our patients due to the shortage of beds. We believe part of this may be due to his concern over his budget which has been cut by the State Legislature which is now in session.

(3) The Medical Social Worker visited the Veterans Bureau, Phoenix, concerning our problem of securing medical information for medically discharged soldiers also information regarding education under the G.I. Bill of Rights. Interest in our problem was expressed by the Director of V.B. and he assured us of his assistance. He suggested that we visit the Veterans Bureau Hospital at Tucson in order to establish a good working relationship which would assist us in securing adequate medical data on soldiers discharged under Section X.

(4) Attended conference (on Project) with the Area Field Representative of the American Red Cross and the Executive Secretary of Tucson A.R.C. Veterans Bureau. Cases of our returning discharged soldiers were discussed particularly the educational and vocational training available. Procedures for obtaining information, also for applications to be made for World War I veterans with disabilities not service connected were outlined. Other new legislation and policies were discussed. This has been a real problem for the Welfare Agency and this Department. We feel now that there is a much better understanding of the scope of our need for service on the part of Red Cross and Veterans Bureau in Tucson. The meeting was extremely beneficial to us.

(5) Attended luncheon, afternoon and evening meeting of Arizona Chapter of the American Association of Social Workers in Phoenix. Mr. Joseph Anderson, Executive Secretary of A.A.S.W. spoke at all meetings.

VII. NARRATIVE...ANY SIGNIFICANT DEVELOPMENTS, E.G. (1) NEW PROCEDURES, (2) RELATIONSHIPS WITH OTHER AGENCIES (3) MENTAL OR OTHER PROBLEM CASES:

Three patients were transferred from our tuberculosis wards to San Luis Obispo County Hospital, three to Fresno County Hospital, and one to Santa Barbara County Hospital.

One patient was examined in Crippled Children's Clinic, Phoenix.

Medical Social Worker consulted with Mrs. Woods and Mrs. Carnes, Los Angeles, on procedures in transferring bed patients from our hospital to Los Angeles County Hospitals, and also for transferring patients through Los Angeles to points north. A procedure was worked out which seems to be satisfactory.

One of the teachers was detailed to Medical Social Service for half-time until August 31.

For the past six weeks it has been very difficult to secure medical charts from the Butte Record Room. Charts of clinic patients are reported as "Not in" and "No record" in about half of the cases for which we ask. No explanation for the "Not in" charts can be given and the "No record" are often patients who are chest, diabetic, etc., who are known to the department and to other divisions as ill patients. Our report to the Welfare Division on "no records" are erroneous and embarrassing in many recent cases. Canal Clinic has been closed and the medical charts have been transferred to Butte. We are now having difficulty in securing these charts.

The result is that Medical Social Service is not giving necessary service to Welfare and Relocation Divisions as both sections need accurate medical information. It is also resulting in delayed or no reports of tuberculosis, lentic and gonorrhoeal cases to County Departments of Health. The Medical Social Worker has offered to work certain evenings each week with the new Record Clerk in order to systematize the files.
