STATEMENT BY WAYNE M. COLLINS, TRUSTEE FOR VARIOUS LITIGANTS

The interest is derived from a special litigation account, namely, Savings Account No. 792754 in the First Western Bank and Trust Company (formerly the San Francisco Bank), 405 Montgomery Street, San Francisco, California, held in my name as Trustee for litigation purposes.

The trust funds have been received by me as trustee for litigation purposes from a substantial number of a group of some 4,354 persons plaintiffs in mass class equity proceedings Nos. 25294-5 pending in the U. S. District Court in San Francisco, entitled Abo, Furuya, et al., v. Brownell (Attorney General), Barber (District Director USI&NS) etc. et. al. and from them for individual administrative causes pending before the U. S. Attorney General. The litigation and administrative remedies involve the cancellation of wartime renunciations of U. S. nationality made by Nisei citizens while detained in our concentration camps simply because of their lineage.

The number of plaintiffs originally was 4,354. Of these some 100 individual causes have been dismissed for various reasons, on request or by virtue of the fact that the administrative remedies pursued have been successful and they have recovered their citizenship under the provisions of Public Law 515. Of the remainder some 1,004, pursuant to order of court have been successful in having their renunciations of U. S. nationality voided and the judgments thereon are final and conclusive. An additional 469 have succeeded in administrative

remedies and final and conclusive judgments have been entered in their individual favor. Approximately 50 additional persons are awaiting the entry of like individual judgments in their favor. Administrative processing is proceeding for the remainder and those unsuccessful therein will have individual court trials.

The trust funds from which the interest has been derived and accumulated thereon are held in Savings Account No. 792754 by me as Trustee for the current plaintiffs in said litigation who have contributed the same for such purposes. The maximum amount contributed by any particular plaintiff thereto does not exceed the sum of \$300. Many contributed appreciably smaller sums and a number contributed nothing by reason of poverty.

The trust funds, as received by me, have been deposited forthwith in said trust savings account and the interest which has been received thereon is credited to said account and constitutes an integral part of the trust funds. From this trust savings account, as needed, are withdrawn into a special commercial account in said Bank to defray the costs and expenses necessary to prosecute the cases to conclusion administratively and in court. The following is a statement of the amount of the trust fund, the maximum number of contributors thereto, the average amount of individual contribution thereto and the average interest received thereon per individual contributor from 1951 through 1954, viz:

The trust litigation fund, presently amounting to approximately \$147,000 covers ~~time~~ approximately 2,731 plaintiffs whose individual cases presently are being processed administratively for possible clearance by the U.S. Justice Department and final judgment thereafter, if successful, or for ultimate individual court trials thereon by those ~~who~~ who are unsuccessful ~~therein~~ in their administrative remedies.
