Dear Mr. Yamashiroya:

If you wish to receive your individual certified copy of the "Final Judgment" of the Court that cancels your wartime renunciation of citizenship and that declares you to be a U.S. citizen, you can obtain it from me by sending to me the \$ 300.00 balance due on your account. Sometime in the future you may need this document to prove your citizenship, to obtain a passport, to establish your right to vote, in applying for employment, Social Security benefits, various licenses, loyalty checkup, etc. If it presses you too much to pay your balance in a lump sum, you can let me know and arrangements can be made for you to pay the balance by installments. I am enclosing a stamped envelope for your reply.

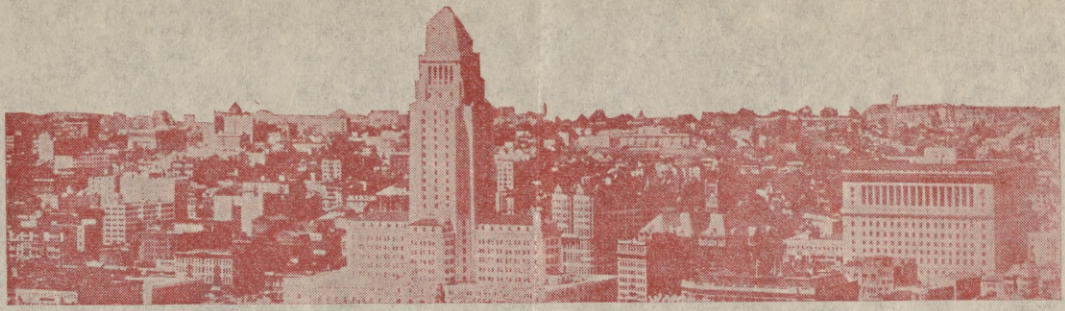

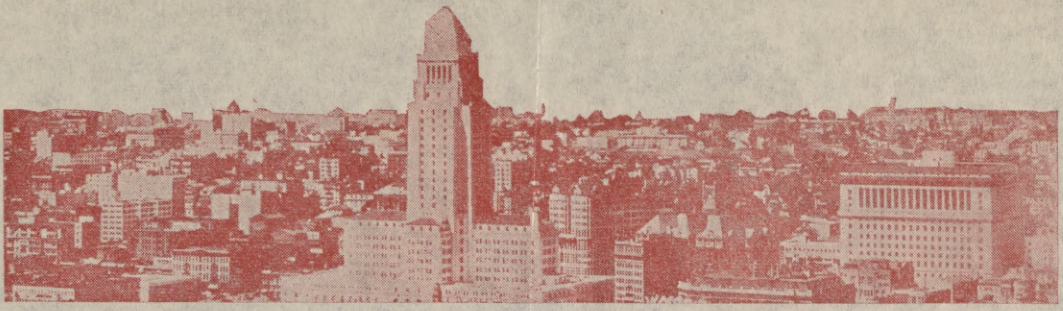

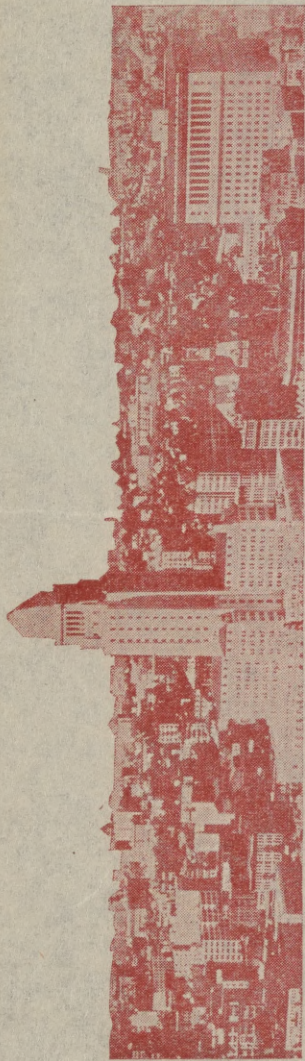

Translation of letter in Japanese

November 8, 1961

Dear Mr. Collins:

I am sorry to have delayed answering your letter and bills but the \$300.00 which you state I owe will never be paid by me. Following is the reason why:

When I was in Crystal City Mr. Shimizu came to me and asked me to join the case which you were handling. I told him that I had no money and since there is no danger of deportation I did not wish to join the case. However, Mr. Shimizu insisted and said that I didn't have to pay any money because the committee had plenty of money which the other renunciants contributed so please join the case. Mr. Shimizu insisted so much that I told him I would join the case. Therefore, I feel that I do not owe any money and will never pay the \$300 you request.
