

You are hereby notified that, pursuant to Section 401(i) of the Nationality Act of 1940, as Amended, and the regulations issued pursuant thereto, your renunciation of United States nationality has been approved by the Attorney General as not contrary to the interests of national defense. Accordingly you are no longer a citizen of the United States of America nor are you entitled to any of the rights and privileges of such citizenship.



Dear Sir:

I have for reply your letter to the Attorney General asking that your renunciation of citizenship be canceled. Having executed an application for permission to renounce your citizenship, you appeared on February 10, 1945 before a Hearing Officer appointed by the Attorney General and executed the final renunciation. This renunciation was approved as not contrary to the interests of national defense by the Attorney General on April 30, 1945. You will recall that at the time you executed the final renunciation form you were given a careful hearing and were asked why you wished to renounce your citizenship and whether you understood the consequences of your act and that you indicated that you did understand what you were doing and that it was your own wish to give up your citizenship.

Upon the approval by the Attorney General of your renunciation of citizenship, pursuant to Section 401(i) of the Nationality Act of 1940 as amended, you ceased to be a United States citizen and became an alien. Neither the Attorney General nor any other officer of this Government has any power under the law to restore your citizenship to you and there is no way under the law by which your renunciation of United States citizenship can be canceled.

Since you are an alien and since you are a person of Japanese ancestry and a person who has shown loyalty to Japan by voluntarily renouncing his United States citizenship during the existence of a war between the United States and Japan, it is presumed that under the laws of Japan you are a national of Japan. Thus you are deemed to be an alien enemy and subject to control as such pursuant to Section 21, Title 50, U. S. Code.

In the event that, since your renunciation hearing, your loyalties have changed and you have realized your mistake, I regret the tragic consequences of your earlier act. The renunciation procedure, however, is surrounded as much as possible by safeguards to make sure that renunciants understand what they are doing; and, once the renunciation is complete, there is no way in which it can be undone.

Dear Sir:

On February 10, 1945, I signed an application for renunciation of U. S. nationality form at the W.R.A. Segregation Center situated at Tule Lake, Modoc County, California, at a perfunctory appearance before a government official. (And I have received a letter dated October 15, 1945, from Mr. Herbert Wechsler, Assistant Attorney General, approving the same.)

I hereby repudiate, withdraw, retract, and revoke the said renunciation upon the following ground and for the following reasons:

(1) The circumstances under which said renunciation form was signed by me did not constitute a fair and impartial hearing and was a denial of my constitutional guaranty of due process of law and of the equal protection of the laws;

(2) I was not a free agent at the time when and the place where said renunciation form was signed but was then and there held in duress and was the victim of fraud, menace, and undue influence and mistake of fact and law;

(3) I then and there was continuously from May 15, 1942 had been detained in the said W.R.A. Segregation Center by official authority and was deprived of substantially all my constitutional rights, liberties, privileges and immunities as an American citizen by birth and by choice and was thusly discriminated against solely by reason of the Japanese nationality of my ancestors;

(4) I was intimidated and compelled to sign the said renunciation form by threats of physical evidence to myself (and members of my family) made by a pressure group in said camp, by members thereof, and I was in constant fear, (as was my family) that said threats would be carried into execution if refused to sign it. I was acting under the menace and fraud of said group and its members and the undue influence exerted by them upon me and I signed said renunciation form under duress.

Because of the foregoing reasons the said renunciation (and approval thereof) were, and each of them is, invalid,

null, and void.

I am not a citizen or subject of Japan and I do not and did not give any allegiance to that country or nation. I am ~~not~~ an alien enemy. I am a native American by birth and also by choice. I recognize as my sovereign the United States of America and I give and ever have given the United States my undivided loyalty and allegiance. I have no dual citizenship.

Therefore I demand that you withdraw and set aside the said renunciation form which is repudiated, recall, withdraw, cancel, and revoke your approval of said renunciation form.

I am ready and willing to have this matter re-opened and a hearing be granted me in order to prove that said renunciation form was signed when I was not a free agent in any sense of the words but was acting under duress and under menace, fraud and undue influence and mistake of fact and law.

I respectfully request your immediate consideration of this urgent matter.

Sir:

On October 16, 1945, I was requested by Mr. Ivan Williams, Officer in Charge, Immigration and Naturalization Service, Department of Justice, Tule Lake Center, Newell, California, to appear before their officer to register under the provisions of the Alien Registration Act.

Although I appeared before the office to comply with the provisions of the Alien Registration Act, I wish to state that said registration form was signed by myself under protest.

I am an American Citizen. Although within the non-repatriation form it indicated in Question No. 2 that my nationality was Japanese, I hereby wish to protest said designation as I am not a citizen or a national of Japan, but a citizen and national of the United States.

Therefore I shall appreciate your accepting this letter as a documentary evidence that my signature affixed on said Alien Registration form and information furnished in Question No. 2 for the non-repatriation form was done so under protest, as I am an American Citizen.
