TO ALL DEPOSITORS AND CREDITORS:

You are hereby notified that on December 8, 1941, the Superintendent of Banks of the State of California, took possession of the property and business of The Yokohama Specie Bank, Ltd., with its principal California office in the City and County of San Francisco and a branch office in the County of Los Angeles, State of California, pursuant to the Bank Act of the State of California. On January 12, 1942, the Bank was placed in Conservatorship in accordance with Section 135c of the Bank Act, under said Superintendent as Conservator and now said Superintendent does hereby place the affairs of said business in liquidation in accordance with said Bank Act and also in accordance with the "ORDER AUTHORIZING LIQUIDATION OF BUSINESS AND PROPERTY OF BANK IN CONSERVATORSHIP" made and entered on the 13th day of March, 1945, IN THE SUPERIOR COURT OF THE STATE OF CALIFORNIA, IN AND FOR THE CITY AND COUNTY OF SAN FRANCISCO.

Notice is hereby further given to all persons, firms and corporations who have any claim or claims of any nature whatsoever against The Yokohama Specie Bank, Ltd., San Francisco, with a branch in Los Angeles, or who have any claim or claims against any property of any character owned or held by said Bank, to present claims in writing in the English language, on the enclosed form for the amount due and owing by said Bank. Claims must be verified by claimant or by his duly authorized agent, and said claim must be filed at the office of said Bank, at 111 Sutter Street, San Francisco, California, or its branch at 215 West 6th Street, Los Angeles, California.

Claimant should bear in mind that if his claim is based on a transaction with the SAN FRANCISCO OFFICE, his claim should be directed to The Yokohama Specie Bank, Ltd., in Liquidation, care of State Banking Department, 111 Sutter St., San Francisco, California. If his claim is based on a transaction with the LOS ANGELES OFFICE, his claim should be directed to The Yokohama Specie Bank, Ltd., care State Banking Department, 215 West 6th Street, Los Angeles, California.

To participate in the first distributions made your claim must be filed at the office of said Bank on or before October 1, 1945.
