The outstanding occurrence of the week, insofar as its influence upon the residents of the relocation centers in Arizona is concerned, was the opinion sent down ~~the~~ by the Arizona Supreme Court that the "Anti-Jap" law passed by the 16th legislature last March is ~~an~~ unconstitutional. The court gave as basis for its decision that the statute is "~~indeed finite and vague~~" "vague and uncertain". The decision affirms a Maricopa Superior Court ruling in a suit filed in June by ~~Sam~~ Tsumoto Ikeda, ~~new member~~ who was represented ~~to~~ by ~~Samuel Chiswick~~ ~~Justice~~ ~~Lockwood~~ a former chief justice of the Arizona Supreme court, A.C. Lockwood. ~~Transmucium~~ Pima County

A significant fact is that the opinion was written by ~~a~~ a superior court judge, ~~nothing in justice in the absence of~~ William G. Hall of Tucson, acting justice in the absence of Justice A.G. McAlister, and concurred in by justices Stanford and Ross. It might ~~possibly have been known~~ Lockwood ~~many appearance~~ be imagined that Lockwood's appearance before the court on which he sat for around 20 years ~~might~~ predispose the ~~other~~ two justices with whom he worked for most of that time---McAlister and Ross---favorably toward his side of any case. That the decision was unanimous with a resident of another section of the state sitting, and ~~with~~ with Stanford, a former governor, as the third man, speaks well for the merits of ~~the case~~ Tsumoto's case, ~~MMMM~~

Three residents of the center, ~~MMMM~~ who were involved in liquor charges growing out of their ~~possession~~ apprehension while in possession of 30 cases of sake, were brought before the U.S. Commissioner, F.A. Hickernell, in Phoenix, waived hearing and were released on \$500 bond each to await trial in federal court. They are at the project.

Eight new members were added to the leave clearance board to expedite the handling of cases for which dockets have been received from Washington. Decisions received from Washington on cases already heard and forwarded ~~in~~ number less than 100.

~~French community analyst~~ ~~arrived at the project~~ ~~when Friday night~~ James Crawford, relocation officer, was named executive secretary of the ~~new~~ leave clearance board to succeed Ralph Drennen, who is leaving the project.

Heating facilities for the schools have been installed and walls and floors have been covered with paper and roofing felt in order to hold the heat in the rooms. Many absences among teachers and students, ill with influenza, have been noted ~~the~~ during the week. The teacher shortage, particularly in the elementary grades, is still quite acute, ~~even but with~~ several new teachers, obtained through Civil Service, are expected to be added to the staff by the first of the year.

Captain Rusch, Camp Savage Intelligence School recruiting officer, interviewed interested applicants here during the week.

Community Enterprise activities continue to be the topic of much discussion among the ~~new~~ residents.

Many Christmas gifts for residents of the center have been received from "outside" sources and ~~a~~ committees have been appointed for their distribution. Little reaction to the "no turkey" edict has been noted and Poston seems likely to enjoy a truly merry--and uneventful--Christmas.

December 19 - 25, Incl, 1943

The traditional ~~spiritual~~ Christmas Holiday was observed throughout ~~the~~ Poston. Chicken ~~dinner~~ instead of turkey was served for the traditional holiday dinner. ~~the~~ Christmas Pageant and program sponsored by the Christian Church, and gifts for the residents, received from the outside sources were distributed to the children. ~~the~~ All went well until the Night of Christmas, when the fire marred the holiday. The second fire to destroy any of the personal effects of any of the evacuees residing in the Colorado River @ War Relocation Center at Poston, broke out in Block 202 completely destroying five warehouses stored with valuable evacuee properties, and a recreation hall. The estimate damage ~~done~~ is not revealed.

During the week oil shortages for the heater and stoves effected the community of Poston. Blocks not receiving oil for long period of time have caused unrest among residents with most blocks starting ration system of one gallon per day to avoid undue hardship.

Honorable Francisco de Amat y Torres Spanish consul at San Francisco arrived during the week. Several representatives were send by each units for inquiries made by the residents. Dr. French; Poston's community analyst spent considerable time introducing to certain of the residents and discussing many phases of Poston life.

Since the business transacted at the Block Managers' meetings has gradually become routine; questions were raised whether to have the meetings every other week. The meetings are to be held every week whether any business or not to keep them together in one group.

During the week the Leave Clearance Board reinforced by nine new members continued the hearing of about 300 dockets which had been sent from Washington. The weeks admissions show signs of slacking due to the holiday transportation regulation. There are many soldiers on furlough ~~from~~ here to spend Christmas and New Years Holiday with their family ~~here~~ in Poston.

The request of ~~the~~ petition to the Spanish Consul to open a diet kitchen. With the decrease in the population such kitchen should be opened to release the congestion of hospital facilities.

REPORT FOR WEEK DECEMBER 26, 1943 - JANUARY 1, 1944 INCL.

Opening the New Year, the War Relocation Authority has taken over the full ~~man~~ responsibility of the Administration of Poston which has been shared with the Indian Service.

Unit II

New years Day was celebrated throughout the camps with little taste of chicken and Japanese Dish highlighting the so called official Japanese Holliday, "Osho-gatsu". Due to the shortage of soup bowls for the patients in Unit I General Hospital, the Block Manager's Supervisor's Office called for cooperation from all units to loan bowls to the hospital for the patients New Years Breakfast. The newly ~~built~~ opened Rest Home at 201 received ten patients from Unit I General Hospital during this week

The Local Council has organized an Emergency Man-Power Board to cooperate with a local board in the Poston Community Council to ~~a~~ make adjustments for future labor problems. The Council acting on request from the Red Cross elected two members to the disaster-preparedness committee.

Upon completion of the school auditorium it was found that several safety matters had been overlooked. The projection booth was not constructed in accordance with National Fire Protection Association Standards. No exit signs or lights had been placed in the projection booth. ~~With no forwarding of the letter to the Fire Department and the Construction Department setting forth the above violations~~ A letter was forwarded to the Project Director and the Construction Department setting forth the above violations. Since that time the exit sign and lights have been installed, the projection booth is not to be used for nitro cellulose base film, the ~~control~~ switch in the booth has not been installed. as yet.

Investigation on the recent fire which broke out in block 202 warehouse where all the personal stored goods, found that only one party's property was found to be insured. Permits were released to the evacuee owners to salvage what property could be identified. The further investigation are being continued.

The Engineeting Department is making cattle guard for the main gates to keep out the wild livestock. The appeal has already been made to the residents for their cooperation. Considerable damage has been inflicted ~~nothing~~ to the vegetables and gardens throughout the units.

The Leave Clearance Board continued interviews during this week.

Unit I Hospital on Friday, December 31st.


Investigations on the recent fire in 202 are being continued.

Following is a brief narrative report for the previous week ending January 10, 1944:

The Christmas Gift Committee met on Friday, January 7th, to discuss matters related to the recent distribution of the Christmas presents and the distribution of the surplus gifts.

The functions and regulations of the 201 Rest Home were explained by Dr. Pressman and Miss Vickers to the Rest Home staff and to Council committee members and others directly concerned with its operations. The group was called together on Monday morning, January 3rd, by Dr. Pressman for this purpose.

Although the Clinic in Unit II will be closed after regular office hours, a plan has been formulated to get ambulance service from this unit. The program is to be discussed at the next Local Council meeting.

The building of new chicken brooder houses to replace those destroyed by the recent fire is well under way, and is expected to be completed before the next shipment of chicks arrive.

Subject: Brief Report

Following is a brief narrative report for the previous week ending January 17, 1944:

The ambulance service of Unit Two has been planned by Dr. Pressman's staff and presented to the Local Council's approval. The Local Council accepted the ambulance service plan with details to be worked out by Miss Crawford, the Health Supervisor of Unit Two. The plan is that the ambulance will be dispatched from Unit Two after Clinic hour with the ambulance office at either the Clinic or the newly opened rest home.

The subject of an entertainment program for the rest home patients has been discussed by the Block Managers and also by Local Councilmen. The system now organized is that various blocks, churches, clubs and other organizations will each be scheduled to entertain the patients weekly.

In order to provide additional comfort to the elementary grade pupils of the Unit Two School, the wall paper has been placed in all apartments of the 210 block by a volunteer group representing the PTA organization. Each block took the responsibility of placing the wall paper to one barrack. The linoleum for the school apartments are now being completed by the linoleum crew now working under the emergency program of the construction department.

The problem of keeping the live stock out of the project site has been discussed on various occasions. Since the arrival of wires into the Parker warehouse, the Engineering department coordinating with the Agriculture department has planned to construct a fence west of the project site. The plan is that each of the units of Poston will construct a certain portion of the fence. The work will begin this week by volunteer groups in three units. The plans for the construction of cattle guard for the main gate is also under way. After completion of the fence and the cattle guards, I believe that this pending problem will be alleviated.


January 17, 1944

The matter concerning the fuel oil and the kerosene distribution have been discussed on several occasions with the warehouse division by the Block Managers' Supervisor and also this office. We find that the present system of distribution of fuel oil is imperfect in that it causes impartial distribution and also causes circumstances where the block fuel tank runs empty. Although kerosene is reported to be difficult to procure, practically all blocks in Unit Two were faced in the last three days with not having any kerosene for heating purposes. If procurment is difficult, a more appropriate distribution should be developed in order to give all blocks some kerosene. Camp One has kerosene while we are out.

As a part of the Infantile Paralysis benefit drive, a talent show was given to the residents of Unit Two by the Three Unit talents. The YBA of Unit Two is sponsoring a benefit dance on the 29th of January in order to complete the benefit program.

In the early part of last week, the office of Internal Security under Mr. Harper's supervision moved their office to Unit One in order to be in closer contact with Project offices.

SUBJECT: Brief Report

Following is a brief narrative report for the previous week ending January 31, 1944:

The project fence construction is continuing with full cooperation and remarkable progress.

Acting upon the discussion by the Local Council and Block Managers, the visitors' food supply situation was referred to Mr. Snelson. A procedure to make a survey of all incoming visitors is now being worked out.

The Unit II Future Farmers of America's Hog Project which has heretofore been operated under the supervision of the Unit Agriculture Department was closed, and on Thursday, January 27th, was transferred to the Project Hog Farm.

Relative to the closing of the Unit II FFA Hog Farm, the delivery of this unit's garbage to the Project Hog Farm has been agreed upon with the Unit I Agriculture Department. It was also agreed that the present garbage crew of our unit will continue to be employed.

The nomination of candidates for Block Managers and Assistant Block Managers was under discussion during the week. The election will be held on February 1, 1944.

The Infantile Paralysis Benefit Drive was splendidly carried out thru the combined efforts of the Boy Scouts and Girl Scouts who sold Infantile Paralysis badges. The Benefit Dance under the sponsorship of the Unit II YBA climaxed the Drive.

The usage of private vehicles in Unit II is under control. All keys of all the private vehicles have been turned in to the Internal Security office.

Two new chicken-brooder buildings have been completed for the Unit II Poultry Project.

This week's admissions were 1 short-term; 9 visitors. Departures were as follows: 1 indefinite; 8 seasonals; and 3 transfers.

Mr. Rupkey of the Engineering Department reported that the heavy tractor that had been broken was ready to resume work on Friday. Mr. Barbour will have his surveying crew stake out the fence line in order that the volunteer crew of our unit can start work to complete the fence construction work, possibly starting work on February 22nd. A day or two of labor will assure the completion of the fence.

The Local Community Council of Unit Two has formulated a plan for memorial services so that they can arrange the organization of future memorial services. The service for the late Sergeant Kiyoshi J. Shiramizu was held Saturday afternoon at the Cottonwood Bowl. The gathering was a success through the cooperation of the three units and the project administration.

On Friday James D. Crawford and Edward Nosssoff of the relocation division introduced the advance group for the coming relocation team. The purpose and intent of this relocation team was explained to the block managers to acquaint them with the program.

In reference to the Selective Service program, there are many residents who have now received their 1-A classifications from their local boards. The committee is giving every available information that it has received from Mr. Crawford to the residents of the community. To date, no one in Unit Two has received official word for pre-induction examination before the Phoenix board.

Following is a brief narrative report for the previous week ending February 28, 1944:

The gifts of medicine, shoyu, miso and tea sent by the Japanese Red Cross to the Japanese nationals residing in Poston were distributed by the block managers to the residents of their respective blocks during the past week.

The Unit administrators, block managers' supervisors of the three units and the Public Relations Board of the Poston community Council met to formulate a general program for the relocation team. In Unit Two the program was worked out by the block managers and the council group; the first meeting is scheduled for Monday evening February 28, and the second meeting on March 4.

Selective Service seems to be the highlight of discussion within the camp at present. Although there are very few who received preinduction examination notice from the Phoenix Selective service headquarters, there are many residents who are getting their 1-A classifications from their local boards. The committee is continuing to give all available information to the persons concerned.

With the recent employment freezing order by the director of employment, some of the divisions are not able to replace the workers terminated because of illness and injury. During the past week the rubbish crew in camp two was in a position of hardship and discontentment which developed into several discussions with the director of employment in regard to making an exception to the freezing order. The employment problem was settled with Mr. Cassily authorizing the exception to the freezing order.

The scheduled lecture and showing of colored films by the relocation team to the residents of camp II had been successfully carried out on the night of February 28 at block 210 and on March 4 at block 222. On both occasions the mess hall was filled with a large crowd. The lecture of Mr. Fistere of Cleveland and Mr. Collum of New York was interpreted by Mr. Manabu Fukuda for the benefit of the issei residents.

On February 29, Mr. Fred Nitta, the vice-chairman of the local council departed Poston to take a position in Washington, D.C. His vacancy at present is not filled.

On Thursday, March 2, the block residents of block 221 and the Block Managers' group lost a good friend who faithfully served as block manager of 221 for a period of 14 months. Mr. Takeo Miyake, the block manager, who departed to Tule Lake Center had been replaced by Mr. Masuo Tsutsui.

As further improvement to the land scaping of camp II, the land scaping crew under the supervision of the Agriculture Department is continuing to plant cottonwood trees bordering the open fire breaks about the camp sites.

Following is a brief narrative report for the previous week ending March 13, 1944:

Through the combined efforts of the three units the construction of the fence along the west side of the project site was completed. The program to chase out the livestock is scheduled to be carried through on Wednesday, March 15 by the coordinated procedures of the three units.

Mr. John Kuwano of Block 219 was selected to fill the vacancy left by Mr. Fred Nitta as councilman of the block. The position of Vice Chairman of the block council left vacant since the departure of Mr. Nitta is not filled at present.

The Local Council discussed having the volunteer fire crews of each block go through a drill in order to be prepared to give assistance in time of emergency. This was brought up in view of the possible decrease in the permanent fire crew through relocation.

The Seventh Day Adventist religious group sponsored a health movie and program at the Cottonwood Bowl on the evening of March 11. The hospital staff was also present to give lectures in reference to health.

The Red Cross Membership War Fund Drive was started in Unit during the week and it will be carried on throughout this week. The block managers are helping in this drive in order to meet the quota set for our unit.

As a recreational activity for the Isseis, naniwabushi programs have been started. The first was held last Thursday in Quad Two. In the next four weeks each of the remaining quads are scheduled to have the same program with Mr. Harada of Camp Three as the performer.

Following is a brief narrative report for the previous week ending March 20, 1944:

At the meeting of the Local Community Council on Monday, March 13, an election was held to fill many vacancies in the office of the local council because of relocation of the members. Mr. K. Okawauchi of 229 was elected vice-chairman of the local council; Mr. R. Tazumi was elected to represent the Unit II local council in the Poston Community Council, filling the vacancy left by Mr. Fred Nitta. The committee chairmen of the local council committees were appointed. Mr. John Kuwano of 219 was appointed Housing chairman, Mr. T. Kimura of 207 was appointed Social Welfare committee chairman and Mr. J. Mukai of 229 was appointed Public Health Committee chairman.

On Thursday, March 16 the Unit II residents cooperated with the residents of Camp I and III in carrying out the coordinated horse and cattle drive. The main gate leading to our unit will be controlled by the Internal Security Division which is working out a schedule to have a man on duty during 24 hours a day.

Saturday, March 18 a Japanese movie was shown to the residents of Camp II. Such a movie is well appreciated by the Issei residents. It is hoped that the WRA will take further action in releasing some of the Japanese films now being frozen by the government in order that it can be shown to the residents of the centers.

Since the opening of the Camp II Rest Home, many organizations have contributed their time and talent to entertain the patients. On Sunday, March 19 they were privileged to have a movie through the efforts of a resident of Unit One.

Following is a brief narrative report for the previous week ending March 27, 1944:

At the Local Council meeting on March 20, 1944 it was discussed and decided to have three volunteers from each block to form a quad volunteer fire crew to assist the firemen in times of emergency. It is hoped that the program will be carried out successfully with the help of the Fire Chief, Mr. Petersen of Camp Two. One major reason for developing this program which was under discussion with Mr. Petersen on various occasions in the past is that it is a known fact that through relocation, a decrease in the present personnel of the Fire Department is imminent.

On March 25 and 26 the Flower Arrangement was on display at the 210 Mess Hall by the students of the Flower Arrangement class under the sponsorship of the Adult Education Department of Unit Two. This event was very successful and drew large crowds on both days.

During the past week and the coming week, it is anticipated that many problems and complaints will be brought to discussion in reference to the employment adjustments. Concerning the division in the project director's line of work which includes the block manager's staff, I now hear of numerous complaints and resentments in the difficulty of conforming to the adjustments. Although some divisions may be in the capacity to easily adhere to the readjustments some divisions will face a decided hardship. I personally believe that if it is the WRA's policy to make such adjustments because of financial status, the numerous appointed personnel can be dispensed with which will decrease the cost of operation and to their positions many evacuees can be hired at equal costs and be of far more benefit to the



residents of the camp. Undoubtedly some of the instructions are from Washington, but I believe that the Project should have authority in making recommendations to Washington to adapt the policies to our needs and purposes. I feel truly that Washington would not know what obstacles and difficulties that would be faced with the detailed operations. Why not work out some of the project policies through your authorizations rather than to follow the strict interpretations of Washington.


Following is a brief narrative report for the previous week ending April 24, 1944:

Many comments have been heard since the "open house" from parents regarding the necessity for increased activities by the PTA in the fostering of a better educational program.

With the recent allocation of funds by the Local Council to provide for a special movie for the community, it is planned to start the first showing on May 15 at the Cottonwood Bowl. The allocation set forth a special showing once a month beside the regular movie shown by the Community Enterprise.



The individuals had come on a short term visit to make a study of the Poston mess hall operations to find ways to improve their mess hall activities at Gila. I believe that this is a fine opportunity in that the evacuees can get the true picture of another center. I personally feel that it would be a great advantage if a representative from our center could visit other centers and bring back information that would improve the mess hall operations.

Coinciding with the second anniversary of the founding of the Poston Cooperative Enterprise, the board of trustees gave an appreciation dinner to the local councilmen and the block managers as an expression of their gratitude for the volunteer help and service given towards the program of the Cooperative Enterprise.

On Monday, May 22, Mr. Walter Anderson, a representative from the Pacific area headquarters of the American Red Cross started the water safety and first aid instructors course for interested residents. He is here through the efforts of the American Red Cross in order to train the life guards and the first aid instructors which will be of great benefit to the residents.

On May 22 the Administrator's office and the central block manager's office representatives and the Council, the Education committee chairman and the PTA were invited to a meeting called by the Poston Two High School student body to discuss the matter of changing the high school name. After deliberation and discussion a committee was selected to organize plans and procedures in the selection of a new name for the Poston Two High School in order to meet the wishes and request of the examiners of the Arizona State School Board.

On Wednesday, May 24 the unit departmental heads of the various divisions were called together by the Local Council in order to select two members as Labor Commissioners from Camp Two to fulfill the responsibilities of ironing out the labor difficulties which may occur. The representatives selected were Mr. Jitsuzo Fukuhara of the Agriculture Department and Mr. Manabu Fukuda of the Council Labor committee.

As part of the program of the Buddhist festivities during the past week, a Go and Shogi tournament was held in Camp Two. The winners of the tournament were presented with awards at the Shibai held on the night of May 28 at the Cottonwood Bowl.

After several months of discord in the functioning of the Camp Two Rest Home which is operating under the Poston General Hospital, a settlement was finally made. During the past week

in order to alleviate the labor friction and difficulty that had been existing, a coordinator was recommended to be assigned to carry out the orderly activity at the rest home. It is now known that Mr. Prather, the business manager of the Poston Hospital had requested this of the Project Director's office so that the new assignment could be fulfilled.

During the past week a visitor from the Manzanar Relocation Center gave a performance of ballad dramas for the interested Isseis of Camp Two. The program was of a classical type and therefore the audience was composed mainly of the older Isseis.

In view of the coming commencement exercises to be held this week for the Poston Two high school Seniors, the block managers have decided to have each block contribute a bouquet of artificial flowers to decorate the Cottonwood Bowl stage.

With the increase of seasonal and indefinite leaves, it is now coming to a point where mess halls in several blocks are facing a shortage of personnel. Although we do not find any volunteer workers helping to run the mess halls, we do find that many of the kitchens are drafting block residents to work in the mess halls. As a result of this, other divisions, aside from the Subsistence Department, are becoming understaffed. It is hoped that the new Manpower Commission will have plans to alleviate this aggravating problem.

Complaints in reference to the medical attention being offered at the Poston General hospital have been brought up and discussed at the block manager's meetings and also at the Council meetings. We realize that there is a shortage of doctors, but regardless of that fact, the residents cannot seem to understand why so many of the doctors are on leave. Because of the doctor shortage, many patients are neglected and do not receive the necessary medical attention. The Local Council of Camp Two stressed this medical problem as one of the important issues in our camp activities.

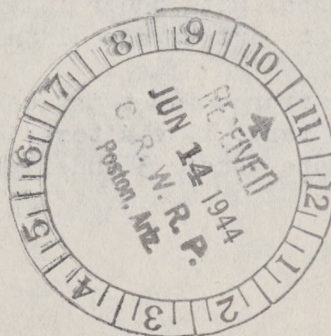

On June 15 the Engineering staff of Camp One came to solve the present difficulty in the drainage system of the waste water running through the Camp Two swimming pool. The swimming pool has been closed for the past week because of inadequate drainage. After consideration by the Engineers, it was decided to place about 140 feet of concrete culverts in order to join the present stagnant pool of water to the main drain canal leading to the Colorado River. It is anticipated that the actual work of placing the culverts will start Wednesday. The drag line and the tractor equipment have been working on this spot since Friday of last week.

On the evening of June 15 through the request of the Unit One hospital committee a few singers and dancers from Camp One went to entertain the T.B. patients in the hospital ward no. three and four.

On Friday June 16, Dr. Clifton Taft, Southern California director of the American Civil Liberties Union was here in Camp Two to visit the residents.

Through the efforts of the Local Council committee, a manager to supervise the general work at the Camp Two Rest Home was selected. Mr. K. Okawauchi who is the Vice Chairman of the Local Council was recommended to fulfill the position.

With the use of a portable water pump the Camp Two swimming pool is being drained in order to take out the stagnant water. The work was started on Saturday afternoon and will probably be completed tomorrow. This is the first time the pool has been drained since its opening.

The Camp Two Clinic was the recipient of many magazines and periodicals donated by the residents through the efforts of the Councilmen and the block managers. Those who must wait in the reception room may now have something to read to occupy their time of waiting.

The visit was by the invitation of the Community Activity Department in order to have the understanding and full support by the councilmen and the block managers in carrying forward the future program of the USO.

Saturday evening 30 persons departed from Camp Two on trial indefinite to Seabrook Farms in New Jersey.



Three former residents of Camp Two were reported wounded in action. The local Council is making plans to hold the memorial services to the two soldiers that passed away. Twenty-three Camp Two residents left on the evening of Friday, August 4th, to report for active duty call at Fort Douglas, Utah.

With the depletion of manpower in Camp Two, the Steward's Department and the Fire Department is now in a critical situation. The council committee is taking up the matter in order to build up its personnel.

The population of Camp Two according to the housing statistics on August 5th is 2368 persons.

Mr. Kenneth Mayeda who had been the coordinator for the Camp Two Community Activities during the past 18 months will be leaving Poston on trial indefinite to New Jersey on August 8th. Mr. Tom Yagi will carry on his position until he is called for active duty to the U. S. Army.


As a result of a Local Council election during the past week, it has been revealed that 11 councilmen had been re-elected and 4 are newly elected council representatives.



Ogawa of 213 was appointed to succeed Mr. Fukuda's former position. The councilmen of Unit Two decided to change their weekly meeting date to Monday afternoons during the winter period.

In order to bring about an efficient relationship between the Local Council and the Block Managers, one block manager was appointed to the membership of each of the Local Council committees to work co-operatively with the council problems.

On Friday October 27 the joint meeting of the Local Council and the Block Managers was held at the council conference room. The agenda for the meeting was in reference to the proposed Hospital Trust Fund for this year in order to give Christmas awards to the doctors and the other hospital workers. At the meeting it was decided that Camp Two agrees to accept the quota of \$450. The money will be raised through the 15 block managers with each block bearing the burden with the quota apportioned to the population figures of October 27.

The Japanese film was shown in Camp Two on Thursday night, October 26, with great enjoyment to the Issei residents of Camp Two.

November 4, 1944:

On November 1 several residents of Camp One who privately owned moving pictures and projector were present at Camp Two Rest Home to provide movie entertainment to the patients. The transportation was arranged through the administration office. This movie entertainment for the patients is the second affair since the opening of the Rest Home on December 31, 1943.

On the evening of November 2 the residents of Camp Two gave a send-off to Mr. James D. Crawford, the former unit administrator of Camp Two, at the area in front of the unit Police Department. Expression of appreciation were made by the block managers group and the council in behalf of the residents. At the same program a gift as a token of appreciation from the residents was presented to Mr. Crawford. Mrs. James D. Crawford, who had served in the capacity as a leadership of the Girl Scouts' activities in Camp Two, gave a farewell message to the residents and the Girl Scouts.


During the week the USO of Camp Two had been preparing to give gifts to the departing soldiers called to active duty. As to my knowledge on this occasion they are giving photographic prints of important locations Camp Two as a remembrance of Poston Camp. The USO is still continuing to take pictures of soldiers and the boys being called to active duty with the cooperation of the Reports Office in Camp I.

Effective November 1 under the new transportation procedure a slight bottleneck had been developed, but reported that it had been settled now. Of course, in the process of the transportation requests, some divisions are still facing the difficulty because of non-authorization to make the requests by the department heads in Camp Two, but in order to keep the activities in progress, the unit administration office at the present is making the transportation requests. Although the motor pool has not been ~~made~~ in Camp Two, I find that all of the vehicles that are necessary to be placed in the motor pool are being parked after working hours. In Camp Two the guards are on duty during the nights, half a day on Saturday, and all day on Sunday to insure the protection of the property parked at the motor pool. The transportation condition in Camp Two is very good in that the cooperation of the motor pool drivers is obtained in the program toward the conservation of motor equipments. All of the vehicles under the motor

The activities for Camp Two during the past week had been very limited. The agenda at the meeting of both the block managers and the councilmen had been more or less a routine discussion. No immediate and important problem was developed.


On November 8, 18 young men from Camp Two had left the Project to join the Armed Forces after receiving their calls to report to active duty to Fort Douglas, Utah. It is also known that on November 20 one person from Camp Two will leave for active duty. The friends of the departing soldiers went to Camp One for the send-off program at the Block 4 stage to give the boys a final farewell.

On the week end of November 11, the Camp One Shibai group came to Camp Two to entertain the residents with their performances.

With the report of the fact that the late Technical Sergeant Abraham Ohama whose parents reside in Block 222 had been killed in action in France, the Council and the Block Managers are considering the factors towards the formulation of the program for his memorial service. It is a known fact that the over-all council had adopted a resolution to have memorial services sponsored by the block of the deceased, but in view of the fact that such a procedure would be uneconomical to the residents as a whole and also since we are giving elaborate send-off programs to the departing soldiers, the residents as a whole feel that it would be our obligation to give a community service for the soldiers who sacrifice their lives on the battlefield. Through the block survey the general consensus is that the residents of Camp Two prefer memorial services sponsored by the community. The general program arrangement will be carried out by the council body with the cooperation of the Block Managers. The arrangement and the clean-up work will be carried out by the residents of the block which has the family of the deceased soldier.

Bowl stage.


On Friday of the same week, Mr. Harada of Camp Three gave a


The block managers well appreciate the cooperation from the Engineering Department in reference to their requests for gravel hauled by the dump trucks to be used within the blocks. At this occasion three loads were delivered to each of the blocks in order to alleviate the muddy condition whenever it rains, but because of the fact that no previous delivery had been made since the opening of camp, the block managers now request for additional supply of gravel. The matter is now referred to the Engineering Department.

The follow-up on the resolution adopted by the Manpower Commission is being made. The local representative is now making a survey of the manpower necessity in all divisions of Camp Two.

The temperature reading which previously had been recorded by Mr. James D. Crawford is now being recorded by Mr. Frum, the local fire chief. The Unit Administration will continue to cooperate with Mr. Frum in keeping the records and submitting the copies to the necessary personnel on the Project.

The request for the adjusting and the repairing of private sewing machines had been submitted to Dr. Powell, Chief of Community Activities and Mr. Andresen of the Procurement Office during the month of August. To this date the Procurement Office was unable to contact the Singer Sewing Machine Agency. Last Week the Procurement Office was fortunate in making contact with the agency in Phoenix to have the repairman on the project. Through the courtesy of the Singer Sewing machine repairman, the residents of Camp Two are having their necessary adjustment and repairing accomplished.

During the past week the Issei activities in Camp Two dominated. On Monday November 27 the dances performed by Fujima Kamsuma and her students attracted a large audience at the Cottonwood Bowl.


Camp Two Shibai gave their performance on November 30. On the following day, the Community Activities of Camp Two sponsored a naniwabushi program at Block 209 Mess Hall with Mr. Harada of Camp Three as the performer.

Under the sponsorship of the local Community Council and the Block Managers, a memorial service was held on Tuesday, November 28, at 2:00 P.M. at the Cottonwood Bowl. The service was held in tribute to the three soldiers, T/Sgt. Ohama, Pfc. Hayashi, and Pfc. Izumizaki, who had been recently killed in action in France.

On the evening of the 28th of November, an unfortunate fire had occurred at Block 215 Barrack 6 about 6:30 P.M. The damage was the complete loss of the barrack #6 and also the personal losses to the three families residing within the barrack. The local Community Council, the block managers, and the Red Cross representatives had held a meeting on the afternoon of November 29 to discuss the possibilities to assist the three families who had lost their clothing and personal properties as a result of the fire. At the meeting it was decided that one day contribution drive would be held in Camp Two on November 30. The committee appointed at the meeting was to meet on Thursday evening November 30 to determine the allocation to the three families from the contribution fund. The administration, the block managers supervisor's office and the local Council together with the Red Cross express appreciation to the residents for their cooperation during the period of the fire.

The landscape crew of Camp Two had finally completed their work of cleaning up the block site of Block 210, which was formerly occupied by the Poston Two School. Appreciation is expressed to Mr. Masuda and his crew.


On December 8 the Camp Three shigin group made a visit to the Camp Two Rest Home to entertain the patients with their program of approximately one hour. The Rest Home staff and the administration personnel of Camp Two truly appreciate the cooperation of the various organizations within the units I, II, and III that frequently offer their time in giving entertainment to the patients.

It has been brought to the attention that again the inferior quality of oil is being distributed within this project. As a result many difficulties are being caused in the operation of the heater stoves and boilers. During the winter months it will be a known fact that all heaters will be in operation. Unless we are able to receive a constant and steady delivery of superior quality oil, it would be difficult to have the stoves adjusted for satisfactory use. The administration of Unit II strongly requests the cooperation of the Operations Division and the Procurement Section in giving their utmost efforts for better quality of oil supply.

The administration office is informed that for the month of December the Community Activities section is allotted a total of 20 gallons of gasoline in carrying out its activities. Needless to be mentioned, this amount of gasoline is inadequate to take care of the necessary activities for the residents of Camp Two. Some have the opinion that the Community Activities is non-essential towards the operation of the project, but I fully realize and stress the importance of the Community Activities' programs for the efficient and smooth operation of this camp. From the past experience of two and a half years in the operation of this project, it can be realized that the Community Activities' programs had played a major part in the upkeep of the morale of the

residents. Unless an adequate program can be maintained, it would naturally result to discontentment and discord among the residents in complying to the many administration policies. Consequently it would cause an extreme difficulty for the smooth operation of the project administration section. I firmly request that you further consider to evaluate the importance of the Community Activities in the operation of the project.

At the same send-off program in Camp I, Mrs. Setsu Sakamoto was presented with a Silver Star, which was awarded posthumously to T/Sgt. Atsushi Sakamoto who had been killed in action in July on the Italian battlefield.

As for the Issei entertainment for the week, on Friday, December 15 Mr. Harada from Camp III performed his presentation of a Naniwabushi program at Block 213. It appears that this program is still well appreciated entertainment for the Issei.


The Christian Church personnel at Camp Two are actively engaged in the formulation of the program in order to distribute the Christmas gifts now being sent in by the various charity and church groups from the outside for the children residing in Poston. The block managers staff had expressed their cooperation in assisting in the actual handling and distribution. It is contemplated that the same procedure as to the sending of the Santa Claus to the blocks as had been done in the past year will be the high light of the Christmas program for the children.

The oil situation in Unit II is still critical although the residents are informed to conserve as much as possible to meet the oil shortage for the winter. It is one of the problems that will be serious until mid-January. The oil delivery to this project seemed to be of very poor quality, as well as the inconsistency of the quality. Because of the fact that the variation of the quality, many heater difficulties have been developed which in turn is the cause for fire hazard.

The Camp II Agriculture Department is currently harvesting one of its unusual crops. The administration of Camp II have temporarily loaned the usage of the open barracks in Block 201 in order to place the peanuts for drying purpose. It is now known that the residents of Poston will have Poston produced peanuts very shortly.



On Christmas Eve, December 24, all blocks in Camp Two held a gathering in their respective mess hall for the children of the block. At this occasion the Santa Claus was present to give the gifts that had been contributed by the various organizations and churches from all parts of the country.


The landscape section in Camp Two that had been continuing its project at the Camp Two High School site is now considering as to the future progress on the general landscape work on the school ground. A slight hesitancy is now realized in view of the future W.R.A. policy as to the project operation. It will be necessary to have the determination of the engineer section whether it would be feasible and justifiable to develop the large scale landscape work by transplanting large trees. It would be unnecessary for the crew to progress if the future operations of this project is such that no one would be there to care for the trees and the shrubbery that may be planted. This matter is now referred to the engineering section for their consideration.

The fuel oil situation on this project is still unsolved although the information had been received that the contractor had agreed to deliver sufficient amount of oil to meet our usage. In reality the oil is not being delivered as expected. The administrators of the three units met with Mr. Lipian on December 30 forenoon to discuss the bottlenecks that may be in existence to delay the fuel oil delivery. As a result of the meeting, it is known that an agreement had been made by the project and the oil company to have the company truck to haul in the oil from Parker railway to the project. If this program is successfully carried out as agreed; I believe that the situation will be alleviated to insure an ample supply.

As a request of Camp Two residents, the regular weekly movie had been shown at the swimming pool stage for the last several months. It had been misunderstood by some that the Camp Two Community Activities was reluctant to use the Cottonwood Bowl stage for movie activity after it was constructed. Currently the Community

Activities Section is appealing to the residents to cast individual votes in order to determine the true wishes of the residents. The north portion residents desire to have the movies shown at the Cottonwood Bowl stage since the location is ideal as well as the closeness to the site. The south portion residents demand the showing at the swimming pool area since the place is centrally located and close to their own blocks. It is hoped that through these individual ballots, the true desire of the residents can be ascertained.



Following is the narrative report for the previous week ending January 13th, 1945.

On January 10 and 11, the Shibai performers from Camp III came to the Cottonwood Bowl to entertain the residents of Camp II. This performance is the Shibai presented at Camp III for their New Year activity.

The Camp One Shibai is scheduled to be in Camp II on 15th and 16th. The shibai performers of Camp Two will probably make their first presentation for this year during the last week of this month.

The messhall workers committee and the Local Council Food Committee met on evening of January 7 to discuss matters relative to the mess operations. It is known to me that the rice situation had been clearly reported in order to relieve misunderstanding. The factors contributing to the unannounced messhall operation policy was also related as information at the occasion.


On Saturday afternoon, January 13th, the combined meeting of Block Managers, Councilman, Messhall representative (2 from each messhall), Local Council Food Committee; Manpower Commissioner; and Employment Office Manager, was called. Information in reference to the future policy of messhall operation was reported by the Local Council Chairman, Mr. S. Sakamoto; Manpower Commission representative, Mr. S. Ogawa; Poston Community Council Food Committee member, Mr. J. Kubota; and myself. The firm opinion of all at the meeting was to oppose labor quota reduction and the messhall closure since it would cause undue hardship to the block residents who will be subjected to the adjustment. It is known that a consolidation of one block group to more than one block would make the administrative work of the Block Manager an extremely difficult task since each block is now considered as one unit in the administrative work. In a month or possibly 2 months, many may depart Poston for

relocation; then it would make it imperative, under this announced policy, to make adjustment continually. The residents affected by the adjustment would be unsettled and greatly disturbed by the numerous adjustments. Some had expressed opinion to postpone this policy until our populace is more on the stable basis. Although no definite messhall closure program had been announced for Camp Two at the present, the participant at the meeting unequivocally opposed to the policy outlined from Washington.

During the week end of January 13 and 14, the Adult Education section of Camp Two sponsored the arts and craft exhibit. The exhibit was held in Block 210 displaying the bird-carving, flower arrangement, and the knitted garments. The affair was very successful with unexpected large crowd of visitors.







The adjustment within the building to transfer the Chronicle Section and the Supply Section of Camp Two is now under consideration.

Relative to the order issued to close the mess hall of 208, much dissension has arisen from the blocks of 207 and 208 because of their misunderstanding as to the Steward Department's policy in consideration towards the formulation of the consolidated mess hall. In view of the fact that Block 207 is a special personnel kitchen, the residents of 207 feel that the number of workers to be provided in the consolidated mess hall should be based upon the actual number of servings, which includes the block population and the additional personnel servings. The 208 residents have the contrary opinion whereby the distribution of workers within the two blocks should be based upon the actual number of population and disregard the additional servings. The problem is still pending with a special emphasis by the Steward Department to clarify its basic policy to be followed in consolidating the mess hall.






Camp III Shibai was presented at Camp III on the evening of April 12, 1945.

The P.T.A. and the local Community Council of Unit II gave a banquet in honor of the teachers of Poston II School on the evening of June 4 at Block 214 mess hall.





Indication had been made as to the closing date for Block 229 messhall; however, the official announcement by the Steward Department has not been made as yet.



The following is a narrative report for the previous week ending July 7, 1945:

Special Local Council meeting was called on Tuesday, July 3. The councilmen considered the matter in regard to the public opinion as to the construction of a temporary stage for Camp II to replace the lost Cottonwood Bowl stage. At the same meeting, the Council body moved to expend the cost for the showing of Japanese film at Camp II on July 5. Mr. George Mukai, the chairman of the Local Council, tendered his resignation at the closing of the meeting in view of his plans for relocation within the immediate future.



The following is a narrative report for the previous week ending July 14, 1945:


The announcement concerning the closure of the WRA centers was conveyed to the block managers at a meeting called on the morning of July 14. At the same meeting, Mr. John Kubota, Food Committee member of the Poston Community Council, gave a detailed information as to the discussions held at the special Food Committee meeting held the day before. The situation concerning the acute shortage of transportation facilities which caused for the non-delivery of some essential food items was presented to the understanding of the block managers.
