Dear Ruth:

I had a not too successful conference with Mrs. Chauncey Clarke today. She will give us \$50.00 to help with the Church etc program. She said that she is not in a position at the present time to give more, as she budgets herself very closely on such matters. I hope to make a similar contact with Mr. Russell who has already given \$50, but may give more. I shall see Mr. Silberberg next week, also Mr. James R. Page, and perhaps get a like amount from them. This could mean, if I am lucky, \$200. We have about \$617 to our account at present. Could \$100 of this be taken to make the \$300 that is needed?

As soon as we get the letter-head and the brochures, and I hope to receive them tomorrow or Monday, we will start the membership drive, which may rapidly add to our fund. What do you think of this plan? It seems definite that we can't get the \$300 at one whack, so this seems to be the best solution if it will work. It is so important that this work of Gillett's be gotten underway immediately with the maximum amount of help that we can give, that you should immediately get in touch with him and tell him to go ahead with securing this additional assistance.

Mrs. Clarke wants about 6 more copies of J. Edgar Hoover's statement, and the facts showing that there was no sabotage in Hawaii, Galen Fishers Balance Sheet, and the Voice That Must Be Heard. Would you have these sent to her right away to her office in Santa Fe Springs. The address is just Mrs. Chauncey D. Clarke Telegraph Road, Santa Fe Springs, Calif. She can do more good with material like this than you can imagin.

Dear Katherine:

You shame me in more ways than one! First of all, you've written twice since I left Los Angeles with shaky knees, and each time in beautiful typing which I cannot possibly hope to emulate. Ah Me!

To come back to the first matter-- do forgive my not having written before, but I have been just too dead on my feet (or otherwise at times) to do more than drag over to S.F. for a meeting with the Junior League and then on last Saturday, a three hour session with Dillon Myer. I should at least have written my very sincere thank you for your fine care while you were feeling so badly yourself. That was certainly a bug to steer clear of in the future. I am only now beginning to feel like myself, at all, and had my first really solid food today noon, when I got lunch (out in the patio) for Mrs. Myer and Mrs. Cozzens.--I'll hope for the best.

As I wired you this morning, I am considering a grip south again to catch up on Pricilla, Mrs. Thayer, Mr. Crotty, et al, and to do any other things I might be able to help you with. Harry is going to Portland next week, and I'd like, if possible to combine three or four days of work-- or rather follow them, for that matter with a couple of days spent with friends out in Hollywood (Russell what's his name the artist's daughter). The best time for that would be to go down on Thurs. or Friday of this week, and work Friday, Saturday and Monday, then stay over to rest in Hollywood Tuesday and wed, then home.

I haven't nerve enough to bother you again, lest I snatch your electric pad, insist on meals in bed etc, so I suggest that you (solely for your own protection) try to reserve me a hotel room.---Harry had a fuss with the Figeroa on accounta they wont take colored guests, so that's out. I just still feel guilty about all of the trouble I made you.

Too bad that you had to scrape so hard to get that money for the \$300.---I see no reason why you shouldnt use the money in excess of the \$500 sent to this office in any way you wish. It may be that your ex. committee will wish to have some procedure or priority agreed upon. It is entirely up to you people.

---Pardon this over the page business s- we're already having to order more of the new letterhead, to have in sending out the extra Sproul pamphlets etc., and I don't want to run short.

--One of the surest indications that I was decidedly 'punchy' when I left Los Angeles was the blithe way I went off without making any arrangements with you about doctor's bill etc. That middle of the night call was most certainly mine, and I suggest that you give your good friend the M.D. my address, so that he can bill me directly.

Before I go south, I expect to talk with our Treasurer and get his precise idea as how best to keep that L.A. account straight, with the less book-keeping here and there. It won't be hard, but it will be better when the method is standardized, don't you think so.?

Last night Harry and I saw Joe Hodges, the young fellow who works under your Joe. He spoke most admiringly of the Big Boss, not only professionally, but also as a most proficient mixer of elegant Old fashioned. He knows.

I presume that you will receive the copies of the mimeographed material you wanted-- the stuff we went over with Gillette and Farnam. I sent samples to both of those men, so they will be familiar with the stuff if and when we go over it with them.

I am most eager to meet with Mrs. Thayer and Pricill, to see if they want to take over a lot of the responsibility of getting names in the Welfare and Civic categories for the Note Book files. They are itching for something specific to do, and as we are so terribly rushed with a million other details, I can think of nothing better for them to busy themselves with. If I only had the same kind of workers up here, who had relatively little other business to claim their enthusiastic attention, the Books would be filled in short order.

Incidentally, Mr. Myer feels that it will be of great value for me to take one of those books, when complete, to show to the General, with the idea of giving him some understanding of the scope of the support he can expect if and when.

I continue to feel contrite over the haphazard way I seem to be getting back on the job after that 'debacle' brought on by the enteritis bug, but I'm really feeling quite myself today, and look forward to a gradual, and I hope, speedy return to the form which at least occasionally can approach a job-- even a letter-- with sufficient concentration to keep it 'all of a piece'.

Let me know what you think about the southern trip-- if I don't make it now, I'm afraid that I'll get held up until after your return from Colorado, as I rather expect to go to Seattle in a couple of weeks.



Dear Ruth:

I believe Mr. Rundquist is urging that persons of influence on the coast write letters to Gen. Bonesteel saying they will support the Army in any policy it announces as to return. This is just what we did some months ago, though how many actually wrote, we have no means of knowing. But in the present campaign, we have not included this definite type of letter. Chapman tells me that yesterday Rundquist intimated that the General was timid and was waiting for the assurance of leading citizens before going ahead. This may be true, but I do not recall that either Myer or Cozzens so stated, or urged us to do in this campaign. Since Rundquist is going to be seeing all the Church and other leaders in the North as well as in Calif. you will wish to check and then regularize his approach. He seems to think we are not taking the most effective tack along this line, though he did not say it to me directly the other day. I agree that a man like Doubleday may have impressed him as not being aggressive or definite enough, but it may do harm if Rundquist takes it on himself to call the tune or start a parallel movement. I know he wants to cooperate closely, but without wishing it, he may start a cross draft.



I am addressing the letter thus in case one of you is out of town - as has happened when I wrote for rush information before.

I have been asked by the Y. W. C. A. secretary in Fresno to speak before a group of two hundred or so, called to discuss the possibilities of an inter-racial committee for Fresno. My topic is to be the Japanese group - others will speak on the Negro and Mexican. The time is October 31st. I am to cover a bit of the past, which is being done now, and what this group can do in the future. I can manage the first two points (I read extensively and benefited you people for help a year or so ago for a panel discussion on the subject, as you may remember), but I'd like your suggestions as to what to bring out on the last point - which should be the attitudes and actions of the group in the future. I have the "Memo Re Support of War Department of Evacuee Return" which Mr. Fisher gave out to a Congregational Church group recently - is it your suggestion that I use any of that. Also would it be indiscreet to suggest that the return

whenever the military lifts the ban will be controlled
and guided as has been done in relocation throughout
the rest of the United States. The fact that Dillon Meyer
passed through Fresno and that a group of us met him
seems to have been kept a close secret and I therefore
hesitate to quote anything he said. I shall of course

Your note here this morning and I am glad that you will get out those two letters. Time is very short and so I hope they are already on the way. Kindly let us know air mail of the answers. If none comes from Houser do you think we could quote from a recent speech, part of which I enclose? It seems to give his stand definitely. He finally answered a personal letter of mine I sent him weeks ago but just gave hints of dire results if the Japanese-Americans were to return to Los Angeles.

Katherine Kaplan and I had a good visit last Thursday. She told me she expected to have from you immediately the list of communities south of Bakersfield where you wish work to begin. She told me the communities chosen were to be those which had at least 100 people of Japanese ancestry prior to evacuation. We tried to find some day before election when Pasadena executive committee could meet but several are so busy, it did not seem possible. Therefore I am setting November 8th for the meeting and Mrs. Kaplan will come up. That seems the best way, as we can then go over the communities you have listed and decide upon those where we can help. At present I have no idea how many will be anywhere in our general neighborhood or where we could offer leads. I am sure our members will wish to help on this fine project. I believe we would need considerable of the mimeographed material bearing on this which Mrs. Kaplan showed me.

I note in recent Pacific Citizen that Mr. Gannon is threatening to hold another hearing in the South, probably Pasadena or Los Angeles. His other one did our cause so much good, probably we should urge him to do so.

It seems to me the statement of the District Attorneys in the Korematsu case (from California, Oregon, Washington) is one of the best we have had, that "the restrictions placed upon this group of our citizens must be removed as soon as military authority determines and the national security permits". They seem to agree with us.


