Dear Mr. Keith:

We have today sent to the District Attorneys of every county which contains any considerable number of Japanese a copy of the General Highway Map for his particular county, together with a request that he secure from his Assessor and other sources the location of all lands within the county owned, occupied or controlled by persons of the Japanese race, and with the further request that all such parcels be marked on the map in red and the same returned to this office. For your information, I am enclosing a copy of this request herewith.

We regard the completion of these maps as a matter of first importance. We would greatly appreciate any assistance that you can give to any of the Assessors in getting the information necessary for the maps or in making the urgency of the matter clear to them. The maps have been sent to the District Attorneys of the following counties:

SUBJECT: **CONVERSATION WITH DISTRICT ATTORNEY GEORGE MORDECAI  
FEBRUARY 4, 1942, AT APPROXIMATELY 5 p.m.**

Mr. Mordecai reported that the Sheriff and the Horticultural Commissioner had a representative at the postoffice, getting information on the Japanese aliens, for the last few days until noon February 4th, at which time the postmaster informed them that that procedure would not be allowed to continue and they would not be permitted to interview any aliens or to obtain data from the Japanese there.

I asked him on what this action was based. He asked the question of someone in the room and said that the postmaster had said he had received a bulletin to that effect. I asked the name of the postmaster, and he stated it was Mr. Edward Murphy.

When I informed Mr. Warren of these circumstances last evening, he asked me if Mr. Mordecai had seen the bulletin. I told him I did not believe so. While he did not give me any specific instructions, he suggested that Mr. Mordecai would probably be shown the bulletin by Mr. Murphy if the request were made.



offering us his services

This morning while you and the General were in conference, Mr. E. Nishimura called and stated that he wanted to see the General about a matter of importance. Mrs. Dibble called me and asked me if I would see him. He came to my office and presented his card, which is attached. He tells me that he is an American-born Japanese and that he has no sympathy with Japan. He is ready, willing and anxious to do anything that he can to help out. I gathered from what he stated he would be willing to do undercover work or anything else that we might ask him. He seemed to have a pretty good knowledge of the dual citizen set-up and said he would be willing to go into that with us if we wanted him to.

Personally I suspect all Japanese, but as they go this young man, who is twenty-five years of age, impressed me as being frank and sincere. I thought you ought to have this information for future reference. I promised Mr. Nishimura that I would call his offer of services to the attention of General Warren and yourself.

STATEMENT OF FACTS

On Thursday, February 26, 1942, at the hour of 3:00 P. M. while the writer was en route to the San Francisco County Jail situated in San Mateo County he observed an Oldsmobile Coupe parked about three miles north of the County Jail on the Skyline Boulevard. The occupant of this car appeared to be an Oriental. In view of this the writer took the license number and continued on, inasmuch as his appointment was for 3:30 P. M. at the County Jail. The license number of this car was 05F254.

The writer proceeded to the San Francisco County Jail where his business was transacted in a period of about forty-five minutes. He then drove again north on the Skyline Boulevard towards San Francisco and again saw this car parked in the same place, the driver of the car having changed his seating posture. The writer continued on for several blocks, then turned his car around and drove back up to the rear of the car and stopped. He then went up and after properly identifying himself to the Japanese occupant of this car, asked as to what the Japanese was doing parked for such a length of time in this area and asked for his credentials. The Japanese immediately produced a draft registration certificate on BSS Form No. 2. This identified the suspect to be Walter Tsunehiko Nakagawa, address 750 El Camino Del Mar, San Francisco. On looking at this card the writer found that the boy was classified as 4-F. There were no apparent physical defects and when asked as to how he received his classification he complained of having ulcers of the stomach and having recently undergone a very serious operation for the correction of this ailment.

The writer knowing that the address given on the card was in a very restricted residential district he questioned the Japanese as to whether or not he working at that address and resided there. The answer was "Yes", that he had been working for a Mrs. Vera R. Hyman for the last nine years or more as houseboy.

The suspect was about 5 feet six inches, weighed about 150 pounds, was wearing glasses and had very definite Japanese characteristics.

When he was questioned as to what his mission was he informed the writer that he had been doing a water color painting of a farmhouse and several outbuildings directly across to the east of where he was parked. Bordering this farmhouse and outbuildings is a lake with a frontage bordering on the Skyline Boulevard. The

main purpose of the writer's questioning this youth was due to the fact that directly west and over a knoll of hills a short distance was situated what was formerly the Dollar Steamship Company's large remote control radio towers, which the writer believes now is operated under the jurisdiction of the Military Authorities.

The suspect was asked by the writer if he might see the picture in question. The Japanese got out of his car and went to the rear. When he opened the turtle back the picture was lying on the top of a scattering of old papers and the "Time" magazines, quite an accumulation of the same. When the Japanese was questioned as to his purpose in carrying the "Time" magazines and papers he said that his employer gave him these to read. Those of the papers that could be seen by the writer carried headlines of the war and other Japanese activities. It may have been by coincidence that these papers confronted the writer, or they may have been preserved for some other purpose. On looking at the picture the same was as explained above, a painting of a farmhouse, several outbuildings, and the lake. The writer then thoroughly checked the automobile for anything of a suspicious nature and found nothing.

It was explained to the Japanese at this point that due to the state of war existing between the two nations he was questioned only as a precautionary measure and no harm was intended. The suspect thanked the writer heartily for his interest and advice as to his parking in these questionable areas, then started his car, turned around and drove slowly north on the Skyline Boulevard towards San Francisco.

The towers mentioned above did not appear in the painting, inasmuch as the painting consisted of only those buildings and the lake situated on the east side of the highway.

BUWALDA re Japanese situation.

Mrs. Eliel and Mrs. Buwalda called at the office on March 2nd and, as you were tied up in a meeting, talked to me.

Mrs. Buwalda left the manuscript of an article which she has written concerning the Japanese in California. She states that the factual material in it has been obtained from the Naval Intelligence in Los Angeles, but the interpretation and suggestions are her own.

It is a long article, surveys the Japanese situation in California, the public attitude toward them, and a suggested solution. She believes that mass internment of the foreign-<sup>and American-born</sup> born Japanese is not practical and has not been indicated by the action of the Federal authorities. She believes, however, that a possible solution is a voluntary submission to government custody by the Nisei. She states in her article that the Nisei would cooperate in this for two reasons:

- (1) Those who are loyal to this country will do it as their part in the war effort and to eliminate the factor of possible fifth column activity by the Japanese, and
- (2) It will give them protection from mob action in the event of an uprising against the Japanese either in connection with enemy attack or otherwise.

Mrs. Buwalda intimates throughout the article that she believes the blanket method of treating all of the Japanese race alike is both unfair and dangerous, inasmuch as it is a concession to and stimulus of race hatred. She believes there are other race hatreds that will tend to flare up.

Mrs. Buwalda told me personally that she has learned from the Naval Intelligence at Los Angeles that the Japanese have, in many instances, turned over extremely valuable information to them and have worked as undercover agents at great risk to themselves. She is informed that they will only do this for the Naval Intelligence because they are confident that that organization alone will maintain the necessary secrecy to protect them. Mrs. Buwalda states that these Japanese have been extremely helpful in assisting the Naval Intelligence to learn what white people are working with the Japanese fifth columnists. She particularly desired that I give you this information as it modifies the information which you relied on in stating over the radio that second-generation Japanese had not given any assistance to law enforcement officers.

Mrs. Eliel and Mrs. Buwalda desire to know if you think it would be well for the Civil Liberties Committee to

make an issue of some of the second-generation Japanese who have been discharged from State service by the State Personnel Board and the State Board of Equalization.

Attorney General Earl Warren has today received a wire from W. H. Bill Mason, of Akron, Ohio, asking us to airmail one-half dozen maps showing the Japanese ownership in strategic locations in California.

Unfortunately, this is out of the question. These maps are very large, being on a scale of one inch to the mile and I am sure you would find it impossible to make any use of them if they were reduced in size. The difficulty is that when they are reduced, most of the Japanese holdings are so small that they do not show up and neither is their proximity to important points so apparent. I feel some assurance in advising you to this effect as several of the agencies of the Federal government, who are concerned with the question and who have desired to make photographic or photostatic copies, have found it impossible to do so.

Mr. Mason also requested us to send you copies of any speeches General Warren may have made on this subject. He has not spoken in public on this matter except on February 21st, at a hearing before the House Committee on National Defense Migration - the so-called Toland Committee. I am, therefore, enclosing a copy of his remarks and also a copy of the written statement submitted in extension thereof, which contains a compilation of the strategic points in some 35 counties of California, which points have Japanese adjacent to them or in their immediate vicinity. I trust that this will be of some assistance.

According to a story appearing in the San Francisco Chronicle of this date the Federal Reserve Bank is to establish an office which will advise enemy aliens with reference to their property. Enclosed you will find a letter from one Clarence Wilmot concerning the transfer of certain real estate standing in the name of a German alien.

Our office receives a number of communications regarding property held by enemy nationals and for future reference we would be interested in determining if the matters now to be handled by the Federal Reserve Bank include generally the property problems of enemy nationals or is to include only advising with aliens who are required to evacuate from the restricted zones. If the latter is the case we would appreciate being advised by you the office to which such inquiries should be directed.
