AS YOU ALL KNOW, WRA IS PRIMARILY A SERVICE ORGANIZATION. ITS MAIN JOB IS TO HELP THE PEOPLE IN RELOCATION CENTER BECOME ESTABLISHED ONCE AGAIN IN PRIVATE LIFE. DURING THE PAST THREE YEARS, IN HELPING OVER 45,000 PEOPLE TO RELOCATE, WE HAVE ENCOUNTERED ALMOST EVERY CONCEIVABLE TYPE OF RESETTLEMENT PROBLEM.

EACH FAMILY THAT HAS COME FORWARD FOR RELOCATION ASSISTANCE HAS PRESENTED A CHALLENGE TO THE ENERGY AND INGENUITY OF OUR STAFF MEMBERS; NO TWO CASES HAVE BEEN EXACTLY ALIKE. YET, IN ALL CASES WITHOUT EXCEPTION, WE HAVE BEEN ABLE TO HELP THE RELOCATORS IN WORKING OUT THEIR OWN DISTINCTIVE PROBLEMS AND IN MAKING AN ADEQUATE ADJUSTMENT. NEVER ONCE HAVE WE FOUND AN INDIVIDUAL OR FAMILY RELOCATION PROBLEM WHICH WE CONSIDERED UNSOLVABLE. WE DO NOT EXPECT TO MEET SUCH PROBLEMS IN THE FUTURE. IT IS HIGHLY IMPORTANT THAT WE CONTINUE RENDERING THIS INDIVIDUALIZED TYPE OF ASSISTANCE IN RELOCATION UNTIL THE VERY END OF THE PROGRAM. IN ORDER TO DO THIS EFFECTIVELY HOWEVER, WE MUST HAVE A COMPARATIVELY EVEN FLOW OF MOVEMENT OUT OF THE CENTERS OVER THE NEXT SEVERAL MONTHS. SUCH A MOVEMENT IS ESSENTIAL IN ORDER TO INSURE CONTINUOUSLY EFFICIENT SERVICE IN INDIVIDUAL OR FAMILY COUNSELLING, IN TRAVEL ARRANGEMENT FOR THE RELOCATORS, IN TRANSPORTATION OF PERSONAL PROPERTY, IN FINDING HOUSING ACCOMMODATIONS FOR RESETTLERS, AND IN ALL THE OTHER LINES OF RELOCATION ASSISTANCE WHICH WRA IS NOW IN EXCELLENT POSITION TO PROVIDE. THOSE WHO ADVISE THE RESIDENTS OF CENTERS TO HANG BACK OR TELL THEM THAT THEIR PROBLEMS ARE UNSOLVABLE, THEREFORE, ARE DOING A MOST SERIOUS DISSERVICE. THEY ARE NOT ONLY IGNORING WRA'S PAST RECORD OF RELOCATION ASSISTANCE BUT ARE ACTUALLY WORKING AGAINST THE WELFARE OF THE PEOPLE WHOM THEY PRETEND TO HELP. WE HAVE CONSIDERED THE PROBLEM OF RENDERING ADEQUATE ASSISTANCE ON AN INDIVIDUAL BASIS TO EVERY ELIGIBLE FAMILY AND EVERY PERSON STILL RESIDING IN RELOCATION CENTERS. WE HAVE ALSO GIVEN ATTENTION TO THE SHORTAGE OF TRANSPORTATION FACILITIES WHICH WILL INEVITABLY BECOME MORE ACUTE IN THE FALL MONTHS AS ADDITIONAL THOUSANDS OF TROOPS ARE REDEPLOYED ACROSS THE COUNTRY. BECAUSE OF THESE PRESSING CONSIDERATIONS, WE HAVE DECIDED ON A GRADUAL SCHEDULE FOR CLOSING RELOCATION CENTERS OVER A PERIOD OF TWO MONTHS INSTEAD OF CLOSING THEM ALL SIMULTANEOUSLY. THE FOLLOWING IS THE SCHEDULE FOR THE CLOSING OF RELOCATION CENTERS:

- GRANADA ON OR BEFORE OCTOBER 15.
- CENTRAL UTAH AND MINIDOKA ON OR BEFORE NOVEMBER 1.
- HEART MOUNTAIN AND GILA RIVER ON OR BEFORE NOVEMBER 15.
- COLORADO RIVER AND MANZANAR ON OR BEFORE DECEMBER 1.
- ROHWER ON OR BEFORE DECEMBER 15.

"IN ORDER TO ASSURE AN EVEN, ORDERLY MOVEMENT FROM THE CENTERS AND A WELL PLANNED PROGRAM OF ASSISTANCE, IT IS ESSENTIAL THAT ALL RESIDENTS SHOULD DECIDE WHERE THEY WISH TO RELOCATE BY SEPTEMBER 1 AT THE LATEST. OUR ADVICE AND ASSISTANCE TO YOU CANNOT BE MADE EFFECTIVE UNTIL YOU HAVE MADE THAT BASIC DECISION. I AM GREATLY PLEASED WITH THE HIGH DEGREE OF SUCCESS ACHIEVED BY THE MORE THAN 45,000 EVACUEES WHO ALREADY LEFT RELOCATION CENTER.

YOUR SUCCESS AND HAPPINESS WILL ENCOURAGE OTHERS TO GO OUT. WRITE ALSO TO THE PROJECT DIRECTOR, TO THE LEAVE OFFICER, TO THE PROJECT NEWSPAPER. 2. RESIGN FROM YOUR PROJECT EMPLOYMENT.
3. CLEAR WITH EVACUEE PROPERTY OFFICE IF YOU HAVE HOUSEHOLD GOODS OR PROFESSIONAL EQUIPMENT TO STORE OR SHIP.
4. SECURE YOUR RAILROAD TICKET. (LEAVE OFFICE.)
5. SECURE YOUR MEAL MONEY. (LEAVE OFFICE.)
6. ARRANGE AT MOTOR POOL FOR TRANSPORTATION OF YOUR CHECKABLE BAGGAGE TO GRANADA. (THIS SHOULD BE DONE THE MORNING BEFORE YOUR DEPARTURE DATE.)
7. ARRANGE AT POLICE STATION FOR YOUR TRANSPORTATION TO GRANADA.
8. CLAIM YOUR IDENTIFICATION CARD, NOTICE OF ARRIVAL CARD, CHANGE OF ADDRESS CARDS, AND GATE PASS AT THE LEAVE OFFICE.




AT YOUR NEW HOME

- B. REPORT OF ARRIVAL. AS SOON AS YOU ARRIVE AT YOUR DESTINATION MAIL YOUR REPORT OF ARRIVAL CARD (FORM WRA 147). WHEN YOU CHANGE ADDRESS MAIL A CHANGE OF ADDRESS CARD (FORM WRA 148). IF YOU ARE AN ALIEN, YOU MUST, IN ADDITION TO THE ABOVE, SECURE PERMISSION FROM THE U. S. DISTRICT ATTORNEY FOR ANY TRAVEL AFTER YOU REACH YOUR DESTINATION. YOU MUST ALSO KEEP THE FEDERAL BUREAU OF INVESTIGATION AND THE IMMIGRATION AND NATURALIZATION SERVICE INFORMED OF YOUR ADDRESS.



- C. RELOCATION OFFICES ARE LOCATED IN THE PRINCIPAL CITIES AND TOWNS IN WHICH EVACUEES HAVE RELOCATED. WRAは個人的基準に於て各家族若くは個人で既に出所した者にも又依然として殘留してゐる者に對しても努めて充分な援助を與へる様慎重なる考慮を拂ひ來つた。更に運輸機關の不足殊に水秋軍隊の輸送と云ふ緊急事態に因り一層激化すると思はれるが、之に付いても充分考慮を重ねた。

- 斯ふした諸般の逼迫せる情勢を研究した結果、本局では全轉住所を同時に閉鎖する事を避けて三月許りの間に八轉住所を徐々に閉鎖する事に決定した。即其の閉鎖日程は左の如し

 - △トバス・ミネトカ、十月一日若くは同日以前
 - △ハート山・ヒラ、十月十五日若くは同日以前

- 右に關し秩序正しき再転住と整然たる補助方針の施行を期する為に最も重要な事は、全在留民が速く共九月一日頃迄には

何れの地に再転住すべきかを決定する事にある。當局に於ては諸君が、此の基本問題を決定する迄は與へんとする援助も効果的たり得ない事を知られ度い。

余は既に再転住せる四万五千名以上の撤退者に依つて挙げられし自力更生の顯著なる事實に限りなき満足を感じてゐる。

今や所内在留民諸君も進んで前述の如き生活様式の改善に努めんとする時WRAは全力を傾注して援助するに吝ならぬ次第である。

嘗て余が各轉住所登訪の際屢々解説を加へた如く、居住民の用語にも亦WRAの用語にも爲し得ざる云ふ言葉は無い若である。
