To Mr. Wayne M. Collins:

We were not a member of pro-japanese group. (Ikokoku Dan or Ikokoku Seinen Dan)

Before war we were good American citizen and we performed our duty as U. S. citizen, but at the time ^{the} war was broken out we American Citizens ~~were~~ were received into the camp with Japanese aliens.

During 3½ years camp life we unwillingly renounced American citizenship by ^{the} pressure of pro-japanese and public influence.

After war was over we desired to live permanently in our native country and we were given a hearing by the officer of the attorney General.

In the mean time we ~~were~~ ^{were} waiting the permission of the Attorney General to join together with my wife's family who already relocating in Salt Lake City, Utah.
