VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.) The following comments are submitted relative to employment experiences during the month of October. The Fair Labor Practice Board was completed and has processed a number of grievances during the month of October, including one case of evacuee labor contractor working within the Project, recruiting for special groups of employers, in direct contradiction to the rules governing employment which assures the same privileges of employer-employee relationships controlled by the Employment Division at the project level. The Fair Labor Practice Board condemned the policy and set up restrictions to prohibit its recurrence. Harvest laborers, completing their contracts signed early in September, are now returning to the project in increasing numbers. Most of them are signing on other contracts still unfilled, and are returning to the fields within a few days. About 10% remained on the project after completing their contracts, and are assigned to project employment. An analysis of the "offers of permanent employment" received at the project, indicates that 90% of them are for sub-standard jobs, domestic or farm offers, where Caucasian labor have left for higher-paid positions and are no longer available. The project is concerned about this and is asking the national office to assist in securing adequate, standard-pay offers for all the occupational groups represented in the employment files. The occupational breakdown under Section I of this report is incomplete, and it is difficult without detailed instructions to determine what is meant, for instance, "Project Operation". We are in receipt of a request for statistics from the Regional office, which includes a breakdown rather more complete in nature than the reporting requirements of the National office.

VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.) Project employment has increased as people have returned from harvest. Special emphasis has been placed on employing workers in project operation jobs, manning newly-arrived machinery, assembling equipment, etc. These will be shifted to land clearance and subjugation as soon as weather permits.

The most significant development has been the discussion between the field investigators and the project employment office relative to their efforts in the field in relocating workers, either on farm jobs where they have been employed, or in other positions. From the project's point of view, the efforts of the field investigators in relocating evacuees are not as satisfactory as project efforts along the same line. The field investigators do not have access to the project facilities, (social service, internal security, placement, census, etc.) and have relocated a large number of people, many of whom would not have been considered as ideal placements, had the applications been processed by the project. It was also discovered that field investigators have extended several hundred pass permits without notifying the project so that when group work short-term leaves issued by the project early in the harvest program fall due, the project has no way of knowing that they have been extended. Regular meetings are now being held with the field investigators in Idaho, and some of this difficulty has been ironed out by mimeographing cards whereby the field investigators can notify the project whenever an extension has been granted. The problem of field investigators permanently relocating individuals in the field has not been settled, as yet. The labor shortage has been almost entirely eliminated by the rapid return of workers in the field, and the employment division is devoting much of its time to efforts of permanent relocation, securing adequate job offers, etc. A Section has been established to centralize all leads, as indicated by Administrative Instruction 12.

VI. - (1). Farm furloughs
- (2). Outside employment
- (3). Nisei volunteers for military service.

If these functions have possibility to make people go out of the Project, naturally the project labor force will be reduced to an acute shortage.

On the other hand, unfair working conditions have been argued recently among the project workers. The main reasons are namely: inadequate wage classification, insufficient work clothing to the laborers who are working outside, and inadequate equipment and transportation facilities.

The feeling of this inadequate compensation especially marks in persons with professional training because some of them are under the same wage classification as non-professional persons and, at the same time, they have to work as hard as others.

Such tendencies may be considered as they will dislike to continue their work.

VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.) There has been an increasing demand for workers from all divisions on the project. This has been partially influenced by weather conditions and it is anticipated that with continuing good weather, the demand for workers will probably show further increase. While no particular shortage of workers exists at the present time, there has been some shifting and transferring of workers during the month. It is anticipated that further transfers will be necessary to fill the demand, especially in agricultural employment.

There is an increasing demand for off-project workers which will materially decrease the supply of workers available for project employment. The transfer of workers to this center from Manzanar and Tule Lake will offset the loss of workers cause by Army induction. A study is being undertaken at this time to collect some factual information regarding man-power and man-day production. It is anticipated that this survey will reveal ways and means of maintaining or increasing production on the project with the same number or even a smaller number of workers.

VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.)

We are facing a shortage in the male manpower on the Project. The survey reveals that we are in need of about 300 men in the immediate future. Our investigation shows that the demand is much greater than the available supply if the present pattern in each division is to be continued.

The figures show that there are only 249 males between the ages of 16 and 64, who are employable but have not registered. Of this number, 60 per cent are under 19 and over 55 years of age, which means that we will have to try and satisfy the demand of 300 with 100. This is not easily done. If these employables register for work, we will have to place them in suitable positions and it is needless to say that it is impossible to place all the available help in suitable positions.

VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.) Although it is needless to say that we are facing a very acute labor shortage, especially War Works and Public Works have been the hardest hit of any divisions so far by workers leaving for outside employment and seasonal farm labor. To bring these division to maximum efficiency, the total requirements are 100 farm laborers for the War Works and 350 for the Public Works such as carpenters, irrigations, laborers, highway laborers, etc.

A great effort has been made in investigation of the male able-bodied persons of working age who have not registered. Recently it has shown an effective increase of intermissions for employment but this manpower will be limited to a certain number. Moreover, it is considered that the only way to moderate this labor problem will be done by placing an older group of female workers where they can work without endangering efficiency and by adjusting the distribution of project labor.

VI. GENERAL COMMENT: (Give a brief report on any unusual and significant problems or incidents which have arisen in the fields of employment, placement, labor relations, work incentives, working conditions, accident prevention, etc.)

According to the monthly statistical employment record, the total number of the project employees has gradually decreased--especially, the number of the female workers has decreased 6% in comparison to that of the previous month. It is considered that the main reasons for the decrease are (1) that no more assignments of labor except for vital jobs have been made through the Placement Office to the divisions, (2) that the divisions have an intention of carrying on labor adjustment to operate within a minimum number of manpower, and (3) that 80% of terminated persons are due to the off-project.

Based upon the new administrative instruction of June 25, 1943, the total number of employed would be greatly reduced, whereas it is estimated that the number of unemployed would increase to nearly 1,000 persons. As to this matter the problem is how to adjust the present labor force in order to fulfill this plan. Also, it is considered that the unemployment problem would arise again in the project.

On the other hand, better standard of wage scales is requested to a certain extent because sooner or later the evacuees will meet the acute financial difficulty under the present wage system.

The following comments on this statistical report are submitted:

1. In the administrative revised instruction No. 27, it is stated " the employees of Business Enterprise, not paid by the War Relocation Authority, are not considered in determining maximum evacuee personnel." Subject to this statement, the total number of employed must be 3047 persons after deduction of 128 workers for Business Enterprise. Moreover, since 229 workers are reserved in the Labor Pool Section (see Form 122) to meet emergency requirements of labor, it may be considered that about 2850 persons are the evacuee workers assigned within a limited number of the personnels.
2. In the Evacuee Employment Section of this report form, it is difficult to show accurate and total employment figures in this given category from which this Project divisional organization has been slightly different due to the revised form of July. For example, the Legal Section is an independent division according to the Project organization. Also, there is no Executive Section under Project Administration, but, since there are more sections under this division, such as Office Service and Statistics, these sections are included in the Executive Section to make use of this given category. The Labor Pool Section is to be under the Employment Division, which makes the total number of workers for August greatly increase over July in this division. In addition to the above mention, the Procurement and Community Analysis are included respectively into Warehousing and Public Welfare sections on this monthly report because, in fact, they belong to the Supply and Community Service Divisions.
3. Regardless of ^{the} unchange on the total employment for August, the number of unemployees shows a decrease of 20% over July. It seems that this decrease is caused by the seasonal farm work and outside employment--nearly 400 persons left Project for employment during the month of August.
4. From the statistical investigation of April, it was found that there were very few employable persons who had not registered for employment at that time. Especially, most of employable males have registered for work. Therefore, approximate 200 males and 50 females are those who had registered previously but have not reported back their return from seasonal work outside Project. ^{to the Project} It is considered that these persons are the same group as those who have not

registered for employment at Project.

5. The term of Unemployment Compensation has to be changed to Illness Compensation, because full time workers, regularly employed, who are unable to report for work due to illness, shall be eligible for this compensation after exhaustion of sick leave (Revised Instruction No. 27).
6. The figures for the vocational training show only the number attending the adult vocational classes. However, there are high school vocational training classes such as office practice, nurse's aide, carpentry, agriculture, auto mechanic, plumber, electrician, etc. The total number of students attending the above mentioned classes is 96 persons (59 boys and 37 girls).

It is hoped that the above explanation will give a reference to this monthly report.

Regarding the monthly report on project Employment, the following comments are submitted: According to the month ending figures of September, the total number of evacuee workers at this Project was 3042--4% decrease as compared with 3175 of the previous month. Especially, the Central Service (Labor Pool) section showed 33% decrease of workers over August. This decrease was caused by the terminations of 180 workers segregated to the Tule Lake Center and the reserve of their vacant jobs for new transferees coming from the Tule Lake Center. Moreover, except an emergent need of professional and skilled workers, no assignments of jobs were made to any persons until the last group of transferees came into this center in order to provide a fair opportunity of project employment among them.

Accordingly, the number of unemployees increased to a certain extent because of a limited number of job openings at Project.

It is estimated that, at least, 650 persons of 1,500 new transferees are employable according to their employment records on hand. However, 50% of them will be assigned to jobs within a few days through the Placement Office.

Recently, the people's attention is turning on the harvest work outside the camp. Therefore, it is not so seriously expected that an unemployment problem will arise within the project.

It is hoped that the above mention will give a reference to this monthly report.

MONTHLY REPORT FOR OCTOBER, 1943

The total number of evacuee employees in this project was 3,047, which showed a slight increase of 0.16% as compared with 3,042 of September, and was 43% of the project population of October. During the middle of the month, however, the total employment increased to 3,200, due to employment of the Tule Lake people. Since the attention of the people began to turn on the harvest work outside the camp, 600 workers were terminated from their work for the seasonal harvest. Regardless of the same number of job assignments made through the Placement Office during the month of October, it has been reported that 1,500 employable evacuees have left on seasonal leave from this center last month.

The remaining manpower will be estimated with the following figures, indicating a noticeable decline of unemployment as compared with 738 of September.

In the report, the divisions which showed remarkable increase in employment are Project Administration, 8.6%; Public Works, 7%; and Internal Security, 6.5%. It is also noticed that the divisions, such as Central Service, Report, and Agriculture, showed a great decrease of 18%, 16.7%, and 13.7%, respectively. (The Central Service, previously under Employment, is now under the supervision of the Operations Division.) During the labor shortage in the Agriculture Division, 260 pupils, under 16 years old, were assigned as temporary harvest workers during the month of October.

Through the experience of last year, however, it is expected that the seasonal workers will gradually return to the project from the beginning of November and that the highest peak of the number will appear at the close of the month. At that time, it is needless to say, there will be a tendency for the volume of project employment to show an increase to a certain extent.

Subject: Monthly Statistical Report on Project Employment


At the return of 1,600 seasonal workers in November 1943, total Project employment showed an increase of 13.5%-- 3,460 employees (2,033 men and 1,427 women), as compared with 3,047 of October 1943. With the exception of Post Office, Warehouse, and Internal Security, all the other divisions showed an expansion of employment volume to a certain extent. Especially, the sections such as Recreation, Central Service, Education, and Fire Protection indicated an increase of 100%, 58%, 40%, and 39%, respectively, over October 1943.

This seasonal return brought total unemployment to 583, an increase of 17.5% over October 1943, but this figure should be practically larger if all the seasonal workers had reported on their return to the Placement Office for Project unemployment. It is expected that the volume of Project unemployment will be gradually enlarged toward the winter season.

The precipitous decline of monthly labor separation rate appeared in November, 7.9 per 100 employees as compared with 19.0 of October 1943 and 8.2 of November 1942; this reason was due to the decrease in the number of evacuees leaving for outside employment. The accession rate decline slightly to 19.3% as compared with 21.5% of October, but showed apparently higher than the separation rate. Since the Project employment quota has been established, however, the employment volume will not be enlarged any more.

Subject: Monthly Statistical Report on Project Employment

The following comments on the attached statistical report are submitted relative to Project employment in December 1943.

The total number of evacuee employees in December 1943 was 3,697 (2231 men and 1466 women), 237 more than in November 1943 and the largest employment volume since July 1943. Since 159 employees of Community Enterprise and 295 part-time workers and trainees were included in this total employment, actually, the total number of evacuee employees on basis of the Project employment quota was 3306 after deduction of these figures mentioned.

However, this gain was largely due to the increase of Project population at the return of seasonal workers, the emergency need of manpower in the operation division, and the decline of monthly labor separation rate, which showed only 4.6 per 100 evacuees employees as compared with 7.9 of November. It is also noticed that the Education Section showed an increase of 118% in employment over November 1943, but this increase should not be considered as an expansion of its employment volume because this section has charge of all the apprentices and trainees, who had been previously distributed to the divisions.

The total number of unemployees was 589, indicating an unchange over November 1943, because Project employment increased to a certain extent. Since the accession rate began to decline in December, it is expected that this volume will either enlarged or unchanged during the winter season (the accession rate in December was 11%).

As was stated in the report of November, it was anticipated that the evacuee employment volume would not be enlarged any more, due to the limited employment quota. However, it is considered that the contingent labor reserve is especially required during the winter season such as coal swamper, highway laborers, boilermen, etc. in order to avoid an occurrence of unfavorable living conditions of evacuee inhabitants due to bad weather. For the purpose of such emergency need, therefore, the present employment volume will be maintained for the present time.

Subject: Monthly Statistical Report on Project Employment

Submitted are the comments on the attached statistical report of January 1944. The total number of evacuee employees on the Project was 3,615 (2,196 men and 1,419 women), 82 less than in December 1943. This total was inclusive of 167 apprentices and trainees at the \$12 rate, 120 part-time workers to be estimated as a half unit of regular work hours, and 158 workers of the Community Enterprises Section not paid by WRA. Therefore, the actual number of evacuee employees should be considered as 3230 of which each unit was based on the standard work day authorized by WRA.

The slight decline of Project employment in January was largely due to the curtailment of placement so that the total number of evacuee employees might not be exceeded an established ceiling. In this attached table, it is noticed that most of the sections indicated a decreasing number of employees, as compared with those of December 1943, except for the sections such as the Finance and the Education. As a whole, the labor separation rate was 6.3 per 100 employees, whereas the accession rate was only 4.1. Also, the establishment of Standard Evacuee Employment on January 8, 1944 resulted in making one of factors of this lower accession rate.

The total number of unemployed was 655, as compared with 589 of December 1943. As was stated on the report of December, it is anticipated that unemployment volume will be enlarged to a certain extent because job openings at Project are almost curtailed for the present time. According to the memorandum relative to the new establishment of Standard Evacuee Employment, a separate allotment for apprentice positions has been made to continue the vocational training problem and excluded from the authorized evacuee positions. Therefore, the applicants for these positions should be neither considered as a labor source at Project nor as unemployed, but there were approximately 90 students subject to this category, who were involved in the total unemployment of January of 1944.
