Dear Yo,

Thanks very much for your gracious letter. Since we didn't hear of any planes falling out of the sky, we presumed you arrived home safely. What a worry wart you are, about the funniest things. Ernie said perhaps you would have felt better if we had another car follow us to the airport, in case ours broke down. That's what they do for the president of IBM.

Your visit was all too brief. We hope you'll be able to return to Utah and spend more time with us. Having guests is no bother with the separate area downstairs. As my mother used to say, when a place is used insects have no opportunity to encroach. Since I dislike traveling, having visitors is like a vacation for me. And Ernie thrives on company, being the social creature of the family. Aside from Nicholas, that is.

You couldn't have picked a better week for your trip. On Easter Sunday, we had two feet of snow in our yard and Nicholas was running belly deep in it. And then on Monday, the winds came hurtling through. The road to Ogden and Weber College was closed. They sent the kids home from school and closed Hill Field. There were many power outages and considerable destruction. Trucks had fallen over on their sides. The wind was not as severe in Salt Lake, but students couldn't walk on the University of Utah campus so they closed that. Alan had to wait until noon before Parley's Canyon was open to Park City.

The ophthalmologist checked my eyes twice because of my concern over the flashings I had. He couldn't find anything. But the flashing occurred again on Easter. He told me to return if it recurred another two or three times. It keeps me edgy. He also commented on my screwball eyes, the kind that don't really require glasses. One eye is farsighted and the other is nearsighted so they compensate. That's another reason I hate going to doctors. Each one invariably comments on some freak aspect of my body. He told me my folded eyelid could be corrected surgically, if I wanted. I retorted that I actually needed a new spirit more than a new appearance. He said he'd read up on spirits.

My friend came by Tuesday to pick up her manuscript. I had typed out your suggestions and she asked that I relay her appreciation. She was going to write you, but I told her it wasn't necessary. That's all you need, more correspondence. Michi Weglyn told me that takes up most of her time.

Speaking of Michi, she called on Saturday. I told her you recommended "Infamy" to your audience at Weber. She was very flattered and properly responsive. Michi said you must have been very ladylike and reserved. She got that impression from reading "Exile." I told her that your reserve



had largely dissolved by the time you left. Michi said I have that effect on people, whatever that means.

Alan spent most of the day with me yesterday. He decided he deserved a day off after working most nights and on Easter Sunday. He said he and Mary Dickson enjoyed you very much. That's a compliment since he doesn't say things he doesn't mean. He tells Ernie that most of the IBM guests are bores. We did a little shopping, had lunch and came home so he could take a nap. Then, he finally washed the Camaro that has been sitting filthy in the carport. Alan borrowed it when it was sparkling clean and had promised to return it in the same condition. Ernie was appalled that it was still dirty when you arrived. Alan stayed for dinner, as usual. Nicholas was happy to see him since Alan took him for a run at Skyline High. He really requires violent exercise, which he doesn't get during the winter. When the weather is clement, Ernie and I take him down to the high school in the car. It's very dangerous since Nicholas goes berserk in the car. I read your note to him and he listened with his head cocked in full attention.

We haven't had snaps (prints) made of your poses with Nicholas. But will this weekend. I refused to go into stores before Easter. Every Mormon parent was probably in there with his or her dozen screaming kids. And I thought it was terrible that you should swipe that snap Ernie took of you and Wanda Robertson.

Thanks very much for the Blum's mints and for "The Sea of Gold." I hope to begin reading it tonight. Just finished, "Dinner at the Homesick Restaurant." I read only about a half dozen books of fiction during the year. Forget writing another evacuation book. Aren't you getting a bit tired of that topic?"

Ernie sends his best. We both missed you after you left.
