Dear Sir:

The maps supplied by you to me for the purpose of indicating thereon all property situate in the County of Fresno owned, controlled, or occupied by persons of the Japanese race are herewith delivered showing in red thereon all agricultural lands of Japanese situate in this County as ascertained from the books in the Assessor's Office. Information as to the interest in land held by Japanese other than of record, such as leases, etc., will take additional time in acquiring, for the reason that it is only in rare cases that leases are placed on record.

I am not furnishing you at this time maps indicating the property of Japanese in incorporated areas as time has not permitted this to be done, but these maps will be furnished you in the near future.

Dear Sir:

I desire to acknowledge receipt of eleven pages of the eleven-page map of your County which was sent to you in connection with the Alien Land Law survey being carried on by this office. Your courtesy and cooperation in connection with the completion and return of these maps are greatly appreciated.

As yet I have received no City maps from you. It may be that the conditions existing in the cities of your County did not justify the preparation of such maps. On the other hand, the task may be requiring more time than I might anticipate. We are finding these maps more and more useful, so if you are going to send any additional maps I would greatly appreciate anything that you can do to get them in my hands at an early date. If you do not consider that these maps would serve any useful purpose, I would appreciate it if you would so advise me so that I can make the proper notations in my records.

I presume that there will probably be material changes in connection with the map of your County which reflects the location of Japanese thereon. If, at any time, any changes seem sufficiently important, I would appreciate it very much if you would advise me of these changes so that I can make the proper notations on the maps of your County which I have here in this office. If you should deem it advisable, I will be glad to return to you all or a part of the maps which you previously sent in to me, and thus give you an opportunity to make any changes, corrections or additions which may be necessary.
