\* Regulations Enacted This Month:

Speed Regulation Within the Center: The maximum speed limit of all motor vehicles within the project area shall not exceed 20 miles per hour, and the maximum speed limit of all motor vehicles in and near all school districts not to exceed 12 miles per hour, except in cases of emergency; and that any person or persons found guilty of the violation of this restriction shall be punished in accordance with the provisions set forth in the Administrative Instruction No. 85, and that the staff of all Internal Security be empowered to enforce this restriction to the fullest extent.

\*\* Problems Referred to Blocks:

Copies of the proposed Charter in Japanese and English were supplied to every voter in every block about the middle of October. Each block voted separately on its ratification. Before the month ended, it was known that ratification would be unanimous.

List of nominees in each block for council representatives was secured by petitions of ten or more voters. Most of these names have been submitted to the Executive Secretary of the Council. The eligibility of each individual is being determined and each one referred to the Project Attorney for confirmation. The Temporary Community Council set November 13, 1943 as election day and is completing plans for that election.

Findings and Recommendations of Committees:

The Wood Committee composed of 4 Councilmen and 6 Block Managers adopted a system of wood cutting and hauling on the block basis. The method proved more satisfactory than by the center basis. It is anticipated that the wood problem will be solved before the winter sets in.

## NARRATIVE REPORT:

The Temporary Community Council was terminated by the establishment of Permanent Community Council, by the general election held Nov. 13th, 1943. Election statistics shows that seventy seven per cent of the eligible voters cast their ballot and of the thirty three councilman elected, eighteen were issei and fifteen nisei.

First meeting of the Permanent Council held Nov. 17th, with thirty two out of thirty three members attending. One elected members tendered his resignation, which was accepted by the Council Body with instruction that his place be filled by person to be selected by the people of the Block. Officers including the Chairman Vice Chairman and Treasurer were elected at this meeting. The elected officers are the following:

Chairman	Frank F. Arakawa
Vice Chairman	Fukuji Sasaki
Treasurer	Zenichi Imamoto

Second Meeting of the Permanent Community Council was held on Nov. 24th, 1943. At this meeting a resolution of appreciation to Mr. Paul A. Taylor was presented to the members for approval and adoption. It was unanimously voted for adoption. The Chairman presented the resolution to Mr. Taylor.

The adoption of Relocation Planning Commission was postponed until formal dissolution of the existing Relocation Committee because three members of the Council were named on the Committee.

The Council enacted an amendment to Article IV Section 2a of the By-laws which reads as follows:

"Members: The members of the Resolution Committee shall be three (3) citizens to be elected by the council."

Whereas such a section is inconsistent with the remainder of the Charter and By-laws, and was so framed thru an error, that it enacted that the said section of the Article and Subsection shall read as follows:

"Members. The members of the Resolution Committee shall be three (3) duly elected and qualified members of the Council."

The amendment was adopted and approved by a unanimous vote.

1. Fact Finding. To investigate into different cases pertaining to the welfare of the residents.
2. Education. Adult education and vocational Training necessary for Relocation Program.
3. Resolution. To draw resolution for the Council.
4. Public Health. Sanitation and Hospital.
5. Food. To look after special diet for those afflicted with different sickness and in general food for the resident as to its nutritious value.
6. Fuel. Apartment wood and coal for mess and Shower room.
7. Labor Relation. To keep all division laborers in harmony.




