



SUBJECT: Committee Resignation


I beg to acknowledge receipt of your letter to the Canal Temporary Community Council, stating the fact that the members of the Constitutional Committee desire to withdraw from that body, together with reasons set forth for their withdrawal.

The Canal Community Council appreciates very greatly the work which the Constitutional Committee has done and is fully aware of all the difficulties it has gone through to produce the draft of the Constitution as it is now. As you stated in your letter it is most probable that written instructions will come from the WRA Headquarters to the effect that Isseis will be allowed membership on the Community Council. Consequently, many changes would be necessary in the draft and we feel that it would be a good thing if more Issei members are added to the Constitutional Committee.

However, since the Committee was not created under the authority of the Community Council but rather under the authority of the Project Director, it would be impossible for us to add to this committee, or subtract from it, any of its members. The Council feels that if the Constitutional Committee desires more Issei members on its board, the Project Director would place on it as many Issei members as the Committee feels necessary.

We realize that up to the present time, the Constitutional Committee has done everything in its power as well as it was able to do under the circumstances. The Council feels that your Committee should reconsider its resignation and be on active duty so that whenever more definite instructions come from the WRA Headquarters, it will be possible for you to modify or change the Constitution accordingly.

Dear Mr. Myer:

We, the people of Canal Community of the Gila River Project, Rivers, Arizona do realize the truth of your reason for closing this community, such as decrease of population which was caused by successful relocation of our people both to the West Coast and elsewhere. This was partly due to our desire to cooperate with your policy because of our faith in you and WRA.

However, we wish to point out some economical factors and differences of circumstance between many of those who have already relocated and those who are still remaining in this center. We will appreciate your sincere consideration on behalf of those who must relocate with the closing of this center.

Most of those who have relocated thus far have been either house or real property owners, ranch owners or possessors of other wealth which enable them to feel secure enough to go out and make their own livelihood. Also many were young and single with no worry of dependents, so naturally they had no serious housing problem to cope with nor to make them feel insecure financially.

Many among the residents now residing in this community are those who have no home to go back to. Most of us have already used or spent the bulk of whatever funds we had at the time of induction into this center. Some family heads are either too old or physically unfit to do any hard labor. Then some families with only one breadwinner and a large number of dependents do feel insecure of making a livelihood for the whole family in an outside war-time community of today. And it is natural for them to be skeptical of relocating depending only on whatever limited held they may get from the welfare agencies.

As you know, closing of one center by transferring the residents into another will not cause much difficulty or hardship to the people, as shown by the experience gained in closing of Jerome Relocation Center. This was due to a full understanding of the people of the dependability of WRA in furnishing a place to go, which was practically the same as a guarantee of security. But the closing of our community differs entirely from the previous closing of the Jerome Relocation Center and we sincerely believe many difficult problems will arise.

Although we realize that WRA is doing everything possible with the cooperation of other government, State and County agencies in returning our people to normal life, yet their combined efforts have failed so far to stop the attack incidents or to wipe out anti-Japanese American elements. Consequently some people cannot help feeling skeptical about relocating into certain insecurity of life and livelihood.

Therefore, we request that the utmost material help and protection be given to those who relocate hereafter, and in addition to the above facts we submit the following suggestions which may be of help toward the solution of some of the problems arising from the closing of this community.

SUGGESTIONS

1. That WRA investigate and furnish full information on places which have group relocation possibilities. Location choices for most Canal residents are California, Arizona, and Texas in order named.
2. That WRA help open farm labor camps in various parts of California.
3. That WRA temporarily loan beds, mattresses and blankets, which the residents are now using, to those who have no household goods.
4. That WRA permit representatives of groups of relocatees to make an exploratory trip to the place of their probable destination anywhere in the U. S. And pay all expenses of such exploratory trips.

5. In order to help the relocation of Canal residents, WRA should locate as much seasonal work as possible in California and permit family heads to go out on such work until closing of center.
(note) Limited WRA help is inadequate to meet the needs of some of the people with low economical circumstances when they relocate. But money saved through seasonal work plus the fact that they can look for housing while working will ease the way for calling out the rest of the family later.
6. That WRA deliver without charge all freight and baggage directly to the home of the relocatee instead of only to the nearest station.
7. That WRA help secure priority on building material for those relocatee who wish to build a temporary home or repair an old home.
8. That any commitment or promise made at the time of relocation by the center relocation officers should be faithfully kept and carried out by the Field offices.
9. That, since the relocation grant of twenty-five dollars will not even pay for one week's room and board, we request your consideration in increasing such grants as much as possible.
10. That WRA help solve housing problem wherever the choice of relocation may be.
11. That WRA store relocatee's goods without charge until relocatees finds suitable and permanent housing.
(note) One average laborer cannot take so much baggage from one job to another until he is able to find permanent housing.
12. That WRA keep up present storage facilities for the duration of war.
13. That WRA give every consideration to old and physically disabled residents.
14. That WRA give careful consideration and same protection to some who may be unable to relocate by closing date.

15. That WRA give full information in both Japanese and English regarding all the papers that individual relocatees must sign at the time of leaving the center.
