CENTRAL JAPANESE EDUCATIONAL ASSOCIATION (Chuo Nippon Kyoikukai)

Fourth Regular Meeting of the Board of Education

November 30, 1943
2:00 pm

The meeting was called to order by the chairman, Sanao Ikeda at 3007-C

1. Mr. Nakamori assumed the duties as Director of Ward 2 after Mr. Fukuda's resignation.

Mr. Shimohara took up the office as the new Director of Ward 6.

2. A donation of \$10.00 to the Chuo Nippon Kyoikukai was received from Mr. Fukagai. It was decided that the Kyoikukai send a letter of appreciation.

3. Following are reports of the negotiation with the Cooperative Enterprise.

- a. Payment of supplies bought

It was decided that as long as the by-laws with the Co-op should not be amended, it will be impossible to open an account; therefore, the Kyoikukai shall raise the money for what supplies are needed and will pay for the supplies used.

- b. Collection of rebate tickets

A box will be placed in each canteen and blocks for residents to put their stubs in. The placing of boxes at the canteen will be left up to the co-op.

- c. The rebate tickets received for purchases made by the Chuo Nippon Kyoikukai shall be counted together with those collected.

4. Rebate ticket collection box

- a. Similar boxes used by the Co-op shall be placed in the blocks.

- b. The words to be written on these collection boxes will be left up to the blocks at this time, but in the future something uniform will be decided.

5. The Chuo Kyoikukai's educational fund for the month of November was \$830.95. Out of this the amount from \$300 to \$400 was paid to the Co-op. The balance will be used

for payments as necessity occurs.

There being no further business the meeting was adjourned.

Fifth Regular Meeting

December 7, 1943
2:00 pm.

The meeting was called to order by the chairman, Sanae Ikeda at 3007-C.

1. Report was made by Mr. Miyamoto of the arrangements being made for the opening of the American public schools. A representative from the Army and WRA were present at this meeting.

Following are matters that were discussed or decided upon:

- a. Approval of the Japanese language schools in this center was given.
- b. The immediate opening of the high school is impossible due to incomplete arrangements.
- c. By using the high school building the grammar school for grades one to nine may be opened.
- d. Resident teachers will be added as teachers are short.
- e. School hours will be both during mornings and afternoon.

The Board of Directors of the Chuo Nippon Kyoikukai resolved that the association has no objection towards the opening of the American Public Schools.

2. November treasury report was made by the Treasurer, Mr. Kiyohara as follows:

3. It was decided that the minutes of the meetings of the Board of Directors will be given to all block educational representatives.
4. Vice Chairman, Mr. Goto, resigned due to personal reasons.
5. A combined meeting of the teachers' representatives and persons appointed for arranging teaching materials will

be held on Saturday afternoon.

Sixth Regular Meeting

The meeting was called to order by the chairman, Sanae Ikeda at 3007-C.

1. The following new Ward Directors were introduced:

Mr. Saburo Shoji succeeding Mr. Goto for Ward 2
Mr. Yanohira succeeding Mr. Jono for Ward 3
Mr. Imamura succeeding Mr. Sahara for Ward 7

2. Wages of all teachers and workers under the Chuo Nippon Kyoikukai.

- a. As it will be difficult to pay in accordance as with the WRA wages in view of the situation now in existence, teachers and workers in the office will be paid \$10.00 per month as wages until the center is back to normalcy.
- b. In response to the efforts made by the teachers, recom-pensations to the teachers at the end of the year will be left up to the wards.

3. Uniformity of the advanced grades

Since it is difficult and also impossible to gain the most efficiency through one teacher teaching many subjects in each ward for the advanced grades, it was decided that these advanced grades in the wards be combined as one unit in this center.

Messrs. Ikeda, Naito, and Kiyohara were appointed to work on this problem with the teachers representatives.

4. The term of office for the officers of the Chuo Nippon Kyoikukai Directors will be six months.

First term: February 1 to July 31
Second term: August 1 to January 31

5. Due to Mr. Goto's resignation, and as this term of office is near the end, the Board will not have an election at this time but will do without the vice chairman.

6. Purchase of mops, buckets, brooms for use in the schools will be left up to the wards.

7. The subject of winter vacation and the New Year Service will be discussed at the next principals' meeting. The Board of Education proposes December 25 to January 2 as winter vacation.

There being no further business the meeting was adjourned.

2. Uniformity of the advanced grades

The following are the reports of the discussions of the advanced grades teachers' association meeting held on Sunday, December 19.

- a. The seven subjects: language, moral course, geography, history, composition, grammar, and writing will be constituted in the advanced grade course and will be divided into first and second grades.
- b. There are approximately 300 students in the advanced grades.
- c. Wards 1, 3, and 4 will constitute School 1 and Wards 2, 5, 6, and 8 as School 2. Ward 7 will be decided after the movement is completed.
- d. Teachers' schedules will be decided at the meeting of the teachers' representatives of School 1 and 2.

3. Following matters were decided at the principals meeting.

- a. The winter vacation will be from December 25 to January 9.
- b. New Year Service will be held as deemed appropriate at this time.
