

Following is my report for the month of August. During this month I had a total of 101 interviews, fifty-three interviews out of these were on account of life insurance and of this fifty-three interviews, one case was of death claim; two cases of total disability benefit claims and eleven interviews for seven cases on account of matured endowment policies. Of these seven Matured endowment cases two of them asked for issuance of Supplementary Contract. I had seven interviews for six cases of Change in Policy; of which five interviews were for Change of Beneficiary and two interviews for Extended Term Insurance. I have interviewed sixteen persons for premium payments; of those two cases were to pay premiums by dividends. Of paying premiums by policy loan, I had four interviews for four cases. I gave a thorough explanation of Extended Term Insurance Provision for nine persons for seven cases, and of cash surrendering of life insurance policy, I had two cases for seven interviews. For fire insurance I had two interviews.

On account of Withholding and Victory Tax and Declaration of Estimated Income and Victory Tax by Individuals and its filing, I had forty-one interviews. I made three interviews for IFR 300 reports for one case and for Social Security two interviews. I have assisted an evacuee for applying license for transaction of her blocked life insurance proceeds to deposit in a blocked savings account in her name.

SUBJECT: Monthly Report for the month of September

Reporting for the month of September, I had a total of 137 interviews; of which thirty-five were in connection with insurance. And out of these thirty-five, three interviews were for death claims, two for total disability benefits, five for matured endowment policy cash transactions, three for change of beneficiary, four each for extended term insurance problems and policy loans, eight to assist life insurance premium payments. For a person I gave a thorough explanation of the War Clause on his life insurance policy and assisted three evacuees in cash surrendering their policies. There was a case of accident insurance claim and a claim for a house fire of an evacuee.

To complete transactions of a blocked life insurance proceeds to deposit in a blocked banking account, I have assisted two evacuees with three interviews. In connection with reports to the Federal Reserve Bank, of the funds in foreign countries, I have made three interviews.

I made ninety-nine interviews to give thorough explanations and to assist in executing form 1040-ES. Mr. Dick Y. Harada assisted us in interviewing and filing of eighty-three cases.

We have written thirty-five letters and they were addressed to the following companies and government agencies: nine for New York Life Insurance Company; four each to the West Coast Life Insurance Company and Sun Life Assurance Company; and two each to the Metropolitan Life Insurance Company; Oregon Mutual Life Insurance Company and the Manufacturers Life Insurance Company and one to John Hancock Life Insurance Company. Seven letters were sent to the United States Collector of Internal Revenue; three for the Federal Reserve Bank of San Francisco and a letter was written to the Fidelity National Bank of Twin Falls, Idaho.
