Dear Mr. Barrows:

In reply to your teletype of March 29, 1944, relative to the factors motivating repatriation and expatriation since the time of the last segregation from this Center in September, 1943, we have gleaned the following information.

On March 20, 1944, we prepared the list of all persons subject to segregation dating from the time of the last segregation to March 20th, inclusive. Our analysis has been taken from this group which on March 20th numbered 190 persons subject to segregation for reasons of repatriation or expatriation. Out of this number 12 had been deferred from the last segregation movement because of illness. In another group and also included in the above figure are 5 people who have requested expatriation or repatriation and who have also requested permission to go to the family internment Camp. The 190 figure is exclusive of accompanying family members.

We have broken this analysis down into two categorical parts, namely, those requesting expatriation or repatriation prior to January 20, 1944, or the date upon which Japanese were declared eligible for selective service, and those making requests after that date. Of the 190 segregants, 35 families consisting of 81 people applied prior to January 20, 1944, 42 families involving 99 persons applied after that date. We have attempted as nearly as possible to categorize the reasons which these individuals gave for their request and from the total group, we picked at random 89 cases, 50 of which requested expatriation or repatriation after January 20, 1944, and 39 requested prior to that time. The difference in these numbers is explained by the fact that there

were more individual requests after January 20, 1944. Those prior to that date included many family members.

Our analysis will be found on the enclosed forms.

In addition to this information we enumerated the respective ages. In that group signing prior to January 20, 1944, the average age was 35 years, which figure was lowered due to the fact there are many family members in the early adolescent years. In that group requesting expatriation or repatriation after January 20, 1944, the average age was found to be 27 years.

We should like to draw your attention to the trend which we believe to be significant and which was not brought by evacuation or segregation. It appears that the coming of selective service to Japanese has definitely increased requests for expatriation and repatriation, many of which we presume would not have been made had they not been subject to military duty. There seems to be quite a bit of feeling on the part of the people dealing with these persons such as members of the local hearing board that the real reason for expatriation on the part of the draft age men is hidden by more acceptable reasons than that of the frank admission of draft evasion, which it would appear, is present in many cases.

Before having advanced this report to you, it was submitted to people on the hearing board, relocation program officers, statistician, and leaves officers who have concurred that this represents a fair cross-section on the matter of repatriation and expatriation. We trust that this meets with your request.

Dear Mr. Stafford:

In laying out my case for your consideration, I sincerely hope that your decision will be in my favor.

I am a 1941 graduate of the University of Washington with a B.S. in Commercial Engineering. In addition to the basic engineering courses, my specialized studies were in production methods and processes.

My greatest interests are in aviation. Up to September 1942, I held private's license #134867. Wearing glasses had disqualified me from taking a CPT course. However, I purchased my own flight time and received ground school training with a CPT group. Staying two extra terms at the University, I studied advanced courses on meteorology and other allied aviation subjects. As of September 1942, I logged nearly 100 hours, mostly on seaplanes.

At the start of the war, I had just begun to attend classes at the Curtiss-Wright Technical Institute in Glendale, Calif.

Having more than sufficient qualifications, I tried to enlist in the Air Corps. Most of my friends from CPT school days were being accepted, but my application came back with - "due to technicalities, we cannot accept your application."

I then tried the Weather Officer's School. This was one branch in which I am thoroughly qualified, having studied the subject intensively. Again, I received a "due to technicality" note.

Soon after that, my father was arrested. Family obligations and government attitude made further attempts impossible.

On April 28, all the Seattle Japanese were evacuated to Puyallup. To say that I was bitter and disillusioned at that time is an understatement. While in this state of mind, I received word that my father was to be interned for the duration. To me that meant that he was to be deported after the war if not sooner.

Therefore, in July, I applied for repatriation. My reasons were many: my father was to be interned. His record for the last thirty years in the United States, not being considered. The treatment I was receiving seemed to prove that I was not considered as a citizen. I was constantly being prevented from even trying to prove my rights to citizenship.

Physically I was a Japanese, that was enough to say that I was a potential fifth columnist or saboteur. I could not defend myself nor prove my loyalty.

Since that time, the government policies has changed. Especially in the past several months, there has been a decided swing in the government's attitude toward us. I began to wonder whether I had acted too hastily. Now, I regret what I had done.

On February 2, the day the Army came to start recruiting volunteers, I received a letter from the Justice Department stating that, in the opinion of the Attorney General, my father should be released to be reunited with his family.

Now, all my reasons for signing repatriation papers have been nullified by the government. My father has been cleared, the Army I know, could use me, but because of my action of last July, I find myself in a very embarrassing position.

I realize that this may be the only chance for the Niseis to prove their worth. This can be the starting point whereby our government will be made to see what great wrong had been done and try to correct this in the future. I believe that a sacrifice of the volunteers is worth the price, when the future of the other 100,000 is at stake.

My request is this: I want my record cleared so that I can join the Army, I want to cancel my repatriation papers. This, I want to take place immediately.

For my part, as soon as I am cleared, I will volunteer for service in the United States Army. I cannot do any more.

Dear Mr. Stafford:

In laying out my case for your consideration, I sincerely hope that your decision will be in my favor.

I am a 1941 graduate of the University of Washington with a B.S. in Commercial Engineering. In addition to the basic engineering courses, my specialized studies were in production methods and processes.

My greatest interests are in aviation. Up to September 1942, I held private's license #134867. Wearing glasses had disqualified me from taking a CPT course. However, I purchased my own flight time and received ground school training with a CPT group. Staying two extra terms at the University, I studied advanced courses on meteorology and other allied aviation subjects. As of September 1942, I logged nearly 100 hours, mostly on seaplanes.

At the start of the war, I had just begun to attend classes at the Curtiss-Wright Technical Institute in Glendale, Calif.

Having more than sufficient qualifications, I tried to enlist in the Air Corps. Most of my friends from CPT school days were being accepted, but my application came back with - "due to technicalities, we cannot accept your application."

I then tried the Weather Officer's School. This was one branch in which I am thoroughly qualified, having studied the subject intensively. Again, I received a "due to technicality" note.

Soon after that my father was arrested. Family obligations and government attitude made further attempts impossible.

On April 28, all the Seattle Japanese were evacuated to Puyallup. To say that I was bitter and disillusioned at that time is a understatement. While in this state of

mind, I received word that my father was to be interned for the duration. To me that meant that he was to be deported after the war if not sooner.

Therefore, in July, I applied for repatriation. My reasons were many: my father was to be interned. His record for the last thirty years in the United States, not being considered. The treatment I was receiving seemed to prove that I was not considered as a citizen. I was constantly being prevented from even trying to prove my rights to citizenship. Physically I was a Japanese, that was enough to say that I was a potential fifth columnist or saboteur. I could not defend myself nor prove my loyalty.

Since that time, the government policies has changed. Especially in the past several months, there has been a decided swing in the government's attitude toward us. I began to wonder whether I had acted too hastily. Now, I regret what I had done.

On February 2, the day the Army came to start recruiting volunteers, I received a letter from the Justice Department stating that, in the opinion of the Attorney General, my father should be released to be re-united with his family.

Now, all my reasons for signing repatriation papers have been nullified by the government. My father has been cleared, the Army I know, could use me, but because of my action of last July, I find myself in a very embarrassing position.

I realize that this may be the only chance for the Niseis to prove their worth. This can be the starting point whereby our government will be made to see what great wrong had been done and try to correct this in the future. I believe that a sacrifice of the volunteers is worth the price, when the future of the other 100,000 is at stake.

My request is this: I want my record cleared so that I can join the Army, I want to cancel my repatriation papers. This, I want to take place immediately.

For my part, as soon as I am cleared, I will volunteer for service in the United States Army. I cannot do any more.
