I have been given to understand that, in a forthcoming book, you examine critically my fieldwork at the Tule Lake Segregation Center. If this is so, then I request that you send me a copy of the relevant portions of your manuscript, so that I may be in a position to evaluate your criticism and respond as might be appropriate. As you may know, I have already published a frank and detailed account of my fieldwork in the early part of my book, Doing Fieldwork: Warnings and Advice, (University of Chicago Press, 1971) which includes a statement of the ethical dilemmas to which I had to respond.

In any case, I would like to complement you on your book, "Years of Infamy". I was particularly interested in your excellent account of what happened at Tule Lake in the latter part of 1945, after I had been forced to leave. And I was deeply moved by Project Director Merritt's account of his talk with Joe Kurihara. It explains a good deal of Mr. Kurihara's behavior at the Tule Lake Center.
