Dear Mr. President:

We would like to add our voices to those many others now being raised to urge the opening of a Second Front.

We Japanese and Japanese-Americans have been evacuated from the only homes that we knew, to be interned for the duration of the war, in the interests of national security. Because of our situation, we regret that we have not been able, as yet, to participate in the war effort of this country in the way of production and combat. As long residents of America and as American citizens, it is our conviction that this people's war must end in a victory of the Allied Nations if we are to insure a permanent peace for the world.

We therefore call for an offensive -- A SECOND FRONT NOW -- for Victory.


Dear Friends:




With reference to your memorandum of July 8, 1942, the following points are approved for release to the "Totalizer."

In accordance with Supplement 8 to the WCCA Operation Manual of the Western Defense Command and Fourth Army, Wartime Civil Control Administration, dated August 1, 1942, and received in this office August 3, 1942, the Center Executive Council and the Center Congress as well as all other activities of the self-governing organization in this Center is hereby declared dissolved.

For your information and guidance the pertinent sub-paragraph of the above Manual is quoted:

A. General

1. No type of self-government organization is authorized in an assembly Center.
2. Advisory committees which have no administrative, executive or judicial power or authority, but which serve as advisers to the Center Manager as hereinafter prescribed are authorized.
3. Immediately upon receipt of these instructions all reference on the part of the administrative staff to evacuee self-government in Assembly Centers will cease. Evacuee organizations constituted contrary to these regulations will be dissolved by the Center Manager immediately. His action will be evidenced in writing and in all cases by letter to evacuee officers concerned.
4. The contents of this entire Section (XXVIII) will be published, posted and disseminated so that all evacuees in each Assembly Center are informed of its contents.

The entire contents of Paragraph XXVIII "Regulations Governing Evacuee Advisory Committee for WCCA Assembly Centers" is being reproduced and will be posted and distributed immediately.

The employment of all assigned evacuee employees in connection with the self-government organization in this Center will be terminated as of the close of business today, August 3, 1942.



We wish to call to your attention again in regards to the books and magazines in Japanese that have been taken up from the residents of this center when the recent search was made for contrabands.

As we have pointed out already, there are among these collections ordinary textbooks, dictionaries, medical books, stories, novels, and books purely on cultural subjects such as flower arrangement and art, that have no bearing on the present international affairs and have no reason for being classified as contrabands.

Since many of the old folks cannot read ~~English at all~~, we feel that the needless deprivation of this sort only hampers our objective of maintaining high morale in our Center sought through other activities such as education and recreation.

It is our understanding that some of the present regulations are imposed upon us as the result of misconduct of the residents of any other center. However, the residents of Tanforan Assembly Center have been very cooperative with the Administrative Staff to date and to our knowledge there have been no outright violations. Under these circumstances, we feel justified in requesting that certain restrictions be adjusted to serve the best purpose of this Center.

Therefore as councilmen, we wish to recommend to you that proper arrangements be made with the WCCA headquarters for investigating these literatures now in your custody and for returning all books that are not objectionable.

In the event that the interpreters are not available from the WCCA headquarters for this purpose, we will gladly assist your administration in providing the competent interpreters from among the residents here.

Although this may seem to be a small matter to you, we are very anxious to have this arrangement made as soon as possible as it will be another contribution to maintaining the high morale at the Center. We will appreciate your immediate attention.

Since Dr. Kitagawa, director of the hospital staff has brought in the problem of providing milk to all residents who really require it and pointed out some discrepancy in the milk distribution, the House Managers have cooperated in making a complete survey of the residents according to the age groups and by the mess hall groups.

Using these figures as a basis, together with an additional information from the hospital and diet kitchen and the education department, we should be able to assist you in ironing out this problem by going direct to the source of these difficulties.

In order to supplement this survey, we would like to obtain the figures from you as to the amount of milk we are receiving at present and how it is distributed; that is, according to mess hall groups, diet kitchen, and education department.

We need your cooperation in solving this problem satisfactorily.

Dear Mr. Fujita:

The members of the Executive Council of the Tanforan Assembly wishes to thank all the House Managers for the excellent work and cooperation in making the extensive survey of our residents according to age groups in order to help solve the problems of proper milk distribution.

Now that we have a concrete picture by mess hall groups, it will help trace down any discrepancy in the milk distribution which seems to be the source of some of the present complaints brought in by Dr. Kitagawa, director of the Hospital Staff.

With the concrete facts of this survey to work on, we can determine whether or not our present milk supply is adequate; and if not, how much more is necessary. Then our recommendations can be made on the basis of the requirement.


It has been brought to my attention that the several men who are working in cooperation with the house managers in delivering packages from the gate to the residents have not been placed on the payroll.



Re: Decision on Preference of Relocation Centers for Research Study.

Gila River Project, WRA is my choice, but there are conditions under which it would be the most favorable for my going there.

1. That my mother and sister be left behind and have the assurance that we can later rejoin each other when we definitely know what physical conditions exist in either center, and rejoin in whichever center that is the most favorable for their health. Having lived in the Bay Region for the greater part of their lives, my mother, sister, and wife have not faced great heat and therefore would not know how they will react to conditions in Gila.
2. That one other family of the study group will go so that we would not be entirely among strangers. This is not a very strong condition to me, but it would make adjustments that much easier. There is the possibility that my wife's family in Santa Anita may be relocated at Gila and in that event this condition would amount to little. *This decision can be waived*

With little facts to go on I still feel that it would be to my best interest to continue the research study at Gila, or for that matter, at any center, but there the study conditions seem to be the most favorable, outside of the heat. The possibility of facing <sup>the isolation of</sup> intellectual and friendly contacts which has stimulated <sup>me</sup> much in the past may be brought to a minimum, and in that case, what little intellect I have will possibly become dormant. This condition will probably offset itself possibly when I make new contacts in the center or develop new outside contacts in the region.
