Dear Mr. Collins,

I am one of the renouncants who are now working at Seabrook Farms and who are not released yet.

I have an American couple for whom I worked when I was in Los Angeles. Now they are in Chester Heights, Pa. - about 20 miles south of Philadelphia.

They have been helping me to get released. They have written two very important letters to Mr. Cooley directly. But unfortunately they learned that their request could not be complied with. So now they think that our release depends much upon the outcome of your case. and they believe that you will win it.

I want to go to their place and study and they also want me to go there and live with them. They have bought a big house in Chester Heights.

Mr. Ramage is working at Philadelphia as an Assistant Supervising Engineer with the Travelers Insurance Company. He served more than five

years in the Pacific was a navy officer, and now holds a rank of Commander on inactive duty.

Now what do you advise them or me so that I can go to this place?

I thank you very much if you kindly give your advice to me or to Mr. Robert S. Ramage, The Engineering Division, The Travelers Insurance Company, Public Ledger Building, Philadelphia, Pa.

Dear Mr. Kaneshiro:

When Mr. Olshausen, Mr. Tamba and Mr. Nakamura were in Seabrook they informed you that the cases have been submitted to Judge St. Sure upon extensive affidavits and briefs and that we are awaiting his decision in order to learn whether or not all of the renunciations are to be set aside. Judge St. Sure has been ill for a number of weeks. We believe that he will return soon and that a decision will be made. We hope that the decision will be favorable to all of the renunciants.

In the meantime the Attorney General refuses to issue releases to the renunciants at Crystal City and to those on relaxed internment at Seabrook Farms and it is likely that he will refuse to do so until the court decides the cases. The only thing that you can do in the meantime is to write to the Attorney General or to Mr. Willard Kelly, Esquire, 1500 Chestnut Street, Philadelphia, Pa., requesting that you be granted a release.
