

Replying to your letter addressed to me under date of March 10th concerning supplementing the maps, which we have heretofore sent you, beg to advise that I think it would probably be more satisfactory to your office to return these maps and have us bring them up to date.

There is one thing that I would like to have clarified before we do so. In the letter addressed to me under date of February 3rd by Mr. Olney he requests that all property which is owned, controlled or occupied by persons of the Japanese race, whether citizens or not, should be marked on the maps in red. The legal definition of the term "occupy" would seem to indicate possession or control. We have instances, however, where the owner of the property lives thereon, farms it himself but permits Japanese contractors, who take care of the labor situation, to occupy a small house or shed on the premises. In other instances we have a situation where the owner farms the property himself but hires five or six Japanese, in some instances husbands and wives and their children. The owner furnishes living quarters for these Japanese laborers and their families. I would like to know what your office means by the word "occupy". Do you mean simply tenants or Japanese occupying the property and farming it on crop share basis, or do you wish us to consider every laborer who lives on the property as an occupant?

This is quite a task inasmuch as we find that the Japanese are not fixed in their abode.

We find them living on one piece of property in one year, or a portion of the year, and on another place at other times. We have been obliged to send out notice to them and request them to call at the office. A number of them have done so and others write back giving insufficient detail. This requires a follow-up system and requires considerable time. However, we have been working at the job constantly and have about reached the position where we can make a final checkup and complete the map.

We would appreciate an answer to this letter at your earliest convenience.

Dear Mr. McDonald:

This will acknowledge receipt of your letter of March 11th relative to the Alien Land Law maps which you have already sent to me.

At the present time all of these maps are in the hands of the federal authorities. We should have them back within the next few days. Just as soon as we receive the maps of your county I will comply with your request and return them to you to enable you to make the additions which you have indicated you would like to make.

So far as locating the Japanese in your county is concerned, I realize that it is difficult, if not impossible, to locate the transient Japanese on the maps. While we are anxious to get the location of all Japanese in your county, I know that such a program has its limitations. Almost every one of the District Attorneys of the State has adopted a different system of locating the Japanese on the map. It seems to me that the best system is to block in on the map as nearly as possible the land which is occupied by Japanese. By the term "occupied" I mean actual possession and control of the land to the extent that the occupant has some vested interest in the land, whether the vested interest be title and fee, leasehold, share-crop or the like. To distinguish the fee-holders from the holders of interest less than fee, I would suggest that you completely fill in, in red, the area held by Japanese in fee and use red lines to indicate the area held by Japanese under less than fee.

Where Japanese are living on lands as tenants for purposes such as laborers having no interest in the real property, it might be well to indicate these people with small red circles. If, however, this is impractical, it is not so essential as to necessitate a lot of extra work. By giving each Japanese in your county a number and placing that number on the map, the persons living at a given place on the map, together with their history, can be readily coordinated.

In filling in or marking any of the vital defense points mentioned by Mr. Olney in his letter, or thought of by you, I would appreciate it if you would use some color of ink or crayon, other than red, so that these points will be readily distinguishable from the marks which are designed to indicate Japanese and their holdings.

It may be that you have followed the scheme above suggested in preparing your map, or on the other hand, you may have adopted some equally meritorious scheme. Since I do not have your map before me and cannot remember just what scheme you did follow, I have taken the liberty of making these suggestions. Please use them only where they seem worthwhile and practical.

I hope that I have given you all the information you need. If, however, I can be of any further help to you in any way, please let me hear from you at your convenience.
