Today has been a sorrowful day for those living in Block #5. Takashi Oda, son of Mr. and Mrs. Sadaichi Oda of 5-9-D, died this morning at 5:00 a.m., after a long illness. Every one available was busy preparing for the Otsuya (awakē) and the funeral service.
