From our records and case files here it seems to me impossible to record these facts other than as follows:

One case of criticism from an evacuee who we were requesting pay a just obligation to another evacuee

Total cases interviewed for the month- - - - - 280

Further analysis of activities are reported on attached list. Many cases involve more than one problem, therefore, the total number of cases enumerated will not balance with the total reported on WRA-241.

We have been successful in moving requisitioned farm machinery to other states by obtaining cooperation of both War Boards, and in this manner assisted in relocation of farmers who would not have been interested in relocating without their equipment.

Our most discouraging problem is the inability of the Transportation Department of the War Relocation Authority to respond to the urgent requests of evacuees to move their personal property to safety after reports of fire, vandalism, and theft.

Collections for evacuees during the month totaled \$12561.69

Continued success has been had with the U. S. D. A. War Board in giving very liberal consideration to evacuees contemplating relocation and allowing them to remove their machinery to other States to establish themselves as farmers. Two large lots consisting of two and three carloads each moved out this month to Utah and Colorado.

In connection with the segregation program, this office had three male evacuee advisers call on each of the 485 families to be moved to Tule Lake Center to advise and inform them on their problems regarding "Hand Baggage", "Checkable Baggage" and "Freight" to be shipped to Tule Lake Center. On September 15, when crating operations were started, these same men with female typist went into the blocks and prepared the forms WRA-156 and continued advise on "checkable baggage" and "hand luggage". The results of this seemed to have been very good to this date.

We, therefore, have agreed to devote more time to this subject and coordinate our efforts to the end that we may encourage more farm families to relocate.

Miss Mary Kinoshita has been promoted to the position held by Miss Nishikawa due to the efficient manner she has handled her work in this office.

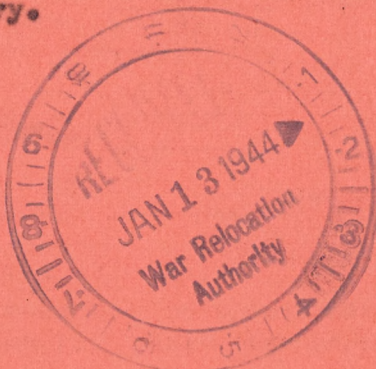
The activities of the Evacuee Property Officer's staff was somewhat curtailed during this month due to several causes. The transfer of this Project from Indian Service to WRA called for some attention to the details of this transfer.

Three days were devoted to painting and reconditioning our offices--this all but brought operations to a stand still.

The unusual number of cases of flu and colds curtailed the activities of members of our staff and retarded the response to calls made on the evacuees. It was also noted that response from the Los Angeles Field Office decreased due to illness of the staff there.

This explanation is offered at this time as it is my belief that with these exceptions the call for work by this office from the evacuees is not on the decline as could be represented by this report.

This is our first report on this revised form which we consider a vast improvement over the old form, however, we were not fully prepared to accumulate the required data in advance to make the report entirely complete. We will attempt to make this report more comprehensive in the future.

The Evacuee Property Officer has been required to devote a large part of his time to planning the expanding of his scope of operations, to prepare for the movement of evacuee property from the project, to accomplish the closing of the project. We have requested approval from civil service for four new appointed personnel in preparing for this work.

Our "Project Memorandum 51-A-Revised" authorizes a well-planned and controlled procedure when inaugurated, and should allow this project to handle the packing, crating and shipping of evacuee property on this project in a very satisfactory manner.

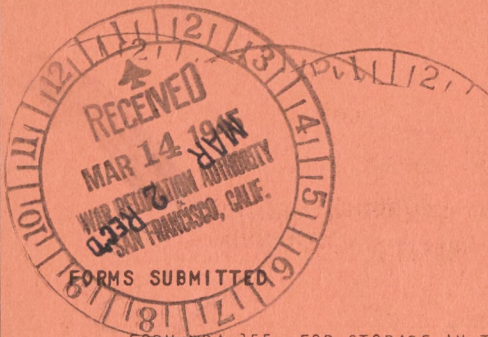

There has been some difficulty experienced in getting evacuee property hauled to Parker due to the labor shortage in the warehousing section. However, there has been no serious accumulation on hand at the close of the month. Preparatory work is well ahead of actual movement of evacuees. There are about 2,000 pre-fabricated boxes on hand as of March 1st.

The Evacuee Property Officer pleads for appointed personnel assistants already authorized, and the authorization of the two additional positions at an early date in order that some time may be allowed to recruit the required personnel.

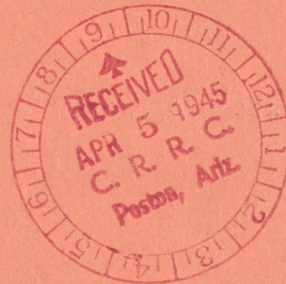


During the month, appointed personnel for the positions of Assistant Evacuee Property Officer and steno-secretary have been filled. The incumbents are well trained for their duties with the result that office organization and general efficiency are greatly improved.

With the continual drain on evacuee personnel as the relocation program progresses, the frequent replacement in key positions is extremely disturbing and difficult for our work. Foreseeing that this situation will steadily become more acute, it is recommended that an appointed position of interviewer be set up immediately. Such position is a very important one since it not only involves interviewing in the matter of moving evacuee property as relocation is made, but also the preparation of Forms 156 (request for transportation) followed by issuance of bills of lading and supervision of handling of other forms and matters relating to such cases. Training of a person for these duties from week to week and month to month cannot be accomplished with the efficiency which is fully required of the Evacuee Property Office.

Five plans have received consideration in de-centralizing the collecting and shipping of outgoing evacuee property. It is believed the plans in each regard will prove most helpful in caring for the needs of the evacuees and for the Center administration.

Shipment of family lots during March almost doubles that of the preceding month. We anticipate that the month of April will far exceed any previous period and we believe our organization is geared to meet any demands which may develop.


The business of this office greatly increased during April over the previous month. However, this increase has manifested itself mostly in movement of evacuee property from the Project to points of relocation and in this report, under the heading of "Warehouse Activity", 148 family lots were shipped during the month.

We anticipate a much heavier movement during the month of May and with this in mind, particular efforts are being put forth to get in readiness to meet the demand. The work of the office is severely handicapped because of shortage of evacuee help, particularly clerk-typists. At this time we are short three clerk-typists and this situation has prevailed during the whole of April. In other words, we have had half the staff formerly provided this office and twice the volume of activity.

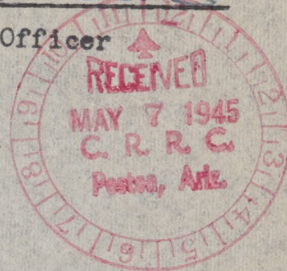
Unless more evacuee help can soon be furnished, arrangement for appointed personnel will be imperative in order to carry the present volume of work and the increase which is just before us. With this problem we are now facing, our duties are heightened because of a similar apparent shortage of clerk-typists in the Warehouse Office where our bills of lading are prepared.

Application for additional appointed personnel, which will largely alleviate the situation mentioned, became effective after the close of the month, but finding fill such positions is a problem.

The movement of freight during the month of June was more than during the previous months and there is expected to be a great increase of business during July, August and September. This expectation is based upon the official announcement from the Director that Camps II and III would be closed as of September 30, 1945.


Contemplating such action, we have effected a de-centralization in handling freight of the three camps by setting up a shipping and receiving station at Camps

The movement of freight during the month of June was considerably more than during the previous months and there is expected to be a great increase of business during the months of July, August and September. This expectation is based upon the official announcement from the Director that Camps II and III would be closed as of September 30, 1945.

Contemplating such action, we have effected a de-centralization in the handling of freight of the three Camps by setting up a shipping and receiving station at both Camp II and Camp III, which functions independently and in the same manner as at Camp I. Furthermore, reorganization calls for preparation of Forms WRA 156 and Government Bills of Lading at the Unit offices of Camps II and III which, when completed are forwarded to the central office at Camp I for approval and accomplishment.

The new set up definitely facilitates the whole operation of moving evacuee property from the Center to points of destination. We are positive that it will further enable us to care for whatever load may be placed upon us by the acceleration of the Relocation program.

The business of the Evacuee Property Section during the month of July was about as usual, except that the volume was considerably greater than in previous months. The movement of freight from the Center has gone along smoothly with no particular problems. During this month, freight going to California points has been sent almost exclusively by Western Truck Lines, while that to eastern sections of the United States has been billed to Universal Carloading and Distributing Company, Inc. This change to Universal from Santa Fe Lines was made because of the door to door delivery service allowed by Universal in country as well as city districts. Freight going to points in Utah, Nevada and New Mexico is sent by Santa Fe Railway, since Universal or Western Truck Lines does not serve those areas.

The problem of evacuee and appointed personnel is becoming more manifest from day to day. Within the month, evacuee clerical help in the main office alone has been reduced from 7 stenographers and clerks to 2 full time and one part time positions filled. With the loss of appointed personnel, 3 authorized positions are now vacant, namely --Assistant Property Officer, steno-clerk and clerk typist. It is imperative that these positions be filled immediately. It is understood, however, that every effort is being made by the Personnel Section to care for the needs respecting both appointed personnel.

The Warehouse promises to become a problem very soon insofar as help is concerned; however, ~~that every effort is being made~~ it is contemplated to employ more laborers in the near future.

As the program of Relocation is accelerated, the volume of clerical work in the main office is correspondingly greater. Almost every evacuee leaving on relocation requires help in adjusting property matters, which cover a wide field. All business relating to unblocking of accounts, insurance, eviction procedure, claims for loss or damage, etc., etc., is handled through this office.
