I think we might better await the final decision of the court of appeals. Because my brother doesn't know English well, so I doubt he might get fail to fill out the sheet right. I don't like to leave him alone here and go back to our old folks in America who are very much waiting for our help & get together again.

The other day we had received two notes one for me \$300, and the other for my bro. \$250. which deducted for donation, from the Tule Lake Defense Committee in Tokyo. So we signed on it & write our addresses where our folks are located - 16940 So. Crenshaw Blvd. Torrance, Cal. and had sent back to Central P.O. Box No. 646. Tokyo. We are very appreciable and happy for your kindness and are waiting for a good address. Thanking you again for your kind notes, we are, sir,
