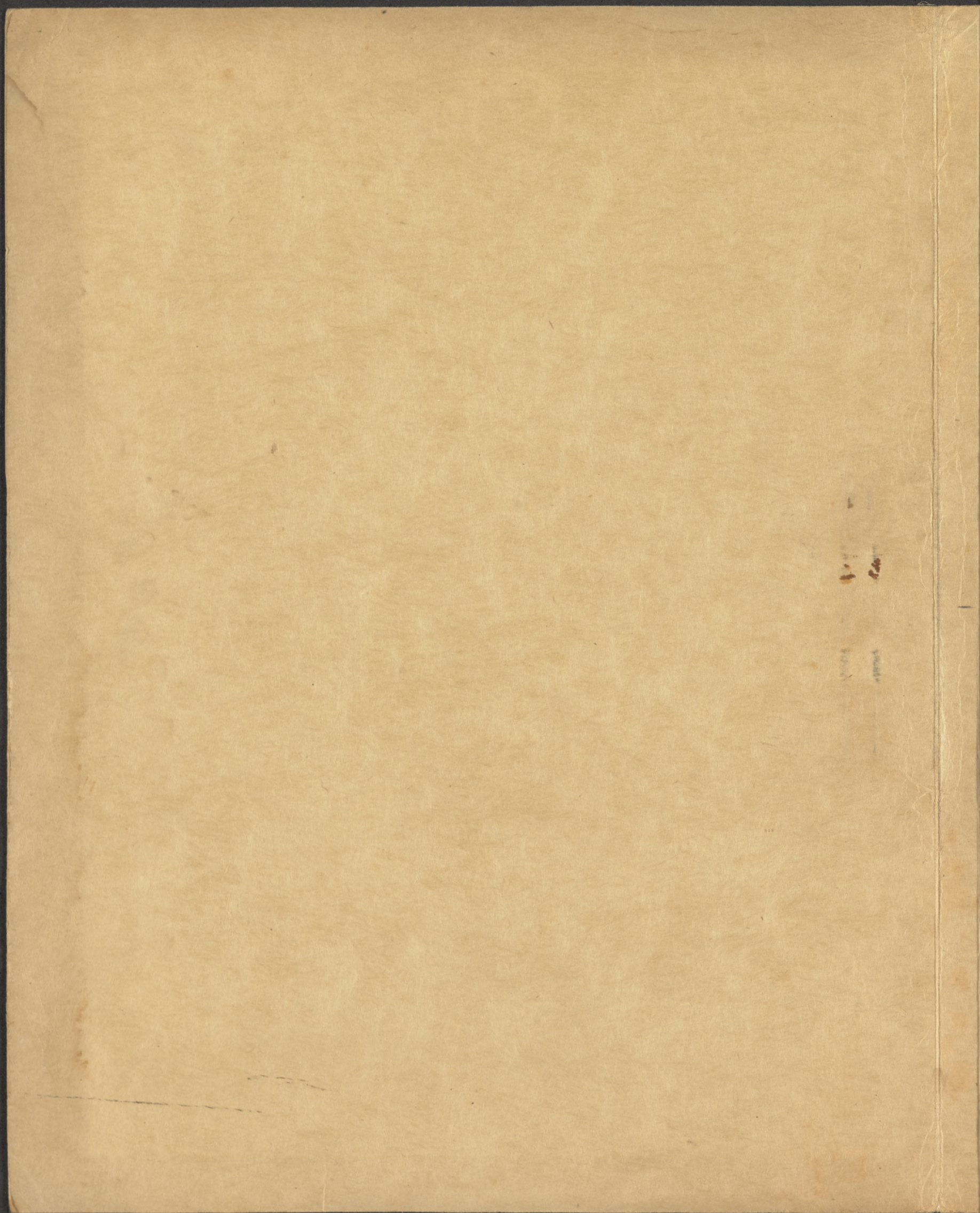

The first meeting of the Junior Class Cabinet was called to order by President Henry Terao in Room 21 at 8:30 p.m.

The purpose of this meeting was to plan ahead for the coming year.

With no further discussion on this matter a new business was brought forth. This was concerning the class beanies and the class pins. Recommendations for chairman of these committees were ask for by the president.

Following a short discussion the cabinet approved to have Harumi Morimune as chairman of the pin committee and Richard Sakurai and Miyeko Abe as co-chairmen for the cap committee.



Business Manager: Harumi Morimune



Middle of May...Junior Assembly


June-last Saturday of school week...Farewell Social

Old business brought up was in regards to the letters to the relocatees. It was decided to send letters to all those who relocated since summer.


A report was given by the president of the last Student Body Council meeting.




Benny Masatani moved that core representatives be re-elected every quarter. This motion passed.



Hisao Yamanishi was unanimously elected as chairman for the ticket committee.


Junior-Senior Prom was the next subject brought up. The following committee chairman were announced by General Chairman Benny Masatani.

Teruo Sonoda was asked to request for the 226 "P.A."


The secretary was asked to send invitation to the Junior Class Cabinets of Unit I and III.
