


Dear Mrs. Kingman: Re By-laws

Despite your admirable desire to have the By-laws brief, I am of the opinion that the document submitted is too much so. In a "voluntary association" such as ours (that is, one not formally incorporated), it is particularly important that the by-laws set up the general framework from the ground up; that they nevertheless provide a flexible machinery (plenty of "mays" instead of "shalls"); and that there ~~is~~ ^{be} a reasonably conservative provision for their amendment.

These features I have tried to incorporate in the enclosed suggestion. Please feel that I have no pride of authorship; I am simply trying to give our Committee the benefit of a long experience in such matters in both corporations for profit and non-profit organizations both voluntary and incorporated. Many features in my draft are responsive to specific troubles that arose and had to be "fixed" by amending by-laws or adding new parts.

I have just been talking to Mrs. Lopez and she told me that you knew of a job for a social worker and immediately I began to wonder what sort it was and if Kay Mano who is at Denson would fit at all. She is not a trained social worker, but is trying to get out to the New York School of Social Work. She has, however, been preparing for social work at the University but has not had her graduate year, and has been working with the social services ever since evacuation, first in the Fresno Center and now at Denson. I think that Mr. Blaisdell knows her. She is a dandy and we are anxious to see her on her way somewhere, although she is not one of our girls. So, just on a chance, I am writing you. She does not have money for graduate work.

We are to have another meeting on Thursday, and this time we are sending out a postal to everyone who seems at all possible. I went to Poston during our vacation, which was early this year, and Mrs. Korngold arrived there just as I left. We have been comparing notes, and came to some of the same conclusions. If Mrs. McLaughlin is not available we shall run the meeting, but I hope that Mrs. McL. will be here. She is to be in town, we know, but we have not heard from her directly yet.

I think that we are about to find us a treasurer, and we will unfreeze the money which lies in the safe in the Methodist Church and send on a contribution to the committee. We hope now to get up some steam ourselves.

We have some good names for the general committee. Would you like them, and like to ask them from there, rather than have us make a list after sounding them out? I think that some would be more apt to respond to an invitation from your end. You are very impressive, you know. I find that there are more people than I had thought who are sympathetic, but some are cagey about getting involved. Perhaps they think we are a bunch of sob sisters, but mostly it is because they are busy at too many other things just now. I just lined up one of our promising lawyers.

Please excuse a hurried note. Have you any suggestions as to profitable things for us to do? For instance, is there any action which seems most pressing? Let us know if and when it is a good time to send letters to our representatives. I ~~am going to~~ send you a copy of a good letter which came from one of our older graduates who is on the outside.

I would not have missed the trip to Poston for anything. I was a wreck when I got home, walked miles and saw so many things and people that I was in a whirl. More people ought to make the effort to visit their friends as they are certainly grateful, and the returns are very great.
