I do not know whether proper steps are being taken to search the baggage of all persons leaving Poston but from a property accountability standpoint such a procedure seems to be logical and reasonable.

Anyone who is not attempting to remove items of Government property from the project would, of course, have no objection to having their baggage searched; on the other hand for the protection of the accountable officer and the Property Custodian such a search would be a prime requirement and of necessity a routine matter.

I will appreciate it if you will discuss this matter with Mr. Kennedy inasmuch as I understand all leave is handled through his office and also with Mr. Reinhardt, Project Property Custodian, with a view to establishing a checking-out process at the earliest possible date.

The following events and problems are hereby noted:


Matters taken up at the Block Managers meeting of April 25, were of routine nature.


At the Block Managers meeting of May 9th election was held for the new members of the Executive Committee, and also the housing committee.

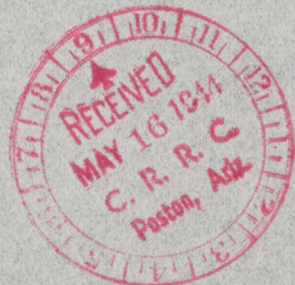

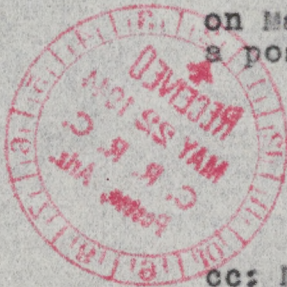
At the Block Managers meeting of May 16,

shows.

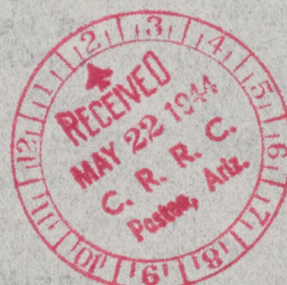
On May 19th the Block Managers Executive

3. Mess Hall workers. (a few blocks)

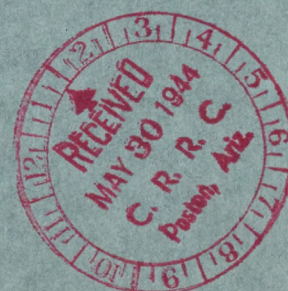
The Local Council held a special meet-

Memorandum to: L. L. Nelson, Unit I Administrator

There are attached hereto copies of the following:

1. Director Myer's letter addressed to all Project Directors dated May 1, regarding the surrendering of food rationing books by administrative personnel.
2. Copy of a memorandum addressed to you dated March 18, from this office regarding the subject.

In an informal discussion of this matter with you, you pointed out that the local Ration Board at Parker had approved allowing these books to be retained by the administrative personnel.

Upon analyzing the Director's letter it seems to me that all administrative personnel, who eat at our messes eight or more meals per week must turn over all War Ration Books since the instructions state that a person who lives in either Group II or III, Institutional Users Establishment (or in a premises maintained in connection with it) for seven consecutive days or more must surrender his War Ration Books.

I believe that we should have a formal clearance from the local Ration Board authorizing the Project to allow the administrative personnel to retain their books. Should it develop that it is desired to collect these books this office still stands ready to have the Chief Steward's office or the Fiscal Division assist in effecting this collection.

A notice was received from the Community Council to the local Council to make a survey of all the quota of each division. The members of this board to be made out of the following:

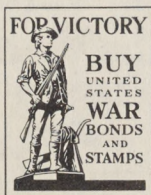

The following problems and events are hereby noted:

For the week ending Dec. 18 everything has been of routine nature. The Block Managers were notified of oil shortage for the coming two weeks and it caused unrest among a few residents. Most of the blocks have started a ration system of one gallon per day to avoid undue hardship.

Clean-up day seemed to be a great success compared to former clean-up days.

The Local Council after a week of investigation and negotiation with various parties concerned took over the scheduling of the Block 4 and 59 stage and assigned it to the Co-ordinator of Community Activities.

Discussion of the method of presenting a request to the Spanish Consul took place and a request from each block (issei residents) was brought to the committee of delegates who drafted the final petition. a copy of which is attached.

Week Ending December 25

Since the business transacted at the Block Managers' meetings has gradually become routine, questions were raised whether to have the meetings every other week. I instructed them that Block Managers' meetings should be held every week whether we had any new business or not in order to keep them together in one group.




December 27, 1943

The plans for the diet kitchen on which I have worked as Chairman of the Council together with the Executive Board are at present temporarily stopped although the opinions of the majority of the residents are for the opening of such a kitchen.

I understand at the staff meeting last week it was decided not to open a new kitchen. As you will recall the translation of the petition to the Spanish Consul requested the opening of such a kitchen. I believe until further decrease in the population such a kitchen should be opened to release the congestion of hospital facilities.

This above outline was in addition to the regular operation and administration of Unit 1.

At the block managers meeting, Mr. Crawford and Mr. Hunter appeared and made a brief talk in regards to the work being done by their department.

An announcement was made by the Health Department to pound all the stray dogs and cats. Registration of all dogs and cats is to start in the near future by the owner.

Mr. Harper, of the Internal Security, appeared and stated that he will enforce the pounding of the stray dogs and cats.




The Block Managers meeting of January 18th was


The following problems and events are hereby noted:


Selection for the recreation hall committee was made and block managers of block 30 and 32 were appointed.

The following problems and events are hereby
noted:

At the regular block managers meeting of February 8, beside routine work, a representative from the evacuee property department made an announcement as to procedure to bring in any property now stored. A report was also made as to the property destroyed by the fire in Camp II, on December 25, 1943.

One representative, was appointed to a committee to receive and distribute shoyu.

A representative was also chosen to conduct memorial services for the servicemen within the Unit.

The local council called a special meeting on February 9, to elect a representative to receive and distribute shoyu etc. This committee met with the Project Director and Dr. Powell, at the Red Cross on Friday February 11, 1944.

The committee for (memorial) funeral service met on Friday with Mr. Nelson and Dr. Powell. The matter was referred to each Local Council to formulate plans and submit to the Community Council.

Members of the Selective Service Advisory Board was appointed, which is composed of Tom Sakai Block Managers Supervisor, Unit Administrator, Tom Sakai from the Local Council, Mr. Hayano of the Education Department, and Mr. Hunter of the Relocation Office.

Monday February 21st, The Community Council called representatives of the three units to schedule a date for the Relocation Team for each of the Units.




The Block Managers meeting of February 29th was short and matters that were taken up were of routine nature.



The situation seemed very serious.

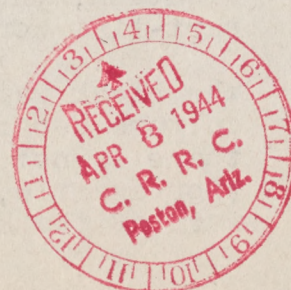
The Block Managers request was presented by the chairman. After full discussion the request was granted.


The Council at its regular meeting held
