## WAR RELOCATION AUTHORITY - WASHINGTON OFFICE

## Functions by Organizational Unit

E2.03

Office of the Director

The Office of the Director of the War Relocation Authority maintains constant liaison with the Secretary of War and appropriate military commanders on all problems of present and potential evacuation from critical military areas. It obtains the cooperation of the Federal Security Agency, Department of Interior, Justice Department, and others in carrying forward many phases of the relocation program. The office establishes basic policies, issues controlling regulations, and directs all activities of the Authority in Washington and in the field.

Office of Finance and Personnel

This office directs the finance, personnel, and property management of the Authority.

It must handle, in addition to the usual administration services of a government agency, the establishment and maintenance of a system of fiscal and administrative management especially designed to meet the complex problems of numerous complete, closed communities of 5,000 to 20,000 evacuees, for whom the government is providing the essentials of life, such as shelter, food, medical attention, education, work clothing, and work opportunities.

This work involves the setting up of budget and accounting systems that conform to established government procedures and that also fit the needs of individual projects; for example, accurate accounts must be kept for each individual as to expenses incurred and credits earned. Experienced technical personnel must be recruited for the varied types of supervisory work required for the successful and frugal operation of a program that encompasses practically all phases of human and economic affairs. Personnel management policies for the Washington, regional, and project offices must be developed within the limits of government standards, but adapted to the peculiar problems prevailing in each project set-up.

Office of the Solicitor

This office provides the necessary legal service and advice to the Director and other officials of the Authority to assure that the program of the Authority is carried on within constitutional and statutory limits and



that full cooperation and understanding regarding the program are maintained between the Authority, the Attorney General of the United States, and the Attorneys General and other officials of the several States where the relocation program is operating or will operate.

In general, the Office of the Solicitor handles all legal problems incident to the planning of the program and the preparation of procedures and regulations to put the program into effect. This work involves legal advice and assistance in project site selection and the acquisition of land; in project organization under Authority regulations, including provisions for the establishment of community government, police and court systems; in developing proper relationships with States on matters of political jurisdiction and law enforcement; in developing policies and procedures for the management or control of evacuees' property; and in determining conditions for proper control of evacuees' activities on relocation areas or while on furlough.

The Office has the responsibility for assisting or acting for the Department of Justice in any litigation that may be brought against the United States as a result of relocation activities of the Authority.

#### Office of Reports and Publications

The OEM Information Division handles press, radio, and related mass-communication essentials for the War Relocation Authority. Hence, the work of the Office of Reports and Publications is restricted to three principal activities: (1) Administrative publications and notices must be provided to all evacuees to enable them to cooperate effectively with the Authority in all phases of the public-work, agricultural, manufacturing, and private-employment programs. The first such publication by the Authority, for example, explained to evacuees the reasons for the establishment of the War Relocation Work Corps, the obligations accepted by enlistees, and the obligations of the government to enlistees. (2) Publications and reports must be prepared for general public distribution, particularly for distribution in the areas where relocation centers are located; each such publication must be handled with full awareness of its international implications. As time goes on, nothing will be more important than the presentation of all the facts surrounding evacuation, including a clear analysis of the Japanese-American population. Otherwise a large number of loyal American citizens of Japanese ancestry are likely to suffer injustices in the face of misunderstandings and a misinformed general public. (3) The evacuation and relocation program, unique in American history, must be documented with care so that there will be basic, authoritative information on this whole movement.

The Washington office functions principally in planning, organizing, and directing the publications and documentation work of the Authority, and



in preparing publications, statements, and reports regarding the program as a whole; it provides directives to the Regional and project offices; it cooperates with the OEM Information Division and numerous other agencies such as OFF, COI, and CIAA.

### Relocating Planning Division

Much of the confusion attending early stages of the West Coast evacuation program resulted from the fact that circumstances made advance planning impossible. The purpose of the Relocation Planning Division is to see to it that adequate preparation for orderly evacuation and relocation will be afforded in any later moves that may become necessary as the war progresses.

The Division keeps fully informed on policies developing in the War Department which may create new responsibilities for the War Relocation Authority. These might involve the designation of new areas to be evacuated, or of new nationality groups to be affected.

The Division maintains liaison with various other agencies of the government to secure whatever information is available on the treatment of American citizens in Axis countries and on how other allied nations are handling Axis citizens and friendly-nation citizens of Axis origin within their borders. Consequently, the work of this Division necessitates close collaboration with officials in the Departments of War, State, and Justice, the Coordinator of Information, the Office of the Coordinator of Inter-American Affairs, and others.

### Manufacturing Division

The Manufacturing Division formulates policies and broad plans for the establishment and operation of manufacturing enterprises on relocation areas to provide useful employment for evacuees and to utilize their labor for the production of articles required by relocated communities. As previously indicated, a third of the evacuee population averages nearly 60 years of age. Another third is under 16 years of age. Consequently, a disproportionately small part of the total population will be able to engage in the type of public work that involves hard physical labor but can nonetheless engage in tasks requiring a great deal of hand work.

The Division will seek to locate industries or enterprises suitable for establishment at relocation centers, and in doing so will maintain



liaison with the War Production Board, the War and Navy Departments, the Department of Labor, and manufacturing research groups, both governmental and private. Plans are being prepared for the production of articles needed at the relocation centers themselves, as work clothing, school furniture, and hospital equipment.

The actual operation of manufacturing enterprises on relocation areas will be under the supervision of the regional and project directors; the Manufacturing Division will serve as a staff service in working out agreements, organizing the enterprises, aiding in procurement of raw materials, and in the distribution of the products.

#### Agricultural Division

The Agricultural Division has technical supervision of the work of evacuees on agricultural projects, including the planning of agricultural production by evacuees, the preparing of lands for planting, and the planting, cultivation, harvesting, processing, and marketing of agricultural crops.

In the inter-mountain region, where most of the projects will be located, agriculture will provide the evacuees with the most immediate and the largest single source of useful employment. Such a large undertaking, which will have an important bearing on the Food for Freedom program, must be carefully planned in cooperation with the United States Department of Agriculture, to assure that the right crops are planted, that they are properly tended, and are utilized most effectively, whether used for food for evacuees, or marketed.

The Washington staff consists of a small technical group which formulates broad policies and plans, cooperates with the Department of Agriculture and with the Department of Interior, and coordinates the agricultural production of the several projects. The administration of agricultural production on relocation areas will be under the direct supervision of the Regional and project directors, operating within policies and instructions issued by the Director of the Authority on advice of the Agricultural Division.

#### Employment Division

The Employment Division formulates programs and policies for the employment of evacuees in useful public and private work. Such employment is necessary to (1) make constructive use of the man-power of the evacuees at a time when the labor resources of the country are vitally needed; (2) to lessen the problems of maintaining order and morale among the evacuees; and (3) to reduce the cost to the government of maintaining this group



for the duration of the war.

To attain these objectives requires a program for development of employment opportunities; it requires the formulation of workable and acceptable policies on wages, hours, and related matters. The provision of work under appropriate safeguards in private employment and in public works outside of the relocation areas is a particular duty of this division, as is the establishment of policies governing wages, hours, working conditions, for evacuees in any and all employment.

Actual negotiation of specific employment opportunities -- such as those for private employment in agriculture recently completed in Oregon, Idaho, and Montana -- are handled by the regional office under policies and instructions issued by the Director of the Authority.

When evacuees engage in private employment at prevailing wages, they are required to pay the government for the support of their dependents who may continue to live at relocation centers. This is necessary to reduce the Federal costs involved; it is also necessary out of fairness to evacuees working on relocation projects because their ultimate earnings will be determined by the difference between costs and income on such projects.

#### Community Management Division

The Community Management Division develops the policies and plans governing the organization of communities at relocation centers, each of which will be faced with much the same problems as a city of 5,000 to 20,000 population.

The Division develops the overall regulations and policies for all community services, such as health, education, police protection, fire-protection, community government, sanitation. It consists of a small staff in Washington that provides technical supervision for community service divisions in the regional and project offices, to which policies, plans, and instructions are transmitted through the orders issued by the Director of the Authority. The Division maintains liaison with and obtains substantial help from all Federal agencies concerned with phases of community management, as the U. S. Public Health Service, the Office of Defense Health and Welfare Service, the Office of Education and the Children's Bureau. It also develops working arrangements with State authorities in such fields as health, education, community management, and public order.



Some phases of community management are going to be difficult to solve. Thus there are not enough Japanese doctors and there is a very serious shortage of Japanese nurses; with the aid of the U. S. Public Health Service means must be found to overcome these deficiencies. There are also very few Japanese school teachers, yet a large part of the evacuee population is of elementary and high school age. Further, evacuees are now being moved to States which do not have a surplus of accredited teachers. Again, the greatest possible responsibility for project government, internal security, and fire-protection must be borne by the evacuees, particularly by the American-citizen evacuees, but wholly new policies and regulations must be developed to make this possible. To keep down the cost to the government, the assistance of private organizations -- such as the Boy Scouts of America, the American Friends Service Committee, the YMCA and YWCA -- must be obtained and channeled in effective directions.

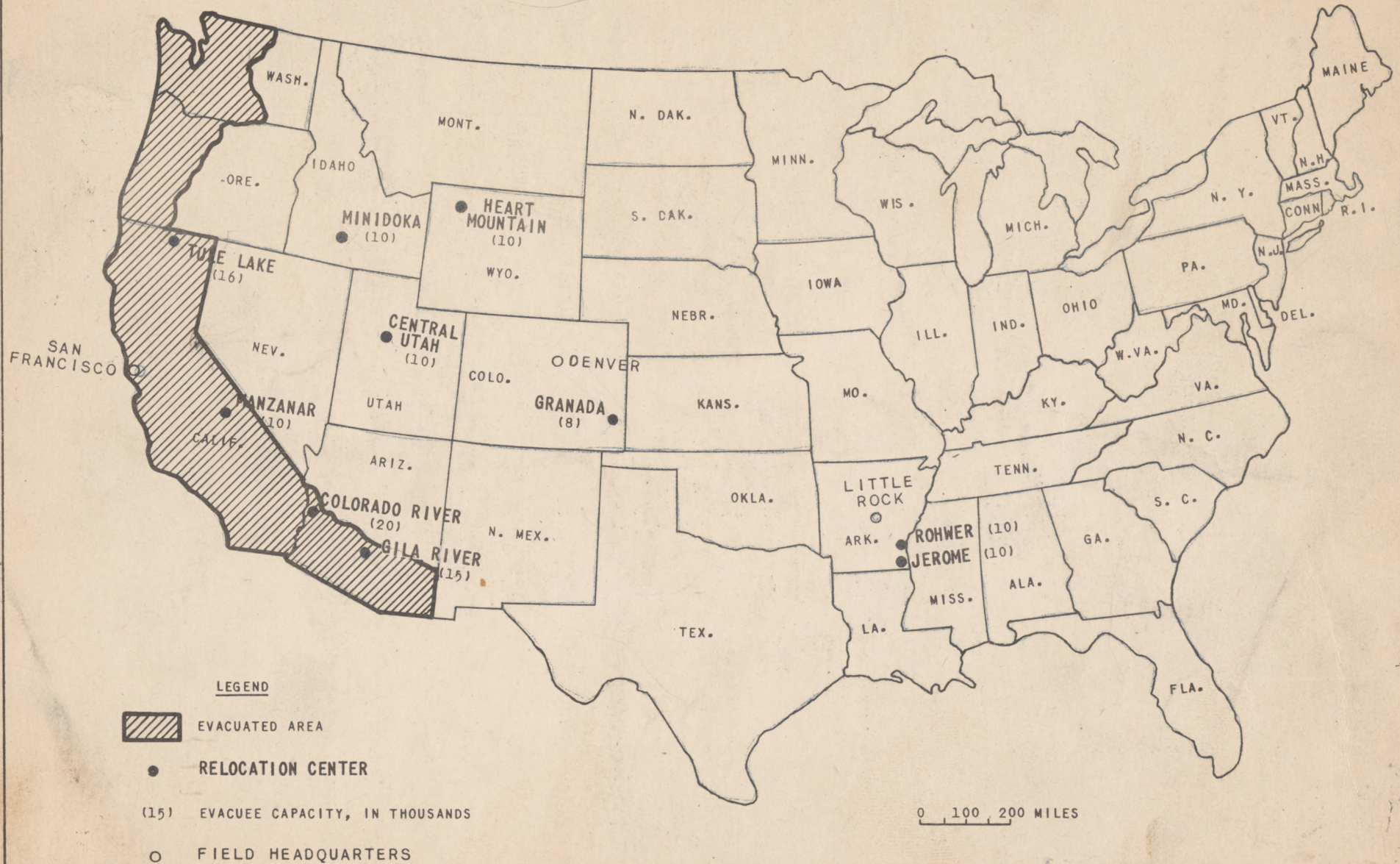

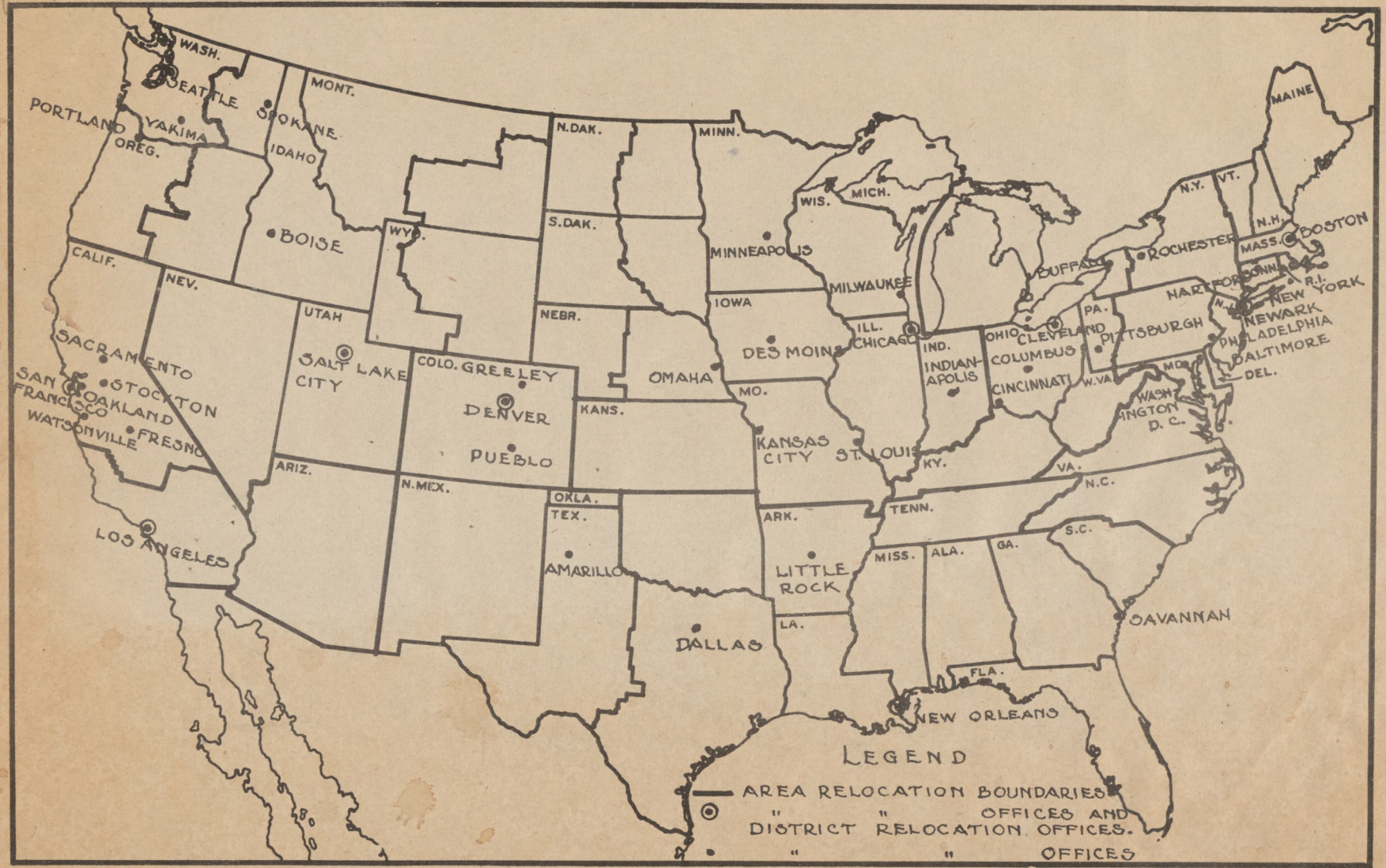

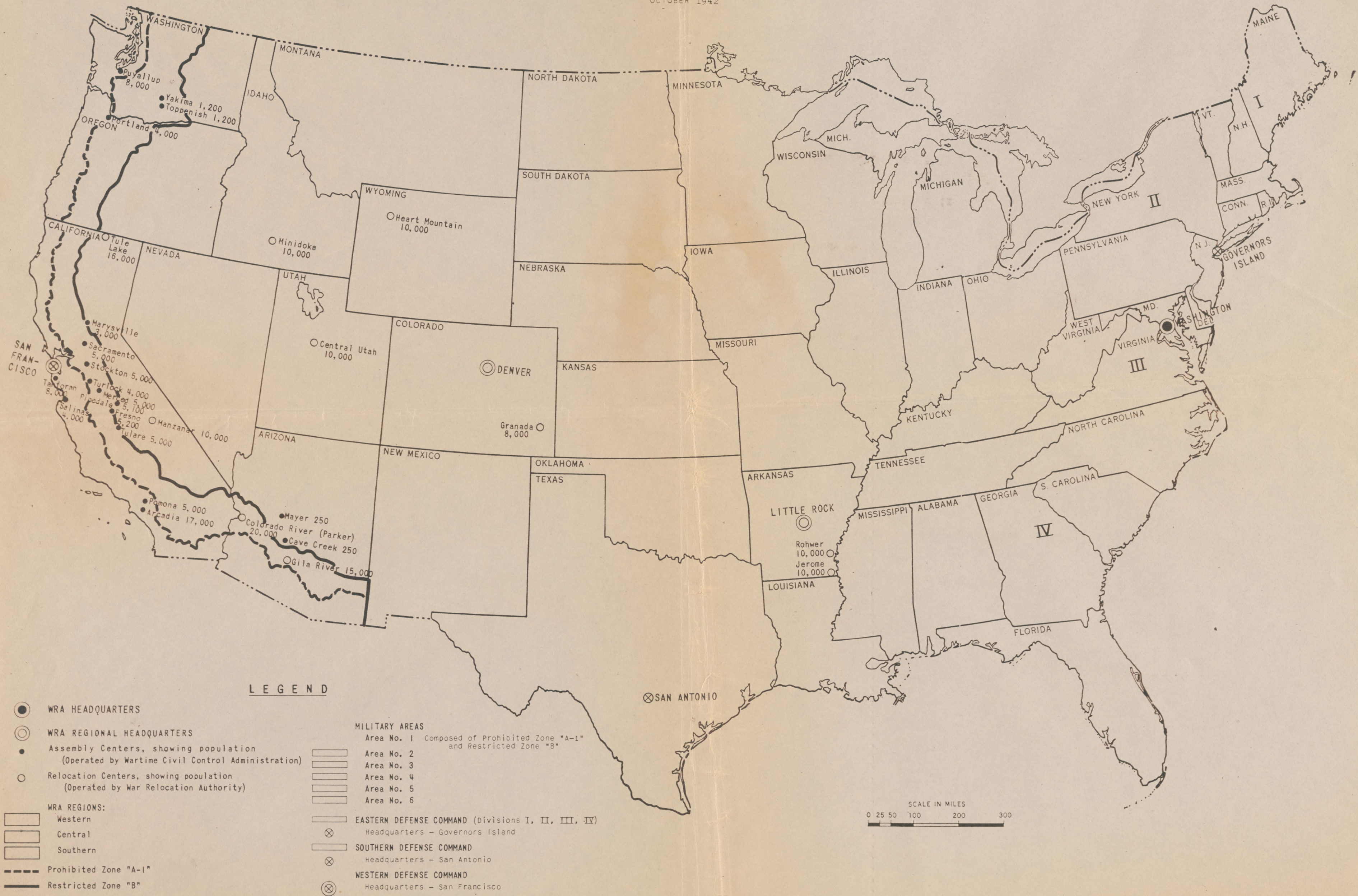
