INTERNED ALIENS MAY BE GRANTED REHEARING FOR RELEASE

According to information received by the Unit II Legal Department, interned aliens are now eligible for a rehearing. The application may be made either by the internee himself, a member of his family or an interested person.

An application may be filed where it is believed that an internee's background indicating his loyalty to this country was not fully presented at his hearing or new and substantial evidence is now available for consideration by the Alien Enemy Hearing Board.

It was specified by E. J. Ennis, Director of The Alien Enemy Control Unit, Dept. of Justice, Washington, D.C., that the application need follow any set form but should present clearly and in sufficient detail the basis for a rehearing.

It was also noted that letters of affidavits attesting to the internee's character, past activities and loyalty to this country; written by reliable persons, should be submitted to the U. S. Attorney in charge of the case.

Further information on this subject and also the name and address of the Attorney in charge of the case may be had by any "proper party" by contacting the Office of Mr. Edward J. Ennis.

NISEI SOLDIERS' FURLOUGH STATUS INTO "MILITARY ZONES" TOLD

Another revision of War Department instructions governing granting of furloughs to soldiers of Japanese ancestry has just been received here from the W. R. A.

It declares that the nisei soldiers may be granted furloughs for purpose of entering states of Washington, Oregon, California and Arizona in cases of:

a) extreme emergency involving serious illness, which will probably result in death of the members of the soldier's immediate family.

b) death of members of the soldier's immediate family.

c) circumstances in which, in the opinion of the Commanders concerned, merit special consideration because of the peculiar features thereof, may be referred to the Commanding General, Western Defense Command for consideration.

SPANISH CONSUL TO REPORT POSTON CENTER PROBLEMS, ACTIVITIES

Senor F. de Amat, Consul of Spain, representing that government, which is the "protective" power for Japanese interests in the United States, arrived last Sat. here to "talk with the enemy alien evacuees" on problems regarding Center activities.

The Consul, who makes the report from all relocation centers, to Spain, made his rounds in Poston, observing various projects.

"CONDITIONS ON THE 'OUTSIDE' DEPLORABLE" CRAWFORDS OBSERVE ON WEEK-END TRIP TO YUMA

Unit II Administrator and Mrs. James D. Crawford were Yuma visitors last Friday and Saturday with their little daughter Nancy.

According to Mr. Crawford, conditions insofar as that particular Arizona city is concerned, were none too bright, especially in regards to food.

"We tramped all day and couldn't find a meat market with beef, pork, chicken nor even turkey for sale. We finally discovered one shop where they had a fish, and another with $\frac{1}{2}$ dozen mutton chops."

Despite the fact that Yuma is situated in a rich truck crop farming area, even vegetables were scarce. And what they do have is poor in quality, he stated.

Such large chain stores as Safeway were very limited in stock. Canned peas and corn were unavailable. The Crawfords were able to purchase only 6 cans of milk, they stated, such goods being sold with a limit. Eggs are a rarity in Yuma and the 5 & 10 stores were practically depleted of their stock.

"We went to about 20 candy shops," said Mr. Crawford, "and we were unable to find any at all. No chocolate bars, no hard (Xmas) candy, no peanuts.

Transportation seems to be a major problem in Arizona as Mr. Crawford revealed that in their first 130 miles of the 150 mile trip to Yuma, they did not encounter a single car.

Housing is another major headache in Yuma and tourists are being hard put to find lodging accommodations.

"All in all," smilingly reported Mr. Crawford, "we're very glad to be back in Poston."

LOW FLYING PLANES ENDANGER LIVES

A low flying U. S. army plane, sweeping down from an easterly direction, reared over the barracks at Poston III barely fifty feet over the roof tops. This happened at 5:32 p.m. last Sunday. Sixteen minutes later, the same plane, a North American Mustang (Apache), returned from the north-east, again skimming over the barracks.

We are loath to bring up this subject but in view of the fact similar low flying over the Colorado River Relocation Center has occurred several times in the past at all three units we feel that attention must be called on the serious endangering of lives--American lives--by what cannot but be considered a reprimandable act of carelessness on the part of the aviators involved.

Whatever the intention of the aviator guilty of low flying over a densely populated community may have been, he succeeded in frightening some residents ill in bed, including a pregnant mother and an aged man suffering from a serious sickness.

Had the aviator crashed, as is always possible, the accident would have resulted in the loss of hundreds of lives as a whole section of barracks probably would have been wiped out by flames from the burning plane. Government property and lives of American citizens in the center would be listed on the loss sheet.

In recognition of the dangers of low flying, there are strict regulations regarding the navigation in the air over cities. It is most important that the aviator or aviators who are guilty of skimming their planes over the barracks should be informed of these regulations. It should be made known that Poston is the third largest city in the state of Arizona. It should be made known that American property and American lives are endangered.

Proper authorities on the administrative staff of our relocation project should take necessary steps to prevent the repetition of low flying over the barracks. If such type of stunt flying is necessary to the training of a pilot, let it be practiced in the uninhabited and open spaces of the desert....K.H.

"CONDITIONS ON THE 'OUTSIDE' DEPLORABLE" CRAWFORDS OBSERVE ON WEEK-END TRIP TO YUMA.

Unit II Administrator and Mrs. James D. Crawford were Yuma visitors last Friday and Saturday with their little daughter Nancy.

According to Mr. Crawford, conditions insofar as that particular Arizona city is concerned, were none too bright, especially in regards to food.

"We tramped all day and couldn't find a meat market with beef, pork, chicken nor even turkey for sale. We finally discovered one shop where they had a fish, and another with 1/2 dozen mutton chops."

Despite the fact that Yuma is situated in a rich truck crop farming area, even vegetables were scarce. And what they do have is poor in quality, he stated.

Such large chain stores as Safeway were very limited in stock. Canned peas and corn were unavailable. The Crawfords were able to purchase only 6 cans of milk, they stated, such goods being sold with a limit. Eggs are a rarity in Yuma and the 5 & 10 stores were practically depleted of their stock.

"We went to about 20 candy shops," said Mr. Crawford, "and we were unable to find any at all. No chocolate bars, no hard (Xmas) candy, no peanuts.

Transportation seems to be a major problem in Arizona as Mr. Crawford revealed that in their first 130 miles of the 150 mile trip to Yuma, they did not encounter a single car.

Housing is another major headache in Yuma and tourists are being hard put to find lodging accommodations.

"All in all," smilingly reported Mr. Crawford, "we're very glad to be back in poston."

"We inspected the Army quartermaster market center in Los Angeles, where Poston receives her foodstuffs. We are working hard to get more adequate food for this large center."

"The outstanding accomplishment during the Conference was the standardizing of food commodities to all Centers, to distribute equally in allotted amount."

It was reported in the meeting that local officials were "pleased with the cooperation" received from the evacuees' subsistence departments in various Relocation Centers.


We had been "lead to believe" that eventually we may have a printed publication, like those of the Manzanar or the Heart Mountain numbers.

SCHOOL PROJECT W.R.A.

"By next October students of Poston can expect to get their education in a classroom as modern as any in America," stated Charles A. Popkins, head of Const. Dept. The schools for Unit I, 2, and 3 will cost in the neighborhood of half-million dollars. 52 pages of blueprint paper were necessary to cover the complete plans.

All the class building will be made of adobe bricks, with the north wall mostly of glass. They will be 22' wide and 145' long, will have asphalt floors. Each building will have a boys and girls washroom. A 10 ft. high standing to give protection from the weather will connect all class buildings.

The Unit I, high school will be situated on the west end. It will have 15 class buildings, one administration, 1 library, and a auditorium with a seating capacity of 1200. Directly north of the school will be the teachers quarters with 8 four-room cottages and a small large club room.

The Unit I elementary school will be located on the firebreak directly west of Blk. 30. It will have 10 buildings, 1 administration, 1 library, and an assembly hall with a capacity of 800.

In Units 2, and 3 the elementary and high school will be incorporated into one large school. Both of them will be built in the west end of the units. They will have 12 class buildings, 1 administration, and 1 library, and a auditorium with a capacity of 950.

In eight fields of study, 64 subjects are offered by the Institute through the correspondence courses.


In cooperation with 78 colleges and university extension courses for academic credit. The function of the Army Institute is to provide specialized training to students.

Although the initial planting of cucumber in the areas bordering Blk. 18 has been considered "a failure" in the sense of equal distribution to each mess hall, due to the lack of cooperation from the local residents, whom without heed, availed themselves in picking the cucumbers, curtailing abundant delivery to all kitchens, Super. 

pushed to the background by a flurry of activities on other fronts, the widely acclaimed co-operative movement at the Colorado River Relocation Center appears to be an almost forgotten thing, but new information can be disclosed now.

The WRA has under consideration an outline plan "to be considered in the organization of a Consumer's Cooperative Association in relocation centers."

Space will not permit even a near complete discussion of the proposals being made, but it is interesting to bring to light one of the "suggestions" listed in the outline plan.

Section III, sub "A" lists several principles under which the cooperative must function. Paragraphs 4 and 5 state:

"Goods purchased by the Association for its members will be sold to them at prevailing market prices and for cash.

"...all surplus resulting from membership patronage will be paid back to the members in proportion to the amount of patronage they gave the community store operated by the Association."

It also is recommended that profits are not used for recreational equipment, community welfare or other purposes not directly connected with the business venture.

The above information which is being passed on without comment is no doubt of interest to many residents who will be affected in one way or another.

Following the administering of oaths, Mr. W. Wade Head gave a brief talk in which he said that the Council must at all times work for the benefit of the people in order to be successful.

CHARCOAL MAY BE BIG POSTON INDUSTRY; EXPERIMENT UNDERWAY

Poston may soon boast of an extensive charcoal industry, it was revealed yesterday by Eckford Sakaguchi, general manager of the Unit II Ind. Dept.

Inquiries made with the U.S. Department of Agriculture reportedly disclosed "good possibilities for marketing coal on the "outside" principally in Calif.

The project is now on an experimental basis in the subjugation areas, it was said yesterday. Mesquite wood has been found to be very satisfactory in tests made to date, and plans are now being considered as to the feasibility of producing charcoal on a greater basis.

ICE CREAM MACHINERY EXPECTED SOON IN UNIT II

Local residents may anticipate consumption of Poston-made ice cream in the very near future.

According to a statement issued by Eckford Sakaguchi, general manager of the Unit II Industries Division, and John Nakamura, chairman of the Unit II Council Committee on Industries, machinery for the ice cream plant is scheduled to arrive here next week and production of "our favorite dish" is expected shortly thereafter.

Unit II will be the center of operations for all three units. Approximately 800 gallons per day is expected to be produced by the plant. Eight workers will be hired with the selection of the manager for the ice cream plant yet to be chosen.

The manufacturing plant will be located in the laundry room of Block 202. The machinery is being rented from the Harold Brokerage of Los Angeles on a per gallon royalty basis. With the Brokerage firm to furnish the dry mix, it was also announced that varied flavors will be manufactured.

Other members of the Council Industry Committee include Cow Wada and S. Nakai of 213 and Masuda of 227.



"MADE IN POSTON" CHARCOAL, ARTIFICIAL FLOWER PRODUCTIONS UNDERWAY

With charcoal production next in line, the Industry Dept. today is forging ahead with great anticipation with "Made in Poston" trade mark in the progress of industrial program promoted by the department.

An experimental kiln is constructed southwest of Blk. 59 with 20 kilns to be constructed, each with 1 ton capacity and with a required time of 4 days for the process.

Kazuhiko Nakamoto, charcoal div. head, assisted by Harada and Ishihara, specialists in the project, are in charge of the production.

The dept. in the immediate future will add another commodity to their ever-growing list of "Made in Poston" with the production of artificial wedding bouquets, corsages of gardenias, roses and orchids which are under the supervision of Mrs. Chino, Blk. 43.

REPATRIATION PROCEDURE NOW HANDLED THROUGH WRA SPANISH EMBASSY DIRECTS JAPANESE INTERESTS

The operating responsibilities formerly handled by the W.C.C.A. in regards to repatriation have been transferred to the War Relocation Authority. This change became effective November 15, according to WRA Administrative Instruction No. 65 which explains in detail the repatriation and exchange of Japanese.

Negotiations with Japan regarding repatriation are handled by the U. S. State Dept., which deals with the Swiss Gov't as the Protecting Power for United States interest in Japan, and with the Spanish Gov't as the Protecting Power for Japanese interests in the United States.

In accomplishing the exchange, Japanese repatriates are placed aboard the exchange vessel in New York and it proceeds to the exchange point (Lourenco Marques, Portuguese E. Africa) where it is met by a boat from Japan bearing American repatriates. The Portuguese Gov't is responsible for insuring the transfer of the Nationals of the 2 hostile powers at Lourenco Marques.

The WRA is working in close cooperation with the State Dept. in matters concerning repatriation. All Project Directors are responsible for accomplishing or expediting all phases of repatriation in relocation centers.

Any person of Japanese ancestry may file application for repatriation. Such applicants may also send a letter to the Spanish Embassy at Washington, D.C., informing them asking to be repatriated. In general, persons requested by the Japanese Gov't. thru

its Spanish representative and desiring to return have priority over those not named by the Japanese Gov't, even tho they have filed a request for repatriation with WCCA, WRA or the State Dept.

Further information concerning repatriation may be had at your legal department or by corresponding with the Spanish Embassy in Washington, D. C.

NOTICE OF ASSIGNMENT FORMS TO BE ISSUED ALL WORKERS

The Employment Bureaus of Poston have been directed by Vernon R. Kennedy, head of Industrial Relations to issue notice of assignment slips to all workers.

These forms when completed will be in five copies to be forwarded to Timekeeping, Social Welfare, Employment, the department in which the individual works, and to the individual worker.

Persons working without referral cards are advised to appear for an interview at the Employment Office as soon as possible.

In case of promotion or release, it has been suggested that the respective department heads notify the employment office. Such cooperation will facilitate the filling of forms.

215 scoring was kept to a minimum as the Terrorette defense allowed them to score but 2 points a half while the 213 offense hit the hoop consistently to win easily.





