Enclosed find eight copies of each of two sets of lists of the plaintiffs in the above-entitled causes who are in Japan. Three copies of each of the sets are intended for your office and five copies of each of the sets are intended for the Passport Division of the State Department.

One set contains the names of such plaintiffs in alphabetical order and their birthdates, except where the latter are lacking in my files. The other set contains their names, birthdates and their addresses in Japan. Inasmuch as a number of these plaintiffs move from time to time the addresses must be viewed as being the last addresses made known to me.

I shall be grateful if you, following our understanding, will be kind enough to cause five copies of each of the sets to be certified as lists of plaintiffs in the above-entitled causes whose cases still are pending before the district court and send the same to the Passport Division of the State Department in Washington, D.C., so that office can forward copies of each of the two sets to our Consuls at Tokyo, Yokohama and Kobe to facilitate the issuance of certificates of identity to those of the plaintiffs whose names are on the lists so that, if they be so inclined, they may return to the United States for hearing purposes. I shall not notify such plaintiffs to apply for such certificates until the lists are received by our Consuls in Japan.

My dear Mr. Burger:

Reference is made to Mr. Collins' letter of August 7, 1953 to the Attorney General and to a discussion with Mr. Grumbly of your office regarding the civil action entitled: "Abo et al., v. Brownell, etc. et al., Nos. 25294-5, USDC, Northern District of California, Southern Division", your file No. 93-1-1320.

It appears that Mr. Collins desires to obtain certificates of identity for the plaintiffs in the Abo case who are residing in Japan and for this purpose has furnished various lists of plaintiffs who are presently residing in Japan. This matter was discussed with Mr. Collins in this office some time ago and he was informed that the various Consular Officers in Japan would accept and process applications for certificates of identity filed by bona fide plaintiffs in the Abo suit but that such applications would have to be filed in accordance with the statute and relevant regulations, and that no guarantee could be given that all such plaintiffs would be issued certificates of identity as a matter of course.

This office will forward copies of the lists furnished by Mr. Collins after your office has checked them for accuracy to the Consular Offices at Kobe, Yokohama, Fukuoka, and Tokyo. It is understood, of course, that these lists will be used merely as evidence that the persons named therein are actually bona fide plaintiffs in the Abo civil action. No effort will be made by the various Consular Offices to invite, or otherwise urge, the plaintiffs to file applications.

As your office is aware, under the provisions of 22 CFR 50.20 the American Consular Office is required to conduct an "independent" investigation in each case to determine whether the applicant's claim

to United States

to United States nationality is made in good faith and has substantial basis, as provided in the statute. This investigation generally includes the bona fides of any allegations of duress contained in the complaint or other allegations bearing on the applicant's claim to United States nationality, as well as a check of the applicant's activities during his foreign residence to determine whether any other acts of expatriation have occurred. Any suggestions which your office may desire to make regarding points to be covered in the independent investigation in renunciant cases will be given consideration by this office.

It is believed that your office may wish to consider the advisability of informing Mr. Collins that the provisions of Section 50.20 must be complied with in each case and that the necessary investigation will take some period of time to complete. The period of time depends, of course, upon the complexity of the case. It may also be desirable to notify Mr. Collins that the influx of applications for certificates of identity will be governed by the facilities and the operating staff of the various consular posts and, consequently, if at a given post a huge number of applicants appear at one time they will be given appointments to appear in the future to file applications according to the appointment schedule of that particular post. Every effort will be made to expedite the processing of applications as rapidly as possible but no special privileges or procedures can be accorded the plaintiffs in the Abo civil action.



In the designations filed in the above entitled proceedings on Feb. 25, 1949, in Furuya v. Clark, No. 25295-G, the defendants asserted that they had documentary evidence showing that the following thirteen persons were members of a pro-Japanese organization at Tule Lake, and that after they renounced citizenship at Tule Lake they voluntarily returned to Japan.

My records show that none of said persons returned to Japan but ever have remained in the United States. My records do not reflect that any of said persons was a member of any pro-Japanese organization with the possible exception of Tamotsu Kobata, Hatsuko Sakamoto and Kimi Tabata, whose membership or non-membership in any such organization has not yet been ascertained by me with certainty.

I would be grateful, therefore, if you would review those records and inform me whether they have been erroneously designated in the above respects, and also inform me of what responses they gave to Question 28.
