We have had 42 inquiries about public assistance, 31 inquiries about clothing, 10 inquiries about declinations, 34 inquiries a bout notary services, 13 inquiries about repatriation, 21 inquiries about outside employment, 5 inquiries about special transfer, 1 inquiry about marital problems, 8 inquiries on student relocation, and 31 inquiries on miscellaneous items.

1. Request Project Director to use all his power to provide Center with shade trees and recommend that this matter be given early attention inasmuch as the end of the dormant season for deciduous trees is nearly over.
2. Council go on record opposing granting of permits to any groups or individuals to offer for sale, any merchandise directly to people of this Center except through regular channels.
3. That Project Director do all in his power to facilitate standard recognition of the Community Hospital and also the Public Schools in order that proper student credit may be obtained.
4. That the Medical Department, so far as possible, complete a physical check-up of all personnel employed where they might endanger the health of the community.
5. Council go on record, recommending that Councilmen be put on the payroll, retroactive to January 1, 1943.
6. Recommend to proper authorities that concrete walks be provided at entrance and exits of mess halls where necessary, for sanitary purposes.

The trend of an increased caseload in public assistance continues. The increase in June as against May was greater than previous gains. The reasons for this can be found in the number of workers who do seasonal labor on a contract basis leaving their families here and need of aid. Toward the end of June also, for the first time on this project some employable workers were unable to receive job. This will be increased in July due to general reduction in personnel. With regard to the new Probation Department of the Welfare Section only one new case of delinquency came up during the month. It is probably too early to say that the Guidance Council and Probation Department have succeeded in decreasing the delinquency rate. An increase can be looked for during the summer with the closing of the regular school term. Assistance for resettlement first granted in May \$32,000.00 increased in June to \$42,233.98.


