Telephone Call from Mr. D. S. Myer, National Director, WRA
to W. E. Rawlings, Act. Project Director
2:30 p.m. - October 12, 1945

Myer: I just read over Barrett's report of October 7 to Ed Ferguson, and I wanted to talk to you about one or two questions involved there.

First, I notice he said there were still 261 people who had not scheduled themselves to go anywhere.

Rawlings: The last check I had was a couple of days ago, and it was 122.

Myer: Are you still picking people up with I.S.?

Rawlings: Not very much. We have to get one once in a while. We got some cases out today on whom we had served 3-day notices, about 40. We had advised them this was their day to leave. When we went down to transport them to the bus, they were all ready to go except one old bachelor, who hid out. I.S. will try to find him and help him out the gate.

Myer: I wonder why it isn't possibly simply to serve notice to all these people they they have to have their plans ready by a certain date, and if not plans are being drawn up for them. Just give notices to everybody.

Rawlings: We haven't yet, but it was our plan to do that Monday. We are rechecking with our interviewers to get complete and accurate list of the people who have not made plans. Our idea was to schedule those then on Monday.

Myer: If you have many more of these cases to pick up, instead of sending I.S. and Barrett down first, send counselors. Use I.S. only in the case of persons who hide out or who are adamant.

Rawlings: Our program is like this, Mr. Myer. We have stopped interviewing people to try to get a date set, on these 120 or so who have not made plans. Our interviewers are spending time helping people who have set a date to be ready to go on the date which they have set. They are doing that on ~~EE~~ everybody. The I.S. are now going after the people the interviewers can't do anything with.

Myer: My only thought is this. Your interviewers have been assigned certain groups and certain people haven't they?

Rawlings: Yes. That's right.

Myer: Even though you have had to give people a date, send the interviewers down to get them rather than I.S.

Rawlings: That is what we did on this group today, and it worked out very nicely.

Myer: I think that is what you should do rather than send the police after everyone.

Rawlings: We have used the police on the few tough cases. This large group was handled by interviewers.

Myer: I would use I.S. only on the tough cases. You have about 120 left then who haven't made plans?

Rawlings: That was the last figure I had. We are rechecking that. We are asking the interviewers to give us an ~~XXX~~ up-to-date, accurate list for Monday.

Myer: The next question was about the Masunaga family. That is the family where there are two girls scheduled as renunciants. They have a mother and father there. Are there other family members?

Rawlings: They have one brother at Santa Fe.

Myer: Do the old folks want to go with the girls?

Rawlings: They want to stay together. The girls are appealing and asking that their renunciation be disregarded. I don't know whether you have received that or not.

Myer: I have not gotten that, but as long as they have renounced it won't do any good. I am getting in touch with Justice to get them moved to internment camp. Do the old folks want to go with them.

Rawlings: If they could go into the internment camp they might want to go with them.

Myer: If they went to Crystal City they would have to be accepted as voluntary internees. I think that is where the girls are going. I am not sure of that, but I don't think they have any other place for single girls. If you want me to I will take this up as a special case and ask if the parents can go along.

Rawlings: They were in here the other day, the mother and one of the girls. They were interested, of course, in their appeal. They had not heard from that. We asked them what the parents would do when the girls were taken away. They have decided they would like to be together here as long as the girls were left, then the parents would go back to their home in Tacoma.

Myer: Do you think they feel all right about that?

Rawlings: Apparently they had about agreed to that. We did not give them any encouragement on going with the girls because we did not know that it was possible.

Myer: I don't know that it is possible. We have not gotten a decision from Justice. If you think it will help your situation there, on morale, and with that family, I will take it up as a special case. Have you any other problems?

Rawlings: I don't think we have any problem other than to get these four women out that we have ~~asked~~ been asked to hold. What about the two women other than the Masunaga girls?

Myer: Are they wives of renunciants, or relatives?

Rawlings: I am not just sure about that.

Myer: I may have that information here, but am not sure about it at the moment. We have told Justice that we want all those people moved before the centers are closed. They are supposed to get some relief from Crystal City. We have not had final notice yet. I think I am going to get in touch with them on these cases. Just to be sure about the facts, I would like to know about the other two girls, their family members, whether they are single women or wives of young renunciants.

Rawlings: Do you want us to indicate to the Masunaga parents that it may be possible they are going?

Myer: I just wondered if you had a plan worked out. They should not plan on it, but we will take the matter up if you want us to. Are you going to let them stay with the girls or are they going on the 16th.

Rawlings: No we changed that. We agreed to let them stay until the girls left.

Myer: That's fine. You say nothing to the parents about it. If you think it advisable, I will inquire off the record whether it would be possible for them to go. I will let you know, and then you can put it up to them.

Myer: What is your general status there now?

Rawlings: It looks pretty good. As far as we can see now we will be cleaned up the week of the 22nd.

Myer: Have you most of your problem cases cleaned up other than this group?

Rawlings: We are starting on the repatriates next Tuesday. We feel that will be the worst group.

Myer: You have cleaned up all those parolees you talked about?

Rawlings: We have that cleaned up.

Myer: What about Welfare cases.

Rawlings: Welfare cases are in good shape. We have 52 ~~XXXXXX~~ summaries out that have not been approved.

Myer: What are you going to do about those 52 cases. Are you going to get approval in time to move them?

Rawlings: I am not sure about ~~MM~~ that. We are doing everything we can. We may come up with a few that are not approved.

Myer: I think you had better start working with Harold on that. Tell them you want to move them into the county of legal settlement, and let them stay there until they get approval. In California they have assured us they will take care of cases for 60 days until they can work out approval with the State Department. See if you can work out something like that with Harold.

Rawlings: He has asked us to hold off on that until the 20th. You think we ought to have some sort of temporary arrangements.

Myer: Yes, WRA would not be footing the bill. Move them into the county someplace until they can work out a plan with the State Department.

Rawlings: We are anxious not to have them here.

Myer: I don't want you to have them there.

Rawlings: It looks like now in the regular course of relocation that we would clean up here to not more than 75-100 people after our movement on the 23rd. We would like to schedule a car of two cars or whatever it takes. We would like to have a final round-up.

Myer: If they are all going to the same destination that is all right. I see no objection to that, assuming they are all going the same direction.

Rawlings: There might be one or two going in other directions. But in other words, fix it so everyone left over would be scheduled out.

Myer: That will be in the last week anyway won't it.

Rawlings: That will be in the last week. I would like to do it a day or so before the end of the month.

Myer: All I want you to do is use all the persuasion possible. Don't use the police except where absolutely necessary.

Rawlings: All right. We will do that. We are getting down now to where some of these situations get kind of nasty. We don't object to that if we are supposed to go ahead and close the camp.

Myer: That is what I want you to do. If you feel you have some real hardship cases, split families because of internment, and so forth; write it up, send it in and we will work it out, as on the Masunaga family, to see if we can get some decision, if it involves the Justice Department.

This is to certify that the undersigned, Project Attorney of the Minidoka Relocation Center, War Relocation Authority, Hunt, Idaho, has been requested by the American Red Cross to investigate the soldier dependency status of Mrs. Chika Nakashima.

Soldier, Pvt. Sam Isamu Nakashima, A.S.N. 39931281, age 29, Co. D., 198th Bn., 76 Regt., Camp Joseph T. Robinson, Arkansas, supported the family prior to its evacuation from Sacramento, California.

The family lived on a farm at Box 545, Route 2, Sacramento, California. Soldier's father is not living. There is no independent income and no means of support for the family known to affiant now that the Minidoka Relocation Center is closing on November 1, 1945. The family of this soldier is scheduled for departure, as are all other residents of the Center, and dates of departure are spread over the remaining few weeks of the Center. No preference is given in the scheduling of departures for the dependent families of soldiers in the Army, and no exception is made in favor of dependents as to the final closing date November 1, 1945.

The family members of the soldier are:

- (1) Mother, Mrs. Chika Nakashima, F.N. 28154, 7-3-B, Minidoka Relocation Center, Hunt, Idaho.
- (2) Brother, James Noboru Nakashima, age 15, same address.
- (3) Brother, George Hiroshi Nakashima, age 15, same address.
- (4) Sister, Mrs. Kinuyo Fukushima, Manzanar Relocation Center, Manzanar, California.
- (5) Sister, Mrs. Helen Tsuchida, Minidoka Relocation Center, Hunt, Idaho.
- (6) Brother, Harry Nakashima, married, no children, migratory farm worker, W.P.A., Pocatello, Idaho.
- (7) Brother, Shigeru Nakashima, age 21, soldier, A.S.N. 39932116, Co. A., 100th Bn., 442nd Infantry, A.P.O. 464, c/o Postmaster, New York, N. Y.

Investigation has developed the fact that the Nakashima family, prior to evacuation, operated their farm under lease. The lease expired during evacuation from California and their farm equipment, agricultural implements, furniture and personal belongings were stolen, ruined through vandalism or exposed to the weather and represents a complete loss.

Interview with the local family members discloses the fact that of the persons named above, numbers (1), (2), and (3) are dependent for maintenance upon the soldier when the family relocates in a few weeks from this Center.
