Dear Miss Uchida,

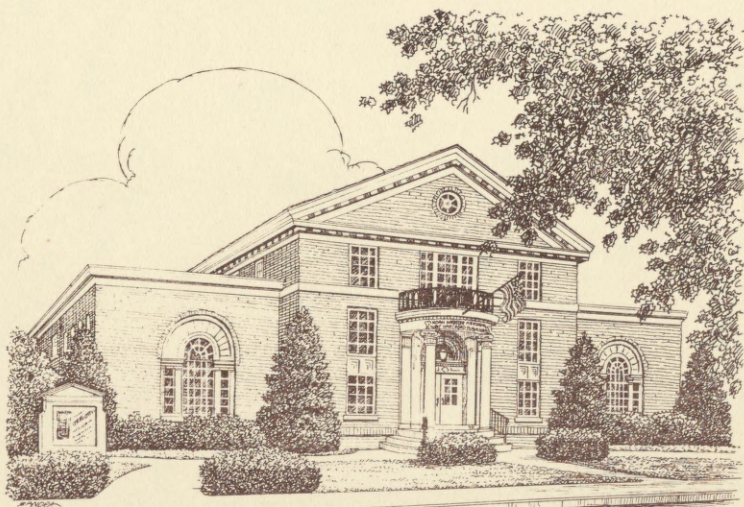
A number of us from
