

NOTICE OF APPROVAL OF RENUNCIATION OF UNITED STATES NATIONALITY

To: Tokiye Inouye
(born February 22, 1912, San Jose, Calif.)

You are hereby notified that, pursuant to Section 401(i) of the Nationality Act of 1940, as Amended, and the regulations issued pursuant thereto, your renunciation of United States nationality has been approved by the Attorney General as not contrary to the interests of national defense. Accordingly you are no longer a citizen of the United States of America nor are you entitled to any of the rights and privileges of such citizenship.

Dear Sir:

I Tokio Inouye born Feb 22, 1912
received your notice dated May 3, 1945 of approval for renunciation
of United States Citizenship. I hereby regret the sudden decision I have
made at the time and for which I'm quite sure there could be no cancellation
of such act.

The reason for my renunciation at the time was that due to
evacuation. I had neither rights nor privileges as an American citizen-
but more or less in status as a alien. I know I would not have (or my
husband) renounced our citizenship if given the rights as all Americans,
and also rumors were prevailing here that if a citizen, we were subject
to a forced relocation.

I have four children, the eldest, Jeanne Setsuko now 12 going
on 13 years, who wishes to remain here in an orphanage if in case we are de
ported. The rest of the children all wish to remain too.

More than ever now, I wish to bring up my children in America,
if given another chance, for which I pray may be granted to us again.

I could swear that I can rectify my past fault by bringing up
my children into a group of defenders of democracy.

Dear Sir:

On March, 1945, I signed an application for Renunciation of United States nationality form at the W.R.A. Segregation Center situated at Tule Lake, Modoc County, California at perfunctory appearance before a government official, (and I have received a letter dated May 3, 1945, from Mr. Herbert Wechsler, assistant Attorney General, approving the same.)

I hereby repudiate, withdraw, retract, and revoke the said renunciation upon the following reasons:

(1) The circumstances under which said renunciation form was signed by me did not constitute a fair and impartial hearing and was a denial of my constitutional guaranty of due process of law and of the equal protection of the law:

(2) I was not a free agent at the time when and the place where said renunciation form was signed but was then and there held in duress and was the victim of fraud, and undue influence and mistake of fact and law:

(3) I then and there was continuously from May 16, 1942, had been detained in the said W.R.A. Segregation Center by official authority and was deprived of substantially all my constitutional rights, liberties, privileges and immunities as an American citizen, and was thusly discriminated against solely by reason of the Japanese nationality of my ancestors:

(4) I was intimidated and compelled to sign the said renunciation form by the reason of Article No. 2, I was deprived of all my constitutional rights and privileges and was put into the Internment Camp since evacuation time I have never believed in U. S. Citizenship rights anymore, this whole matter has caused me to take wrong impression through out my camp life.

Because of the foregoing reasons the said renunciation (and approval thereof) were, and each of them invalid, null and void.

I am not an alien enemy. I am a native American. I recognize as my sovereign the United States of America, and during my years in America, I have been a law abiding citizen, respecting the law and rules.

Therefore I demand that you withdraw and set aside the said renunciation form which is repudiate, withdrawn and revoked by me, and that you recall, withdraw, cancel, and revoke my approval of said renunciation form.

I am ready and willing to have this matter re-opened, and a hearing be granted to me in order to prove that said renunciation form was signed when I was not a free agent in any sense of the words but was acting under duress, fraud and undue influence and mistake of fact and law.

I respectfully request your immediate consideration of this urgent matter.
